- I understand that as an Animal Services Agency foster parent, I am responsible for this animal's well being and ensure it is treated humanely and with compassion.
- I understand that as a foster parent for the Animal Services Agency I will not place the animal in another person's care without the prior consent of the Adoption/Community Education Coordinator.
- I understand the Animal Services Agency is responsible for determining the fate of this animal.
- I understand that as a Animal Services Agency foster parent my name and phone number will be given to members of the public interested in meeting this foster dog.
- I acknowledge receipt of the stated supplies from the Animal Services Agency and agree to return them on the date specified.
- I am aware that the Animal Services Agency is not responsible for any damage done to my property or any person by this animal.
- I understand that the Animal Services Agency is the legal guardian of this animal at all times until the animal is adopted through the adoption program.
- I am aware that if I choose to integrate the foster animals with my own animals, any vet bills for my animal are not the responsibility of the Animal Services Agency.
- I am aware that if any health concerns with my foster animal arise, I am to report them to the Adoption/ Community Education Coordinator or the Kennel Attendant at the Animal Services Agency.
- I understand that if the animal requires emergency attention after regular business hours I am to take the dog to the Emergency Clinic and then bring the bill to the Animal Services Agency. Upon reviewing the bill the Animal Services Agency will determine the amount to be reimbursed.
