Revise E2.6.2 to read:

E2.6.2 Materials and Constructions Methods:

Add E2.6.2(b) and E2.6.2(c) as follows:

- (b) All posts and supports shall be centred in the concrete footing such that there is a complete collar of concrete around each post and support. Where posts are not perfectly centred there should be a minimum of 2" (two inches) of concrete at any point around the post.
- (c) All concrete footings shall be a minimum of 3' (three feet) depth, or in accordance with Manufacturers specifications or whichever is greater.
