Revise:	B3.2	to read:	The Bidder is advised that screened and degritted wastewater will be made available on January 23, 24, 27, 28, and 29 from 9:00 AM to 3:00PM.
Add:	B3.2.1		Bidders shall register their request for wastewater samples by emailing the Contract Administrator identified in D4.
Add:	B3.2.2		Wastewater sample requests shall identify the Bidder, the date and approximate time the Bidder's representative will arrive at the Site, the name and contact information of the Bidder's representative, and the quantity of wastewater, in litres, that is requested. The Contract Administrator reserves the right to reasonably limit the quantity of wastewater that Bidders may receive.
Add:	B3.2.3		SEWPCC operations staff will collect wastewater samples and place such samples into containers provided by the Bidder.
Add:	B3.2.4		Bidders are to make all other necessary arrangements, including but not limited to all costs and logistics (representative to come to the Site, personal protective equipment for their representative if the representative wishes to witness sample collection by the plant staff, sample containers, labelling, transportation to and from the Site, transportation to lab, analysis, reporting, etc.).
