  - (d) anticipated schedule and actual project delivery schedule, or the variance between the two;
  - (e) project owner;
  - (f) reference information (two current names with telephone numbers per project).

#### Revise B21.4

- B21.4 Further to B21.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices and prices for any equipment that may be needed for the City's FC devices to connect, as identified in B13.1(a)(i). For Item 4, for evaluation purposes only, the City will use a termination **at** 30 months.
- B21.4.1 Further to B21.1(a), in the event that a unit price is not provided on Form B: Prices, the City will determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.
