B2.1 The Submission Deadline is 4:00 p.m. Winnipeg time, **January 16, 2015**

PART D - SUPPLEMENTAL CONDITIONS

Revise: D11.1 to read:

D11.1 The Contractor shall achieve Total Performance within **one hundred and twenty (120)** consecutive Working

Days of the commencement of the Work as specified in D10.1. Each Item is to be

treated as a separate Work in this regard.

PART E - SPECIFICATIONS

Revise: E1.3(f) to read: Each TLS shall have full duplex bandwidth. Fibre based TLS bandwidth must be

dedicated. Copper based TLS bandwidth may be shared provided bandwidth

requirements are met;

Revise: E1.3(i) to read: Copper based Transparent LAN Services (TLS) shall target a maximum average return-trip

latency of less than **30 ms** as measured by a network ping test from one end of the circuit to the other. For service level purposes maximum latency may be negotiable based

upon site conditions on a site by site basis.

Revise: E2.2.2 to read: The City reserves the right to increase or decrease TLS speeds up to once per month per

site at no additional cost beyond the difference in Monthly service fees between the

two speeds and any required hardware installation charges.

Revise: E3.306 to read Item No.52a – 10 Mbps TLS at 1745 Wyper Rd. shall be a remote 10 Mbps fibre TLS

connection at Winnipeg Police Site 1745 Wyper Rd. to connect to both Head End

connections (Items 1a and 1b), or Point to Point microwave transport in the licensed spectrum for the "last mile" connectivity to the Bidder's fibre network provided it can

meet the specifications in reference to a fibre based connections in E1 and E3

(specifically latency and bandwidth).
