PART D – SUPPLEMENTAL CONDITIONS

- Revise D5.3.1 and D5.3.2 to read:
 - D5.3.1 Notwithstanding C8, Fees for Subconsultants engaged to perform services in D5.3 shall be payable as invoiced by the Subconsultant, plus an allowed handling fee of 5%.
 - D5.3.2 Consultant Fees for supervision of Subconsultants required to perform any services in D5.3 shall be considered as a Contract Administration Service, and included with Fees proposed in B8.8(d).
- Add: D5.9 Assume the construction contract(s) associated with this project is to include 85 Working Days in 2016 and 85 Working Days in 2017, for the Contractor(s) to achieve Substantial Performance.
- Revise: D11.2 to read:
 - D11.2 Invoices must clearly indicate:
 - (a) the City's purchase order number;
 - (b) project file number;
 - (c) a breakdown of:
 - (i) Preliminary Design Fees;
 - (ii) Public Engagement Process Fees including hours and hourly rates for Services provided in the invoice period;
 - (i) Allowable Disbursements shall be identified separately on each invoice.
 - (iii) Detailed Design Fees;
 - (iv) Contract Administration Fees including hours and hourly rates for Services provided in the invoice period;

- (i) Allowable Disbursements shall be identified separately on each invoice.
- (v) Post Construction Service Fees including hours and hourly rates for Services provided in the invoice period;
 - (i) Allowable Disbursements shall be identified separately on each invoice.
- (vi) Other Project costs and Subconsultant Fees in accordance with D5.2 including the invoiced amount plus an allowed 5% handling fee. Copies of invoices must be attached.
- (d) the amount payable with GST and MRST (as applicable) shown as separate amounts; and
- (e) the Consultant's GST registration number.
