PART B – BIDDING PROCEDURES

Delete B10.1(c).

Revise B12.1 to read:

- B12.1 The Bidder shall complete Form B: Prices by providing the following details for each Configuration:
 - (a) Description;
 - (b) SKU number:
 - (c) Approximate Quantity;
 - (d) Unit Price, in Canadian funds; and
 - (e) Amount.
- B12.1.1 Each Configuration shall be as follows:
 - (a) Section A Configuration 1 Table 1 Initial Purchase;
 - (b) Section A Configuration 1 Table 2 Future Purchase;
 - (c) Section B Configuration 2 Table 1 Initial Purchase;
 - (d) Section B Configuration 2 Table 2 Future Purchase.
- B12.1.2 All items required to complete the Work, including those necessarily incidental to the Work must be included on Form B: Prices.

Revise B13.1 to read:

B13.1 The Bidder shall, on Form B: Prices, provide unit prices **in Canadian funds** for the individual SKUs that make up the configurations and a complete description of the price determination mechanism(s) used to calculate the prices.

Delete B18 in its entirety.

QUESTIONS AND ANSWERS

- Regarding Section E3.21(a), does the requirement to include 5 years of maintenance mean that maintenance coverage would be for a 5-year period from the start of the contract or that each item would have 5 years of maintenance included from the date of its installation? For example, if an item was acquired in January 2017 (as part of the future requirement) would it need to have maintenance coverage that would not end until January 2022?
 - A1 Each item shall have maintenance for 5 years from date of installation. An item acquired in January 2017 shall have maintenance until January 2022.
