Add:	B10.3	The City may, in its sole discretion either prior to or after the issuance of a RFP, replace a Prequalified Proponent that has informed the City that it does not intend to participate in a RFP process by adding the next highest ranked Proponent to the list of Prequalified Proponents.
Add:	B10.4	Each Proponent who is eligible to be added to the list of Prequalified Proponents pursuant to B10.3 is a "Reserve Prequalified Proponent". The provisions of B10.3 shall survive the cancellation or conclusion of the RFQ process and will be applied in a manner which recognizes the legitimate interest of the City to maximize competitive tension during a RFP process while respecting the principles of the fairness to all Proponents.
Add:	B10.5	Prior to being added to the list of Prequalified Proponents, upon notification by the City, a Reserve Prequalified Proponent will be required to:
		 (a) confirm in writing in a form satisfactory to the City that the Reserve Prequalified Proponent wishes to participate in a RFP process; and (b) either, i. provide the City with a confirmation that its Key Personnel have not changed; or ii. make application pursuant to B28.7.1 for a change to the Key Personnel.
Add:	B10.6	Qualification Submissions will not be opened publicly.
Add:	B10.7	After completion of the evaluation, the names of the Pre-qualified Proponents will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/
Add:	B10.8	To the extent permitted, the City shall treat all Qualification Submissions as confidential. However, the Proponent is advised that any information contained in any Qualifications Submission may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.
