PART B – BIDDING PROCEDURES

- Revise: B13.1(a)(ii) to read: Network security, **including internal security processes and safeguards**;
- Revise: B14.1 to read: Proponents should submit a proposed fibre route **and the approximate installation depth** for each sewage treatment plant from the property line to the onsite demark room.
- Revise: B24.1 to read: Award of the Contract shall be based on the following evaluation criteria:
 - (a) Compliance by the Proponent with the requirements of the Request for Proposal or acceptable deviation therefrom; (pass/fail);
 - (b) Qualifications of the Proponent and Subcontractors, if any, pursuant to B18: (pass/fail);
 - (c) Total Bid Price for the Selected Alternative 45%;
 - (d) Company Profile and Experience 10%;
 - (e) Technical Specifications 15%;
 - (f) Proposed Fibre Routes 6%;
 - (g) Service Levels 20%;
 - (h) Project Schedule 4%;
 - (i) Economic analysis of any approved alternate pursuant to B8;
- Add: B25.5.1 Where Proponents request the City to enter into agreements under their terms and conditions, a copy of the proposed agreement should be included with the Proposal Submission for consideration by the City.

Revise: E2.6 to read: All installed cable shall be inside **PVC or aluminum** conduit and be installed straight along building lines either vertical or horizontal (conduit run with 90 degrees directional changes, without angles). Provide any identification (such as markings, phone number) on pull boxes and conduit.

Questions and Answers

Q1 Please provide site drawings with the property line for each site.

- Q2 How much extra cable is required at SEWPCC, NEWPCC and WEWPC?
- A2 For SEWPCC and WEWPC, 30 ft of extra cable is sufficient. For NEWPCC, additional extra cable is not required.
- Q3 Is it acceptable to install a box on the exterior of the building for SEWPCC, NEWPCC and WEWPC?
- A3 A box installed on the exterior of the building is acceptable for SEWPCC, NEWPCC and WEWPC. It is preferable to install the box near grade level and/or in an inconspicuous location.
- Q4 At SEWPCC, can a vault be installed outside the building for the extra cable?
- A4 An exterior vault at SEWPCC is acceptable.
- Q5 At SEWPCC, what is the approximate depth of the proposed duct bank?
- A5 The following drawings have been added to Appendix 1 – Drawings on the FTP site:

- Q6 At WEWPC, are there any future plans for building/construction north of site, i.e. between WEWPC buildings and Wilkes Ave?
- A6 There are currently no plans for construction north of WEWPC, i.e. between WEWPC buildings and Wilkes Ave.
- Q7 Regarding B24.4, how will the City decide which Alternative to select?
- A7 The City shall have the right to select the Alternative which is in its best interests, based on average cost per year and other factors determined by the City. The average cost per year for each Alternative will be the Total Bid Price divided by the number of years of the Contract.
- Q8 Does clause D5.1 apply to equipment and technology used for the provision of the Services to the City?
- A8 Clause D5.1 does not apply to equipment and technology used for provision of the Services to the City.
- Q9 Regarding E2.6, can the word “conduit” be replaced with the word “pathway” as referred in Section 56 of the Canadian Electrical Code?
- A9 No.

Note to Proponents:

Proponents are reminded that requests for any substitute, including fibre routes that are different than the preferred fibre routes included in the RFP, must be made in accordance with **B8**.
