Proof may include the original manufacture packaging and label, supported by the manufacture's specifications. Bidder's will not be required and do not have to submit samples of approved products with their bid.

**Replace** B15.4 to read: Further to B15.1(c), the Bid Price shall be the sum of the Approx. Quantity Purchased 2015, multiplied by the Unit Price for the approved product listed for Item Nos. 1 to 7, shown on Form B: Prices, plus the Approx. Quantity Purchased 2015 multiplied by the unit price for each approved product listed for item No. 8, shown on Form B Prices, plus the Manufacturer's dispenser price to Bidder (based on 1 unit), and the Delivery charge for orders less than \$500.00 (based on 1 unit).

Add: D3.1(b) to read: **Prorate**" means to divide, distribute, or assess proportionately; on the basis of proportional distribution
