- (b) Payment for conduit installation shall include the supply of all materials, and completion of all work specified herein and on the drawings, including trenching and conduit installation, entry of conduit into the Civil Maintenance/Aqueduct Storage Building, warning tape and mechanical protection as required to complete the work.
- (c) The supply and installation of telephone cable will be completed by others.
