PART D - SUPPLEMENTAL CONDITIONS

Revise the numbering under D2 Scope of Work to read:

D2. SCOPE OF WORK

- D2.1 The Work to be done under the Contract shall consist of the installation, repair and removal of Traffic Signals underground infrastructure for the period from May 7, 2018 until November 30, 2018.
- D2.2 The major components of the Work are as follows:
 - (a) Installation of concrete bases.
 - (b) Installation of underground conduit
 - (c) Installation of concrete and pre-cast pits
 - (d) Removal of existing bases and pits
 - (e) Restoration of pavement, miscellaneous slabs, medians and boulevards
- D2.3 The Work shall be done on an "as required" basis during the term of the Contract **as the "Anticipated Work" listed in Appendix A will require coordination with others**.
- D2.3.1 The type and quantity of Work to be performed under this Contract shall be as authorized from time to time by the Contract Administrator and/or Users.
- D2.3.2 Notwithstanding C7.4, the City shall have no obligation under the Contract to purchase any quantity of any item in excess of its actual operational requirements.
- D2.4 Further to C7, if at any time for the duration of the Contract, if the City requires additional quantities of the Contract items, the City may request the Contractor to supply up to one hundred percent (100%) additional
