Form B(R1): Remove Items No.5.d and 5.e inclusive.

Page numbering on some forms may be changed as a result.

QUESTIONS AND ANSWERS

Q1: On the Form B-Prices, there are 40 and 50 cubic metre bins listed for rental, but no 40 or 50m bins in the contract locations. Can the city confirm if they require these sizes?

A1: The line items 5.d and 5.e that are associated with the 40m³ and 50m³ bin rentals have been removed from Form B-Prices.

Q2: Can the city denote which locations have compactors and if they are self-contained units or not?

A2: Based on the current information and to the best of our knowledge the City of Winnipeg has with regards to roll off bin compactors (specific type of compactor is unknown), the information is presented below:

Q3: Regarding the frequency of extra bin requirements based on historical use. We need to know how many spare bins they would require, and we would require to stock.

A3: These requests to supply additional roll of containers will only be for the City of Winnipeg locations that currently have service and based on historical information they may or may not increase. Generally, these requests are related to unforeseen circumstances (i.e., extreme seasonal changes/emergency cleanup situations).
