- 1. Concrete To Be As Per City Of Winnipeg Specification Cw 3310


 Portland Cement Concrete Pavement Works (latest Revision)
- Contraction Joints @ 2439 Max C/c. Seal Joint With Approved Polyethylene Sealant For Flush Finish
- Synthetic Turf To Be Suitable For Sports Field Application And Approved By Contract Administrator. Installed As Per Manufacturer's Written Instructions.
- 4. Subgrade And Compacted Granular Base As Per City Of Winnipeg Specification Cw 3110 <u>Sub-grade</u>, <u>Sub-base And Base Course</u>
 Construction (latest Revision)

5. 2x2 x2' Long ACQ Treated Pressure Treat Wood Stakes to be Placed Every 610 (2') Along Outer Edges of 6x6 Pressure Treat Lumber Where Granular Surfacing Located. Ensure top of Stake is Set 2" Below Top of Finished 6x6 Framing.

- 6. Concrete to Have Light Broom Finish
- 7. Measurements in PITCH PLAN Are From Outside Edge of 6x6 Lumber

Turf Fastened w/ 1.5" #8 Pan

Head Corrosion Resistant



Screws with Washer Combi-grid geotextile / geogrid composite ssembly x 2 Every 100mm 150mm depth 19mm (3/4" down) compacted limestone. 50mm depth 1/4" down compacted limstone Ensure granular is compacted to top of timber edge beyond chamfered edge. Contract Administrator to approve prior to turf install. Basic Synthetic turf. Installed as per **BASIC SYNTHETIC TURF** manufacturers' written specifications **WRAPPING DETAIL** Aritificial turf wrapped around side of timber stapled x 2 every 100mm. Turf to wrapped to 6" x 6" PT wood header. Treating end cuts of the 100mm down edge of timber wood edging with wood preservative suitable for underground use. All end cuts to be treated with appropriate above ground (clear) or below ground preservative suitable for outdoor applications 3' long 19mm DIA, rebar spike counter sink 50mm down from top of timber every 2' Subgrade compacted to min. 95% SPD
