ELECTRICAL DEMOLITION NOTES:

REFER TO DRAWING E-4 SPECIFICATIONS.
----- INDICATES DEMOLITION. INCLUDES ELECTRICAL SYMBOLS.

- REMOVE ALL IN-FLOOR AND CEILING HUNG CONDUIT INCLUDING ANY ATTACHED RECEPTACLE AND SWITCH BOXES, EXCEPT FIRE PREVENTION DEVICES, AS NOTED. REMOVE ALL WIRING BACK TO SOURCE. CAP ALL CONDUITS BENEATH EXISTING FLOOR SURFACE, PATCH CONCRETE AND FINISH FLOOR AS PER ARCHITECTURAL DRAWINGS.
- REMOVE AS INDICATED RECEPTACLES, SWITCHES, PANELS, DATA, TELEPHONE, REDUNDANT & ASSOCIATED WIRING BACK TO SOURCE.
- REMOVE ELECTRICAL BOX & CONDUIT FROM WALL.
- REMOVE ABANDONED ELECTRICAL WIRING, CONDUIT, BREAKERS, SWITCHES IN EXISTING ELECTRICAL PANELS.
- EXISTING FIREBELL IS WIRED TO EXISTING ACTIVE FIRE PREVENTION SYSTEM. WORK TO REMOVE &/OR RELOCATE MUST BE COORDINATED WITH CITY OF WINNIPEG.
- REMOVE EXISTING DANGLING FIREHORNS & CONDUIT.
- INVESTIGATE. IF FIRE PREVENTION DEVICE, CONSULT CITY OF WINNIPEG. REWIRING &/OR REHANGING MAY BE REQUIRED.

- THESE DRAWINGS SHALL NOT BE SCALED.
- THE CONTRACTOR SHALL VISIT THE SITE AND SATISFY ONESELF ALL DIMENSIONS, DATUM, AND DETAILED INFORMATION SHOWN ARE CORRECT.
- THE CONTRACTOR IS TO REVIEW AND COORDINATE ALL ARCHITECTURAL, MECHANICAL, ELECTRICAL AND STRUCTURAL DRAWINGS FOR ADDITIONAL OPENINGS THROUGH FLOORS, WALLS, AND CEILINGS FOR DUCT, PIPE & ELECTRICAL RISERS AND ALL OPENINGS NOT SHOWN ON DRAWINGS.
- ALL OPENINGS THROUGH FIRE ASSEMBLIES, INCLUDING FLOORS AND CEILINGS ARE TO BE FIRE STOPPED AND SEALED WITH ULC APPROVED FIRE STOPPING TO MAINTAIN THE INTEGRITY OF THE FIRE SEPARATION, AND PROVIDE A SMOKE-TIGHT BARRIER.
- ALL PRODUCTS AND MATERIALS TO BE USED AND INSTALLED SHALL CONFORM WITH MANUFACTURERS SPECIFICATIONS & APPLICABLE CODES.
- THE CONTRACTOR SHALL BE RESPONSIBLE TO PATCH AND MAKE GOOD ALL EXISTING CONSTRUCTION AFFECTED BY THE REMOVAL OF ALL ITEMS FORMING THE PART OF THE RENOVATION WORK.
- WHERE NEW FLOORING AND BASE IS TO BE INSTALLED IN EXISTING AREAS (REFER TO FLOOR PLAN AND ROOM SCHEDULE) THE EXISTING FLOORING SURFACE AND BASE MUST BE REMOVED, UNLESS OTHERWISE NOTED. ALL FLOOR SURFACES SHALL BE PREPARED IN ACCORDANCE TO MANUFACTURERS RECOMMENDATIONS FOR INSTALLATION OF NEW FLOOR.
- WHERE PAINTING OF EXISTING WALLS IS INDICATED ON THE ROOM SCHEDULE, THESE WALLS MUST BE CLEANED OF ANY EXISTING WALL COVERING, PATCHED & PREPARED TO ACCEPT NEW MATERIAL, UNLESS OTHERWISE NOTED.
- ALL ABANDONED ELECTRICAL FIXTURES, COMPONENTS & RECEPTACLE WIRINGS SHALL BE REMOVED BACK TO SOURCE.
- WARNING:** ASBESTOS IS PRESENT IN THE MAIN FLOOR CEILING SPACE, & EAST & WEST AIR SHAFTS.
