- .3 Fabricate components, drawers, doors, shelves, counters, and of die formed stainless steel. Form each unit rigid, not dependent on building structure adjacent units for rigidity.
- .4 Form edges and seams smooth. Form material for counter tops, facing, shelves, from continuous sheets.
- .5 Turn down edges of shelves 25 mm on each side and return 16 mm front and back.
- .6 Electric spot weld casework; grind joints smooth and flush.
- .7 Form counter tops of 1.5 mm thick stainless steel

- .8 Cut and drill counter tops, backs, and other components for service outlets and fixtures.

2.5 FINISHES

- .1 Stainless Steel: No. 4 finish.
- .2 Shop finish all components.
- .3 Coat metal surfaces in contact with cementitious materials with bituminous paint.
