1.0 DESCRIPTION OF EQUIPMENT AND PERFORMANCE-

1.1 THESE SPECIFICATIONS DESCRIBE THE SUPPLY AND DELIVERY OF A PTO FRONT MOUNTED SNOWBLOWER SPECIFIED HEREIN. THE PTO FRONT MOUNTED SNOWBLOWERS SHALL BE NEW 2009 OR 2010 MODEL YEAR OR NEWER.

1.2 Shall be capable of consistent top performance for snow removal in winter environment, which is normal to the City of Winnipeg.

1.3 The **PTO FRONT MOUNTED SNOWBLOWER** and all other items/components shall be the manufacturer's latest models. The equipment shall be furnished complete and ready for operation. Any parts or accessories not specifically mentioned, but which are required to complete and place the equipment, (including attachments) in successful operation shall be furnished as though specifically mentioned in these specifications. The complete equipment, and all parts thereof, shall conform in strength and quality of material and workmanship, to the best standards and engineering practice of the industry.

2.0 OTHER SPECIFICATIONS AND STANDARDS-

2.1 All applicable SAE standards form an integral part of these specifications and shall have precedence in any conflict concerning minimum acceptable standards.

Pricing should be based on two (2) business days for maintenance personnel and two (2) business days for operating personnel.

Note: The first payment of the contract on the equipment will not be issued until successful completion of training has been conducted to the satisfaction of the Contract Administrator.
