## **PLANTING NOTES**

- 1. IF SOIL TESTS REQUIRE, NITROGEN AND PHOSPHORUS FERTILIZER SHOULD BE APPLIED AS PER MANUFACTURER'S INSTRUCTIONS.
- 2. EXACT LOCATION OF TEST PLOTS TO BE CONFIRMED ON SITE BY LANDSCAPE ARCHITECT.
- 3. FIRST SHRUB PLANTED IN TEST PLOTS SHALL BE PLANTED UNDER THE OBSERVANCE OF THE CONTRACT ADMINISTRATOR
- 4. ENSURE FINE GRADING OF TOPSOIL ALLOWS POSITIVE DRAINAGE AND PREVENTS POOLING OF WATER.
- 6. FEATHER TOPSOIL, REQUIRED FOR TURF SEED, BACK INTO EXISTING GRADES. 5. REFER TO DETAIL 4 ON LS-501 FOR SHRUB TEST PLOT PLANTING DETAIL.


# General Notes

- All dimensions to be verified on site. Layout 5. and elevations of all park areas, pathways and fences shall be staked by approved surveyor and reviewed and approved by landscape architect and civil engineer prior to 6.
- construction. Do not scale drawings for construction. Contractor to verify all existing conditions and dimensions required to perform the work and 7. report any discrepancies to the landscape architect prior to commencing work.
- All dimensions are in metric (meters m). Base drawing and survey data provided by City of Winnipeg.
- Contractor shall report any discrepancies between 9. the drawings and site conditions prior to commencement of the work.
- Where Landscape drawings show engineering information, such information is for informational purposes only. Do not construct engineering works
- from these drawings. Where applicable, refer to grading plan for grading information.
- All work to be carried out in conformance with codes and bylaws of the authorities having jurisdiction.
- During construction, existing roads and fences are to be protected to City of Winnipeg Standards. The contractor, at their own expense, is responsible to repaire any damage caused during constuction to City of Winnipeg
- Consult with appropriate utility prior to construction activity. All utility locations are the responsibility of the Contractor. Hand dig within the limits recommended by the service utility. Utility conflicts with proposed tree locations must be reported immediately to the Landscape Architect
