PART B - BIDDING PROCEDURES

B1. CONTRACT TITLE

B1.1 ANNABELLA WALKWAY PROJECT – ANNABELLA STREET, WINNIPEG, MB

B2. SUBMISSION DEADLINE

- B2.1 The Submission Deadline is 4:00 p.m. Winnipeg time, October 16, 2015.
- B2.2 Bids determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.
- B2.3 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

B3. SITE INVESTIGATION

- B3.1 Further to C3.1, the Contract Administrator or an authorized representative will be available at the Site at 2 PM on October 9, 2015 to provide Bidders access to the Site.
- B3.2 The Bidder shall not be entitled to rely on any information or interpretation received at the Site investigation unless that information or interpretation is the Bidder's direct observation, or is provided by the Contract Administrator in writing.

B4. ENQUIRIES

- B4.1 All enquiries shall be directed to the Contract Administrator identified in D3.1.
- B4.2 If the Bidder finds errors, discrepancies or omissions in the Bid Opportunity, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.
- B4.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator to all Bidders by issuing an addendum.
- B4.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Bid Opportunity will be provided by the Contract Administrator only to the Bidder who made the enquiry.
- B4.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B4 unless that response or interpretation is provided by the Contract Administrator in writing.

B5. CONFIDENTIALITY

- B5.1 Information provided to a Bidder by the City or acquired by a Bidder by way of further enquiries or through investigation is confidential. Such information shall not be used or disclosed in any way without the prior written authorization of the Contract Administrator. The use and disclosure of the confidential information shall not apply to information which:
 - (a) was known to the Bidder before receipt hereof; or
 - (b) becomes publicly known other than through the Bidder; or
 - (c) is disclosed pursuant to the requirements of a governmental authority or judicial order.
- B5.2 The Bidder shall not make any statement of fact or opinion regarding any aspect of the Bid Opportunity to the media or any member of the public without the prior written authorization of the Contract Administrator.

B6. ADDENDA

- B6.1 The Contract Administrator may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Bid Opportunity, or clarifying the meaning or intent of any provision therein.
- B6.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B6.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <u>http://www.winnipeg.ca/matmgt/</u>
- B6.2.2 The Bidder is responsible for ensuring that he/she has received all addenda and is advised to check the Materials Management Division website for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.
- B6.2.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 8 of Form A: Bid. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.

B7. SUBSTITUTES

- B7.1 The Work is based on the Plant, Materials and methods specified in the Bid Opportunity.
- B7.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B7.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- B7.4 The Bidder shall ensure that any and all requests for approval of a substitute:
 - (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative;
 - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
 - (c) identify any anticipated cost or time savings that may be associated with the substitute;
 - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance;
 - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B7.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his/her sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.
- B7.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, to the Bidder who requested approval of the substitute.

- B7.6.1 The Contract Administrator will issue an Addendum, disclosing the approved materials, equipment, methods and products to all potential Bidders. The Bidder requesting and obtaining the approval of a substitute shall be responsible for disseminating information regarding the approval to any person or persons he/she wishes to inform.
- B7.7 If the Contract Administrator approves a substitute as an "approved equal", any Bidder may use the approved equal in place of the specified item.
- B7.8 If the Contract Administrator approves a substitute as an "approved alternative", any Bidder bidding that approved alternative may base his/her Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B16.
- B7.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.
- B7.10 Notwithstanding B7.2 to B7.9, and in accordance with B8.7, deviations inconsistent with the Bid Opportunity document shall be evaluated in accordance with B16.1(a).

B8. BID COMPONENTS

- B8.1 The Bid shall consist of the following components:
 - (a) Form A: Bid;
 - (b) Form B: Prices;
- B8.2 Further to B8.1, the Bidder should include the written correspondence from the Contract Administrator approving a substitute in accordance with B7.
- B8.3 All components of the Bid shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Bid.
- B8.4 The Bid Submission may be submitted by mail, courier or personal delivery, or by facsimile transmission.
- B8.5 If the Bid Submission is submitted by mail, courier or personal delivery, it shall be enclosed and sealed in an envelope clearly marked with the Bid Opportunity number and the Bidder's name and address, and shall be submitted to:

- B8.5.1 Samples or other components of the Bid Submission which cannot reasonably be enclosed in the envelope may be packaged separately, but shall be clearly marked with the Bid Opportunity number, the Bidder's name and address, and an indication that the contents are part of the Bidder's Bid Submission.
- B8.6 Bidders are advised not to include any information/literature except as requested in accordance with B8.1.
- B8.7 Bidders are advised that inclusion of terms and conditions inconsistent with the Bid Opportunity document, including the General Conditions, will be evaluated in accordance with B16.1(a).
- B8.8 If the Bid Submission is submitted by facsimile transmission, it shall be submitted to 204 949-1178.

- B8.8.1 The Bidder is advised that the City cannot take responsibility for the availability of the facsimile machine at any time.
- B8.8.2 Bids submitted by internet electronic mail (e-mail) will not be accepted.

B9. BID

- B9.1 The Bidder shall complete Form A: Bid, making all required entries.
- B9.2 Paragraph 2 of Form A: Bid shall be completed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his/her own name, his/her name shall be inserted;
 - (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
 - (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;
 - (d) if the Bidder is carrying on business under a name other than his/her own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B9.2.1 If a Bid is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B9.2.
- B9.3 In Paragraph 3 of Form A: Bid, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Bid.
- B9.4 Paragraph 10 of Form A: Bid shall be signed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his/her own name, it shall be signed by the Bidder;
 - (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
 - (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers;
 - (d) if the Bidder is carrying on business under a name other than his/her own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B9.4.1 The name and official capacity of all individuals signing Form A: Bid should be printed below such signatures.
- B9.4.2 All signatures shall be original.
- B9.5 If a Bid is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Bid and the Contract, when awarded, shall be both joint and several.

B10. PRICES

- B10.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- B10.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.
- B10.3 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.
- B10.4 Payments to Non-Resident Contractors are subject to Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).

B11. DISCLOSURE

- B11.1 Various Persons provided information or services with respect to this Work. In the City's opinion, this relationship or association does not create a conflict of interest because of this full disclosure. Where applicable, additional material available as a result of contact with these Persons is listed below.
- B11.2 The Persons are:

- B11.3 Additional Material:
 - (a) Rocks

B12. QUALIFICATION

- B12.1 The Bidder shall:
 - (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba; and
 - (b) be financially capable of carrying out the terms of the Contract; and
 - (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.
- B12.2 The Bidder and any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <u>http://www.winnipeg.ca/matmgt/debar.stm</u>
- B12.3 The Bidder and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) have successfully carried out work similar in nature, scope and value to the Work; and
 - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and
 - (c) have a written workplace safety and health program if required pursuant to The Workplace Safety and Health Act (Manitoba);
- B12.4 Further to B12.3(c), the Bidder shall, within five (5) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator that the Bidder/Subcontractors has a workplace safety and health program meeting the requirements of The Workplace Safety and Health Act (Manitoba), by providing:
 - (a) a copy of their valid Manitoba COR certificate and Letter of Good Standing (or Manitoba equivalency) as issued under the Certificate of Recognition (COR) Program administered by the Construction Safety Association of Manitoba or by the Manitoba Heavy Construction Association's WORKSAFELY™ COR™ Program; or
 - (b) a copy of their valid Manitoba SECOR[™] certificate and Letter of Good Standing (or Manitoba equivalency) as issued under the Small Employer Certificate of Recognition

Program (SECOR[™]) administered by the Construction Safety Association of Manitoba or by the Manitoba Heavy Construction Association's WORKSAFELY[™] COR[™] Program; or

- (c) a report or letter to that effect from an independent reviewer acceptable to the City. (A list of acceptable reviewers and the review template are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <u>http://www.winnipeg.ca/matmgt/</u>.
- B12.5 The Bidder shall submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Bidder and of any proposed Subcontractor.
- B12.6 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

B13. OPENING OF BIDS AND RELEASE OF INFORMATION

- B13.1 Bids will not be opened publicly.
- B13.2 Following the submission deadline, the names of the Bidders and their Total Bid Prices (unevaluated, and pending review and verification of conformance with requirements) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <u>http://www.winnipeg.ca/matmgt/bidopp.asp</u>
- B13.3 After award of Contract, the name(s) of the successful Bidder(s) and the Contract amount(s) will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/
- B13.4 The Bidder is advised that any information contained in any Bid may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.

B14. IRREVOCABLE BID

- B14.1 The Bid(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 9 of Form A: Bid.
- B14.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work for the time period specified in Paragraph 9 of Form A: Bid.

B15. WITHDRAWAL OF BIDS

- B15.1 A Bidder may withdraw his/her Bid without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.
- B15.1.1 Notwithstanding C23.3, the time and date of receipt of any notice withdrawing a Bid shall be the time and date of receipt as determined by the Manager of Materials.
- B15.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Bid or the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid, and only such person, has authority to give notice of withdrawal.
- B15.1.3 If a Bidder gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials will:
 - (a) retain the Bid until after the Submission Deadline has elapsed;

- (b) open the Bid to identify the contact person named in Paragraph 3 of Form A: Bid and the Bidder's authorized representatives named in Paragraph 10 of Form A: Bid; and
- (c) if the notice has been given by any one of the persons specified in B15.1.3(b), declare the Bid withdrawn.
- B15.2 A Bidder who withdraws his/her Bid after the Submission Deadline but before his/her Bid has been released or has lapsed as provided for in B14.2 shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law.

B16. EVALUATION OF BIDS

- B16.1 Award of the Contract shall be based on the following bid evaluation criteria:
 - (a) compliance by the Bidder with the requirements of the Bid Opportunity or acceptable deviation there from (pass/fail);
 - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B12 (pass/fail);
 - (c) Total Bid Price;
 - (d) economic analysis of any approved alternative pursuant to B7.
- B16.2 Further to B16.1(a), the Award Authority may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements or minor informalities or irregularities, if the interests of the City so require.
- B16.3 Further to B16.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his/her Bid or in other information required to be submitted, that he/she is responsible and qualified.
- B16.4 Further to B16.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices.
- B16.4.1 Further to B16.1(a), in the event that a unit price is not provided on Form B: Prices, the City will determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.

B17. AWARD OF CONTRACT

- B17.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B17.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive.
- B17.2.1 Without limiting the generality of B17.2, the City will have no obligation to award a Contract where:
 - (a) the prices exceed the available City funds for the Work;
 - (b) the prices are materially in excess of the prices received for similar work in the past;
 - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
 - (d) only one Bid is received; or
 - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.

- B17.3 Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive Bid, in accordance with B16.
- B17.3.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his/her Bid upon written request to the Contract Administrator.
- B17.4 Notwithstanding C4, the City may issue a Purchase Order to the successful Bidder in lieu of the execution of a Contract.
- B17.5 The Contract, as defined in C1.1, in its entirety shall be deemed to be incorporated in and to form a part of the Purchase Order notwithstanding that it is not necessarily attached to or accompany said Purchase Order.

PART C - GENERAL CONDITIONS

C0. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2006 12 15) are applicable to the Work of the Contract.
- C0.1.1 The General Conditions for Construction are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <u>http://www.winnipeg.ca/matmgt/gen_cond.stm</u>
- C0.2 A reference in the Bid Opportunity to a section, clause or subclause with the prefix "**C**" designates a section, clause or subclause in the *General Conditions for Construction*.

PART D - SUPPLEMENTAL CONDITIONS

GENERAL

D1. GENERAL CONDITIONS

D1.1 In addition to the *General Conditions for Construction*, these Supplemental Conditions are applicable to the Work of the Contract.

D2. SCOPE OF WORK

D2.1 The Work to be done under the Contract shall consist of mob-demobilization of equipment and personnel, site preparation involving grading, soil removal, and surveying, supply and installation of 1) a granular path walkway and rocks for the edging, 2) flag stone, 3) rocks for the staircases, 4) rip-rap, and 5) Gabion baskets and leveling rock.

D3. CONTRACT ADMINISTRATOR

- D3.2 At the pre-construction meeting, Clark Hryhoruk will identify additional personnel representing the Contract Administrator and their respective roles and responsibilities for the Work.
- D3.3 Bids Submissions must be submitted to the address in B8.5.

D4. CONTRACTOR'S SUPERVISOR

D4.1 At the pre-construction meeting, the Contractor shall identify his/her designated supervisor and any additional personnel representing the Contractor and their respective roles and responsibilities for the Work.

D5. OWNERSHIP OF INFORMATION, CONFIDENTIALITY AND NON DISCLOSURE

- D5.1 The Contract, all deliverables produced or developed, and information provided to or acquired by the Contractor are the property of the City and shall not be appropriated for the Contractors own use, or for the use of any third party.
- D5.2 The Contractor shall not make any public announcements or press releases regarding the Contract, without the prior written authorization of the Contract Administrator.
- D5.3 The following shall be confidential and shall not be disclosed by the Contractor to the media or any member of the public without the prior written authorization of the Contract Administrator;
 - (a) information provided to the Contractor by the City or acquired by the Contractor during the course of the Work;
 - (b) the Contract, all deliverables produced or developed; and
 - (c) any statement of fact or opinion regarding any aspect of the Contract.
- D5.4 A Contractor who violates any provision of D5 may be determined to be in breach of Contract.

D6. NOTICES

- D6.1 Except as provided for in C23.2.2, all notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the Contractor shall be sent to the address or facsimile number identified by the Contractor in Paragraph 2 of Form A: Bid.
- D6.2 All notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the City, except as expressly otherwise required in D6.3, D6.4 or elsewhere in the Contract, shall be sent to the attention of the Contract Administrator at the facsimile number identified in D3.1.
- D6.3 Notwithstanding C21., all notices of appeal to the Chief Administrative Officer shall be sent to the attention of the Chief Financial Officer at the following facsimile number:

E2. MOB-DEMOBILIZATION, AND SITE PREPARATION

Description

- E2.1 This specification shall cover the work required under the heading Mob-Demobilization, and Site Preparation, and shall include:
 - a) Mobilization and demobilization of all personnel and equipment required to complete the work
 - b) Site Preparation which involves all work and materials required for preparing the site for construction of the walkway.
- E2.2 The Work to be done by the Contractor shall include superintendence, labour, materials, and all other things necessary for and incidental to the satisfactory performance and completion of all work as hereinafter specified.

Materials

Fine Crushed Limestone

E2.3 The Contractor shall be responsible for the placement and compaction of 100 mm fine crushed limestone to the design elevations shown on Drawing 2 during regrading of the existing bike path. Approximately 3 m³ of fine crushed limestone will be required to regrade the existing bike path. Care must be taken when placing fine crushed limestone adjacent the walkway and/or any other items. The Contractor will be held liable for damage to the aforementioned items, and shall be required to provide appropriate restoration to the satisfaction of the Contract Administrator.

Quality Control

- E3.1 This Specification shall cover the work required under the heading Walkway Edge Rocks as shown in Form B: Prices, and shall include the supply and installation of the walkway edge rocks, granular materials, filter fabric, excess soil removal, and regrading of the bank and all other incidental items related to construction of the path to the flag stone elevation.
- E3.2 The Work to be done by the Contractor shall include superintendence, labor, materials, and all other things necessary for and incidental to the satisfactory performance and completion of all Work as hereinafter specified.

<u>General</u>

Walkway Edge Rocks

E3.4 The pathway edges for the walkway from the bike path to the flag stone elevation to be installed as shown on Drawing Nos. 2, 3 and 4 with rocks selected from Mariash Quarry of size 300 mm wide, 300 to 600 mm high and a minimum 50 kg per rock. An estimated 26 tons (37.3 m in length) of walkway edge rocks are required with an estimated cut volume of 5.2 m³ and fill volume of 4.2 m³. The rocks will be selected by the Contract administrator prior to the prior to removal from Mariash Quarry.

Engineered Fills

E3.5 The path shall be 6 to 12 mm limestone down (Granular 1) placed in a single 100 mm lift and compacted to 100% Maximum Dry Density (MDD) as shown in Drawing No. 4. Granular rock fill placed below the walkway edge rocks, and used to raise existing grade and side slopes as required shall be 20 mm crushed limestone base coarse (Granular 2) and compacted near 100% Maximum Dry Density (MDD) as shown on Drawing No. 4. Approximately 8 m³ of Granular 1 and 8 m³ of Granular 2 will be required to complete the path.

Filter Fabric

E3.1 Filter fabric placed below the path as shown on Drawing 4 to be geotextile NW-801 or equivalent. Approximately 45 m² of filter fabric is required to complete the new path.

Construction Methods

E3.2 The installation of the path to lower walkway and all other components shall have the shape and dimensions as shown on the drawings, and final approval of the above will be provided by the Contract Administrator. The elevation of the new path shall be within 0.03 m; minor field adjustments to the location of the path may be required, and approval must be obtained by the Contract Administrator prior to construction.

- E3.3 All workmanship and materials furnished and supplied under this Specification will be subject to inspection by the Contract Administrator, including all operations from the selection and production of materials through the final acceptance of the specific Work. The Contractor shall be responsible for the control of all operations to complete the work, except the inspections or approvals that have been previously given.
- E3.4 The Contract Administrator shall have full access for inspection and control of testing of materials at the site to determine whether the materials are being selected and placed or Work being conducted in accordance with this Specification.

E4. SUPPLY AND INSTALLATION OF FLAG STONE LANDING

Description

- E4.1 This Specification shall cover the work required under the heading Flag Stone as shown in Form B: Prices, and shall include the supply and installation of the rock for the flag stone, engineered fills, filter fabric, and all other incidental items related to the flag stone landing.
- E4.2 The Work to be done by the Contractor shall include superintendence, labor, materials, and all other things necessary for and incidental to the satisfactory performance and completion of all Work as hereinafter specified.

Materials

General

E4.3 The Contractor shall be responsible for the supply, safe storage and handling of all materials set forth in this Specification required to complete the Work.

Flag Stone

E4.4 The flag stone landing is to be installed as shown on Drawing Nos. 2 and 4 with flag stone selected from Mariash Quarry. The flag stones shall have a 25 to 100 mm gap between each stone with an estimated 7 tons of flag stone required over an area of approximately 56 m².

Engineered Fills

E4.5 Granular rock fill placed below the flag stone and in the gaps between the flag stones as shown on Drawing No. 4 shall be 6 to 12 mm limestone down. Compacted to 100% Maximum Dry Density (MDD) will be required prior to placement of the flag stone, and the fines shall not exceed 20% passing the 0.08 mm sieve. Approximately 3 m³ of 6 to 12 mm limestone down will be required for the Flag Stone Landing.

Filter Fabric

E4.6 Filter fabric placed below the Flag Stones as shown on Drawing 4 shall be geotextile NW-801 or equivalent. Approximately 60 m² of filter fabric is required to complete the flag stone landing.

Construction Methods

E4.7 The installation of the flag stone landing and all other components shall have the shape and dimensions as shown on the drawings, and final approval of the above will be provided by the Contract Administrator. The flag stone elevation shall be within 0.03 m; minor field adjustments may be required and approval must be obtained by the Contract Administrator prior to construction.

Quality Control

- E4.8 All workmanship and materials furnished and supplied under this Specification will be subject to inspection by the Contract Administrator, including all operations from the selection and production of materials through the final acceptance of the specific Work. The Contractor shall be responsible for the control of all operations to complete the work, except the inspections or approvals that have been previously given.
- E4.9 The Contract Administrator shall have full access for inspection and control of testing of materials at the site to determine whether the materials are being selected and placed or Work being conducted in accordance with this Specification.

E5. SUPPLY AND INSTALLATION OF STAIRCASE

Description

- E5.1 This Specification shall cover the work required under the headings Upper Staircase Rocks, Lower Staircase Rocks, 50 – 100 mm dia. Leveling Rock, and Gabion Baskets as shown in Form B: Prices, and shall include the supply and installation of the staircase, engineered fills, leveling rock, gabion baskets, and all other incidental items related to the staircase.
- E5.2 The Work to be done by the Contractor shall include superintendence, labor, materials, and all other things necessary for and incidental to the satisfactory performance and completion of all Work as hereinafter specified.

Materials

<u>General</u>

E5.3 The Contractor shall be responsible for the supply, safe storage and handling of all materials set forth in this Specification required to complete the Work.

Staircase Rocks

E5.4 The staircase rocks are to be custom fit and installed into the lower bank as shown on Drawing Nos. 2 and 3 with rocks selected from Mariash Quarry. The staircase is to be installed in three runs with the first run 1.5 m wide with 450 mm treads and the risers being approximately 150 mm. The second run shall be 1.8 m wide with 1.5 m treads and risers of approximately 150 mm. The final run shall be 2.7 m wide with 1.5 m treads and risers of approximately 150 mm for the first row of steps and approximately 200 mm for the remaining. An estimated 37 tons of staircase rocks will be required to complete the upper and lower staircase.

Leveling Rock

E5.5 50 to 100 mm diameter limestone (leveling rock) shall be placed alongside the staircase rocks to prevent erosion and facilitate launching of a canoe or kayak. An estimated 70 tons of leveling rock will be required to complete the staircase.

Gabion Baskets

E5.6 The galvanized gabion baskets shall be installed below the staircase rocks as shown on Drawing Nos. 2 and 3. Three (3) gabion baskets sized 3.0 m x 1.0 m x 0.3 m and four (4) gabion baskets sized 2.0 m x 1.0 m x 0.3 m will be required to complete the staircase. The baskets shall be a Standard mesh-wire, with an internal wire diameter of 2.70 mm, an external wire diameter of 3.70 mm, and a tensile strength of at least 500 MPa, as per ASTM A641.03.

Construction Methods

E5.7 The installation of the staircase and all other components shall have the shape and dimensions as shown on the drawings, and final approval of the above will be provided by the Contract Administrator. The staircase shall be within 0.05 m; minor field adjustments to the location and

shape may be required and approval must be obtained by the Contract Administrator prior to construction.

E6.6 All workmanship and materials furnished and supplied under this Specification will be subject to inspection by the Contract Administrator, including all operations from the selection and production of materials through the final acceptance of the specific Work. The Contractor shall be responsible for the control of all operations to complete the work, except the inspections or approvals that have been previously given.

E6.7 The Contract Administrator shall have full access for inspection and control of testing of materials at the site to determine whether the materials are being selected and placed or Work being conducted in accordance with this Specification.
