- 3. ALL WORK SHALL COMPLY WITH THE MOST CURRENT VERSION OF ALL APPLICABLE CODES AND STANDARDS, WHICH SHALL BE CONSIDERED PART OF THESE CONTRACT DOCUMENTS. IN THE CASE OF CONFLICTING REQUIREMENTS, THE MOST STRINGENT REGULATION SHALL PREVAIL.
- CONTRACTOR TO MAINTAIN CURRENT AND READILY REVIEWABLE AS-BUILT DRAWINGS ACCURATELY REFLECTING SITE INSTALLATIONS.

- 1 EXISTING FAN COIL DUCTWORK ON MEZZANINE TO BE REMOVED, ALONG WITH DIFFUSERS. FIRE DAMPER IN FLOOR PENETRATION TO BE REMOVED AND REINSTALLED IN SAME LOCATION TO MAINTAIN FIRE SEPARATION. RETEST FIRE DAMPER ONCE REINSTALLATION IS COMPLETE. FIRE DAMPER IS 650X275.
- (2) REMOVE EXISTING AC THERMOSTAT.
- (3) EXISTING HEATER TO BE REMOVED.
- (4) EXISTING HEATER AND CAGE TO BE REMOVED.
- 5 EXISTING HEAT SENSOR TO BE REMOVED AND RETURNED TO THE CITY.
- 6 EXISTING RETURN GRILLE TO BE REMOVED. COORDINATE FLOOR PATCHING WITH ARCHITECTURAL REQUIREMENTS.
- 7 REMOVE EXISTING DRINKING FOUNTAIN. RETAIN PLUMBING ROUGH-INS FOR NEW DRINKING FOUNTAIN IN RENOVATION PHASE.


