



GENERAL NOTES:

- 1. THIS DRAWING IS DIAGRAMMATIC ONLY. DO NOT SCALE.
- 2. THE MECHANICAL SYSTEMS SHOWN ARE APPROXIMATE IN LOCATION ONLY. CONTRACTOR TO VERIFY EXACT LOCATION OF SYSTEMS BEING MODIFIED ON SITE PRIOR TO COMMENCEMENT OF WORK.
- 3. ALL WORK SHALL COMPLY WITH THE MOST CURRENT VERSION OF ALL APPLICABLE CODES AND STANDARDS, WHICH SHALL BE CONSIDERED PART OF THESE CONTRACT DOCUMENTS. IN THE CASE OF CONFLICTING REQUIREMENTS, THE MOST STRINGENT REGULATION SHALL PREVAIL.
- 4. CONTRACTOR TO MAINTAIN CURRENT AND READILY REVIEWABLE AS-BUILT DRAWINGS ACCURATELY REFLECTING SITE INSTALLATIONS.
- 5. CONTRACTOR TO ENSURE ALL MATERIALS MODIFIED OR INSTALLED IN AN AIR PLENUM ARE RATED FOR SUCH USE.
- 6. CONTRACTOR TO MAINTAIN DIGITAL PHOTOGRAPHIC RECORDS OF ALL INSTALLATIONS PRIOR TO CONCEALMENT.
- 7. MECHANICAL SUBCONTRACTOR TO COORDINATE WITH CONTRACTOR FOR SCANNING, CUTTING AND PATCHING OF FLOOR AND SLAB TO DETERMINE EXACT LOCATION OF EXISTING DRAIN PIPES WHERE NEW DRAIN PIPES TIE IN.
- 8. PROVIDE CAP ON ALL PIPING TO PREVENT DEBRIS ENTERING SYSTEM.
- 9. PROVIDE PROWRAP (TM) ON ALL EXPOSED PIPING UNDER

BARRIER FREE LAVATORIES AND SINKS.

10. MATERIAL INSTALLED IN CEILING SPACE TO BE RATED FOR AIR PLENUM INSTALLATION.

DRAWING NOTES:

- 1 INSTALL NEW LAVATORY IN SIMILAR LOCATION AS EXISTING. MODIFY EXTEND PIPING AS REQUIRED.
- (2) INSTALL NEW TOILET IN SIMILAR LOCATION AT EXISTING. MODIFY EXTEND PIPE AS NECESSARY.
- 3 COORDINATE PIPE INSTALLATION HEIGHTS WITH ARCHITECTURAL CEILING REQUIREMENTS PRIOR TO INSTALLATION.
- (4) SANITARY FROM FLOOR DRAIN ABOVE.
- (5) SANITARY LINE FROM LAVATORY ABOVE.
- (6) SANITARY LINE FROM TOILET ABOVE.
- 7 LOOP VENT SINK AS NECESSARY AND THE INTO NEAREST VENT MAIN.
- 8 RUN VENT FROM NEW WASHROOM OVER TO LOCATION OF EXISTING WASHROOM AND CONNECT TO EXISTING VENT STACK.
- 9 NEW SANITARY PIPING. CONTRACTOR TO SCAN EXISTING SLAB TO DETERMINE PROPER TIE-IN LOCATIONS PRIOR TO COMMENCING WORK.
- (10) CONNECT NEW WASHROOM SANITARY DRAIN INTO EXISTING 1000 MAIN. CONTRACTOR TO SCAN SLAB TO DETERMINE EXACT LOCATION PRIOR TO COMMENCING WORK.
- (1) RUN NEW PIPING IN MILLWORK OVER TO TIE-IN LOCATION.
- (12) CONNECT NEW PIPING DOWNSTREAM OF EXISTING WATER METER AT THIS LOCATION.


