ALL OPENINGS THROUGH THE FIRE SEPARATIONS AS A RESULT OF THE WORK OF THIS CONTRACT ARE TO BE FIRE STOPPED AND SEALED WITH ULC APPROVED FIRE STOPPING TO MAINTAIN THE INTEGRITY OF THE FIRE SEPARATION, AND PROVIDE AND SMOKE-TIGHT Barrier.

ALL PRODUCTS AND MATERIALS TO BE USED AND INSTALLED SHALL CONFORM WITH MANUFACTURER'S SPECIFICATIONS & APPLICABLE CODES.

THE CONTRACTOR SHALL BE RESPONSIBLE TO PATCH AND MAKE GOOD ALL EXISTING CONSTRUCTION AFFECTED BY THE REMOVAL OF ALL ITEMS FORMING THE PART OF THE RENOVATION WORK.

WHERE NEW FLOORING AND BASE IS TO BE INSTALLED IN EXISTING AREAS (REFER TO FLOOR PLAN AND ROOM SCHEDULE) THE EXISTING FLOORING SURFACE AND BASE MUST BE REMOVED, UNLESS OTHERWISE NOTED. ALL FLOOR SURFACES SHALL BE PREPARED IN ACCORDANCE TO MANUFACTURER'S RECOMMENDATIONS FOR INSTALLATION OF NEW FLOOR.



- DISCONNECT AND REMOVE ALL CONDUIT, WIRING, CONNECTORS AND ELECTRICAL EQUIPMENT FOR RTU-1, RTU-2 AND GLYCOL CIRC. PUMP BACK TO THE CIRCUIT BREAKERS IN DISTRIBUTION 'B'.
- 2 PROVIDE NEW LISTED CIRCUIT BREAKERS IN THE EXISTING WESTINGHOUSE PANEL BOARD AS INDICATED C/W LISTED MOUNTING HARDWARE.
- 4 Provide New Starters for Pumps 'P-1a' and 'P1-b'.
- 4> PROVIDE NEW ELECTRICAL CONNECTIONS INCLUDING CONDUIT, WIRING AND DISCONNECT SWITCHES FOR THE NEW MECHANICAL EQUIPMENT.
- 5 PROVIDE NEW MCC BUCKETS C/W MCP, OVERLOADS, CONTACTORS, HOA, PILOT LIGHTS AND DISCONNECT SWITCH FOR PUMPS 'P-3A' AND 'P-3B'.
