Revise E21.2(d)(i) to read: The Contract Administrator and City have no information on the existing pumps other than what is shown on the pump and motor nameplates. The existing pumps were manufactured by Fairbanks Morse and manufactured/assembled by ABBA Pump Parts and Service.
