PART B - BIDDING PROCEDURES

B1. CONTRACT TITLE

B1.1 PROVISION OF ELECTROMAGNETIC PIPELINE INSPECTION SERVICES

B2. SUBMISSION DEADLINE

- B2.1 The Submission Deadline is 12:00 noon Winnipeg time, July 14, 2022.
- B2.2 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

B3. SITE INVESTIGATION

- B3.1 Further to C3.1, the Contract Administrator or an authorized representative will be available at the Site at 9:00 a.m. on July 6, 2022 to provide Bidders access to the Site. Bidders are instructed to meet at the first location at 9:00 a.m., after which the site investigation will move to the subsequent location(s).
 - (a) Site 2 Provencher Bridge Force Mains, East Abutment
 - (b) Site 2 Provencher Bridge Force Mains, West Abutment
 - (c) Site 1 Old Forts Bridge Force Mains, North Abutment
 - (d) Site 1 Old Forts Bridge Force Mains, South Abutment
 - (e) Site 3 Norwood Bridge Force Main, North Abutment
 - (f) Site 5 West Perimeter Force Main, Pumping Station
- B3.2 Proponents attending the site investigation are required to register for the site investigation at least 48 hours prior by contacting the Contract Administrator listed in D5.
- B3.3 The Bidder is advised that access to pipelines at bridge sites is considered Confined Space and access is restricted. Confined space entry will not be permitted during Site Investigations.
- B3.4 Although attendance at the Site Investigation is not mandatory, the City strongly suggests that Bidders attend.
- B3.5 The Bidder shall not be entitled to rely on any information or interpretation received at the site investigation unless that information or interpretation is the Bidder's direct observation, or is provided by the Contract Administrator in writing.
- B3.6 The Bidder may view portions of the site located within public right-of-ways without making an appointment.

B4. ENQUIRIES

- B4.1 All enquiries shall be directed to the Contract Administrator identified in D5.1.
- B4.2 If the Bidder finds errors, discrepancies or omissions in the Tender, or is unsure of the meaning or intent of any provision therein, the Bidder shall notify the Contract Administrator of the error, discrepancy or omission, or request a clarification as to the meaning or intent of the provision at least five (5) Business Days prior to the Submission Deadline.
- B4.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Tender will be provided by the Contract Administrator to all Bidders by issuing an addendum.

- B4.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Tender will be provided by the Contract Administrator only to the Bidder who made the enquiry.
- B4.5 The Bidder shall not be entitled to rely on any response or interpretation received pursuant to B4 unless that response or interpretation is provided by the Contract Administrator in writing.

B5. CONFIDENTIALITY

- B5.1 Information provided to a Bidder by the City or acquired by a Bidder by way of further enquiries or through investigation is confidential. Such information shall not be used or disclosed in any way without the prior written authorization of the Contract Administrator. The use and disclosure of the confidential information shall not apply to information which:
 - (a) was known to the Bidder before receipt hereof; or
 - (b) becomes publicly known other than through the Bidder; or
 - (c) is disclosed pursuant to the requirements of a governmental authority or judicial order.
- B5.2 The Bidder shall not make any statement of fact or opinion regarding any aspect of the Tender to the media or any member of the public without the prior written authorization of the Contract Administrator.

B6. ADDENDA

- B6.1 The Contract Administrator may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Tender, or clarifying the meaning or intent of any provision therein.
- B6.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B6.3 Addenda will be available on the MERX website at www.merx.com.
- B6.4 The Bidder is responsible for ensuring that he/she has received all addenda and is advised to check the MERX website for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.
- B6.5 The Bidder shall acknowledge receipt of each addendum in Paragraph 10 of Form A: Bid/Proposal. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.
- B6.6 Notwithstanding B4, enquiries related to an Addendum may be directed to the Contract Administrator indicated in D5.

B7. SUBSTITUTES

- B7.1 The Work is based on the Plant, Materials and methods specified in the Tender.
- B7.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B7.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.

- B7.4 The Bidder shall ensure that any and all requests for approval of a substitute:
 - (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative:
 - (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
 - (c) identify any anticipated cost or time savings that may be associated with the substitute;
 - (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance:
 - (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B7.5 The Contract Administrator, after assessing the request for approval of a substitute, may in his/her sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.
- B7.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, to the Bidder who requested approval of the substitute.
- B7.6.1 The Contract Administrator will issue an Addendum, disclosing the approved materials, equipment, methods and products to all potential Bidders. The Bidder requesting and obtaining the approval of a substitute shall be responsible for disseminating information regarding the approval to any person or persons he/she wishes to inform.
- B7.7 If the Contract Administrator approves a substitute as an "approved equal", any Bidder may use the approved equal in place of the specified item.
- B7.8 If the Contract Administrator approves a substitute as an "approved alternative", any Bidder bidding that approved alternative may base his/her Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B18.
- B7.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.

B8. BID COMPONENTS

- B8.1 The Bid shall consist of the following components:
 - (a) Form A: Bid/Proposal;
 - (b) Form B: Prices;
 - (c) Form G1: Bid Bond and Agreement to Bond.
- B8.2 All components of the Bid shall be fully completed or provided, and submitted by the Bidder no later than the Submission Deadline, with all required entries made clearly and completely.
- B8.3 The Bid shall be submitted electronically through MERX at www.merx.com.
- B8.3.1 Bids will **only** be accepted electronically through MERX.

B8.4 Bidders are advised that inclusion of terms and conditions inconsistent with the Tender document, including the General Conditions, will be evaluated in accordance with B18.1(a).

B9. BID

- B9.1 The Bidder shall complete Form A: Bid/Proposal, making all required entries.
- B9.2 Paragraph 2 of Form A: Bid/Proposal shall be completed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his/her own name, his/her name shall be inserted:
 - (b) if the Bidder is a partnership, the full name of the partnership shall be inserted;
 - (c) if the Bidder is a corporation, the full name of the corporation shall be inserted;
 - (d) if the Bidder is carrying on business under a name other than his/her own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B9.2.1 If a Bid is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B9.2.
- B9.3 In Paragraph 3 of Form A: Bid/Proposal, the Bidder shall identify a contact person who is authorized to represent the Bidder for purposes of the Bid.
- B9.4 Paragraph 13 of Form A: Bid/Proposal shall be signed in accordance with the following requirements:
 - (a) if the Bidder is a sole proprietor carrying on business in his/her own name, it shall be signed by the Bidder;
 - (b) if the Bidder is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
 - (c) if the Bidder is a corporation, it shall be signed by its duly authorized officer or officers;
 - (d) if the Bidder is carrying on business under a name other than his/her own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B9.4.1 The name and official capacity of all individuals signing Form A: Bid/Proposal should be entered below such signatures.
- B9.5 If a Bid is submitted jointly by two or more persons, the word "Bidder" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Bidders in the Bid and the Contract, when awarded, shall be both joint and several.

B10. PRICES

- B10.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- B10.1.1 Notwithstanding C12.2.3(c), prices on Form B: Prices shall not include the Manitoba Retail Sales Tax (MRST, also known as PST), which shall be extra where applicable.
- B10.1.2 Prices stated on Form B: Prices shall not include any costs which may be incurred by the Contractor with respect to any applicable funding agreement obligations as outlined in D28. Any such costs shall be determined in accordance with D28.
- B10.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.

- B10.3 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.
- B10.4 Payments to Non-Resident Contractors are subject to Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).
- B10.5 The Bidder shall enter the Total Bid Price from Form B: Prices into the Total Bid Price field in MERX.
- B10.5.1 Bidders are advised that the calculation indicated in B18.4 will prevail over the Total Bid Price entered in MERX.

B11. DISCLOSURE

- B11.1 Various Persons provided information or services with respect to this Work. In the City's opinion, this relationship or association does not create a conflict of interest because of this full disclosure. Where applicable, additional material available as a result of contact with these Persons is listed below.
- B11.2 The Persons are:
 - (a) PICA Corporation
 - (i) Technical requirements for inspection technologies.

B12. CONFLICT OF INTEREST AND GOOD FAITH

- B12.1 Further to C3.2, Bidders, by responding to this Tender, declare that no Conflict of Interest currently exists, or is reasonably expected to exist in the future.
- B12.2 Conflict of Interest means any situation or circumstance where a Bidder or employee of the Bidder proposed for the Work has:
 - (a) other commitments;
 - (b) relationships;
 - (c) financial interests; or
 - (d) involvement in ongoing litigation;

that could or would be seen to:

- exercise an improper influence over the objective, unbiased and impartial exercise of the independent judgment of the City with respect to the evaluation of Bids or award of the Contract; or
- (ii) compromise, impair or be incompatible with the effective performance of a Bidder's obligations under the Contract;
- (e) has contractual or other obligations to the City that could or would be seen to have been compromised or impaired as a result of its participation in the Tender process or the Work; or
- (f) has knowledge of confidential information (other than confidential information disclosed by the City in the normal course of the Tender process) of strategic and/or material relevance to the Tender process or to the Work that is not available to other bidders and that could or would be seen to give that Bidder an unfair competitive advantage.
- B12.3 In connection with its Bid, each entity identified in B12.2 shall:
 - (a) avoid any perceived, potential or actual Conflict of Interest in relation to the procurement process and the Work;
 - (b) upon discovering any perceived, potential or actual Conflict of Interest at any time during the Tender process, promptly disclose a detailed description of the Conflict of Interest to the City in a written statement to the Contract Administrator; and

- (c) provide the City with the proposed means to avoid or mitigate, to the greatest extent practicable, any perceived, potential or actual Conflict of Interest and shall submit any additional information to the City that the City considers necessary to properly assess the perceived, potential or actual Conflict of Interest.
- B12.4 Without limiting B12.3, the City may, in its sole discretion, waive any and all perceived, potential or actual Conflicts of Interest. The City's waiver may be based upon such terms and conditions as the City, in its sole discretion, requires to satisfy itself that the Conflict of Interest has been appropriately avoided or mitigated, including requiring the Bidder to put into place such policies, procedures, measures and other safeguards as may be required by and be acceptable to the City, in its sole discretion, to avoid or mitigate the impact of such Conflict of Interest.
- B12.5 Without limiting B12.3, and in addition to all contractual or other rights or rights at law or in equity or legislation that may be available to the City, the City may, in its sole discretion:
 - (a) disqualify a Bidder that fails to disclose a perceived, potential or actual Conflict of Interest of the Bidder or any of its employees proposed for the Work;
 - (b) require the removal or replacement of any employees proposed for the Work that has a perceived, actual or potential Conflict of Interest that the City, in its sole discretion, determines cannot be avoided or mitigated;
 - (c) disqualify a Bidder or employees proposed for the Work that fails to comply with any requirements prescribed by the City pursuant to B12.4 to avoid or mitigate a Conflict of Interest; and
 - (d) disqualify a Bidder if the Bidder, or one of its employees proposed for the Work, has a perceived, potential or actual Conflict of Interest that, in the City's sole discretion, cannot be avoided or mitigated, or otherwise resolved.
- B12.6 The final determination of whether a perceived, potential or actual Conflict of Interest exists shall be made by the City, in its sole discretion.

B13. QUALIFICATION

- B13.1 The Bidder shall:
 - (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba; and
 - (b) be financially capable of carrying out the terms of the Contract; and
 - (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.
- B13.2 The Bidder and any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at https://www.winnipeg.ca/matmgt/Templates/files/debar.pdf
- B13.3 The Bidder and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
 - (a) have successfully carried out work similar in nature, scope and value to the Work; and
 - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and
 - (c) have a written workplace safety and health program if required pursuant to The Workplace Safety and Health Act (Manitoba);

 - (d) have completed the Accessible Customer Service online training required by the Accessibility for Manitobans Act (AMA) (see B13.6 and D8), and
 - (e) upon request of the Contract Administrator, provide the Security Clearances in accordance with PART F .
- B13.4 Further to B13.3, the Bidder and/or any proposed Subcontractor undertaking the Work shall, within five (5) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator to demonstrate the following qualifications in accordance with E5:
 - (a) A minimum of three (3) examples of successful internal electromagnetic inspections, conforming to the minimum technical and detection requirements in E5.3(a) on:
 - (i) Steel Force Mains with a minimum diameter of 400 mm.
 - (b) A minimum of three (3) examples of successfully external electromagnetic inspections, conforming to the minimum technical and detection requirements in E5.3(a) on:
 - (i) Steel Force Mains with a minimum diameter of 400 mm.
- B13.5 Further to B13.3(c), the Bidder shall, within five (5) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator that the Bidder/Subcontractor has a workplace safety and health program meeting the requirements of The Workplace Safety and Health Act (Manitoba), by providing:
 - (a) Written confirmation of a safety and health certification meeting SAFE Work Manitoba's SAFE Work Certified Standard (e.g., COR™ and SECOR™) in the form of:
 - (i) a copy of their valid Manitoba COR certificate and Letter of Good Standing (or Manitoba equivalency) as issued under the Certificate of Recognition (COR) Program administered by the Construction Safety Association of Manitoba or by the Manitoba Heavy Construction Association's WORKSAFELY™ COR™ Program; or
 - (ii) a copy of their valid Manitoba SECOR™ certificate and Letter of Good Standing (or Manitoba equivalency) as issued under the Small Employer Certificate of Recognition Program (SECOR™) administered by the Construction Safety Association of Manitoba or by the Manitoba Heavy Construction Association's WORKSAFELY™ COR™ Program; or
 - (b) a report or letter to that effect from an independent reviewer acceptable to the City. (A list of acceptable reviewers and the review template are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/.
- B13.6 Further to B13.3(d), the Bidder acknowledges they and all Subcontractors have obtained training required by the Accessibility for Manitobans Act (AMA) available at http://www.accessibilitymb.ca/training.html for anyone that may have any interaction with the public on behalf of the City of Winnipeg.
- B13.7 The Bidder shall submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Bidder and of any proposed Subcontractor.
- B13.8 The Bidder shall provide, on the request of the Contract Administrator, full access to any of the Bidder's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.

B14. BID SECURITY

B14.1 The Bidder shall include in its Bid Submission bid security in the form of a digital bid bond, in the amount of at least ten percent (10%) of the Total Bid Price, and agreement to bond of a company registered to conduct the business of a surety in Manitoba, in Form G1: Bid Bond and Agreement to Bond, available on The City of Winnipeg, Corporate Finance, Materials

Management Division website at https://www.winnipeg.ca/MatMqt/templates/files/eBidsecurity.pdf.

- B14.2 Bid security shall be submitted in a digital format meeting the following criteria:
 - (a) The version submitted by the Bidder must have valid digital signatures and seals;
 - (b) The version submitted by the Bidder must be verifiable by the City with respect to the totality and wholeness of the bond form, including: the content; all digital signatures and digital seals; with the surety company, or an approved verification service provider of the surety company.
 - (c) The version submitted must be viewable, printable and storable in standard electronic file formats compatible with the City, and in a single file. Allowable formats include pdf.
 - (d) The verification may be conducted by the City immediately or at any time during the life of the bond and at the discretion of the City with no requirement for passwords or fees.
 - (e) The results of the verification must provide a clear, immediate and printable indication of pass or fail regarding B14.2(a).
- B14.3 Bonds failing the verification process will not be considered to be valid and the bid shall be determined to be non-responsive in accordance with B18.1(a).
- B14.4 Bonds passing the verification process will be treated as original and authentic.
- B14.4.1 If the Bidder submits alternative bids, the bid security shall be in the amount of the specified percentage of the highest Total Bid Price submitted.
- B14.5 The bid security of the successful Bidder and the next two lowest evaluated responsive and responsible Bidders will be released by the City when a Contract for the Work has been duly formed with the successful Bidder and the contract securities are furnished as provided herein. The bid securities of all other Bidders will be released when a Contract is awarded.
- B14.6 The bid securities of all Bidders will be released by the City as soon as practicable following notification by the Contract Administrator to the Bidders that no award of Contract will be made pursuant to the Tender.

B15. OPENING OF BIDS AND RELEASE OF INFORMATION

- B15.1 Bids will not be opened publicly.
- B15.2 Following the Submission Deadline, the names of the Bidders and their Total Bid Prices (unevaluated and pending review and verification of conformance with requirements) will be available on the MERX website at www.merx.com.
- B15.3 After award of Contract, the name(s) of the successful Bidder(s) and their Contract amount(s) will be available on the MERX website at www.merx.com.
- B15.4 The Bidder is advised that any information contained in any Bid may be released if required by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law or by City policy or procedures (which may include access by members of City Council).
- B15.4.1 To the extent permitted, the City shall treat as confidential information, those aspects of a Bid Submission identified by the Bidder as such in accordance with and by reference to Part 2, Section 17 or Section 18 or Section 26 of The Freedom of Information and Protection of Privacy Act (Manitoba), as amended.

B16. IRREVOCABLE BID

B16.1 The Bid(s) submitted by the Bidder shall be irrevocable for the time period specified in Paragraph 11 of Form A: Bid/Proposal.

B16.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work until a Contract for the Work has been duly formed and the contract securities have been furnished as herein provided, but any Bid shall be deemed to have lapsed unless accepted within the time period specified in Paragraph 11 of Form A: Bid/Proposal.

B17. WITHDRAWAL OF BIDS

B17.1 A Bidder may withdraw his/her Bid without penalty at any time prior to the Submission Deadline.

B18. EVALUATION OF BIDS

- B18.1 Award of the Contract shall be based on the following bid evaluation criteria:
 - (a) compliance by the Bidder with the requirements of the Tender, or acceptable deviation there from (pass/fail);
 - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B13 (pass/fail);
 - (c) Total Bid Price;
 - (d) economic analysis of any approved alternative pursuant to B7.
- B18.2 Further to B18.1(a), the Award Authority may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements or minor informalities or irregularities, if the interests of the City so require.
- B18.3 Further to B18.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his/her Bid or in other information required to be submitted, that he/she is qualified.
- B18.4 Further to B18.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices.
- B18.4.1 Bidders are advised that the calculation indicated in B18.4 will prevail over the Total Bid Price entered in MERX.
- B18.4.2 Further to B18.1(a), in the event that a unit price is not provided on Form B: Prices, the City may determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.

B19. AWARD OF CONTRACT

- B19.1 The City will give notice of the award of the Contract or will give notice that no award will be made.
- B19.2 The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be qualified, and the Bids are determined to be responsive.
- B19.2.1 Without limiting the generality of B19.2, the City will have no obligation to award a Contract where:
 - (a) the prices exceed the available City funds for the Work;
 - (b) the prices are materially in excess of the prices received for similar work in the past;
 - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with its own forces;
 - (d) only one Bid is received; or
 - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.

- B19.3 If funding for the Work is provided to the City of Winnipeg by the Government of Manitoba and/or the Government of Canada, Bidders are advised that the terms of D28 shall immediately take effect upon confirmation of such funding, regardless of when funding is confirmed.
- B19.4 Where an award of Contract is made by the City, the award shall be made to the qualified Bidder submitting the lowest evaluated responsive Bid, in accordance with B18.
- B19.4.1 Following the award of contract, a Bidder will be provided with information related to the evaluation of his/her Bid upon written request to the Contract Administrator.

PART C - GENERAL CONDITIONS

CO. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2020-01-31) are applicable to the Work of the Contract.
- C0.1.1 The General Conditions for Construction are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/gen_cond.stm
- C0.2 A reference in the Tender to a section, clause or subclause with the prefix "C" designates a section, clause or subclause in the *General Conditions for Construction*.

PART D - SUPPLEMENTAL CONDITIONS

GENERAL

D1. GENERAL CONDITIONS

D1.1 In addition to the *General Conditions for Construction*, these Supplemental Conditions are applicable to the Work of the Contract.

D2. FORM OF CONTRACT DOCUMENTS

D2.1 Notwithstanding C4.1(c) and C4.4, the Contract Documents will be provided to the Contractor electronically and there will be no requirement for execution and return to the City by the Contractor. Accordingly, the provisions under C4.4(a) and C4.4(b) are no longer applicable.

D3. SCOPE OF WORK

- D3.1 The Work to be done under the Contract shall consist of inspection of steel sewer force mains crossing rivers by use of internal and external electromagnetic inspection equipment, including planning, inspection, data analysis and reporting.
- D3.2 The major components of the Work are as follows:
 - (a) Inspection Planning;
 - (b) Mobilization;
 - (c) External Inspection of three (3) sewer force mains by electromagnetic methods, contained within girders on two (2) bridges
 - (d) External Inspection of one (1) sewer force main by electromagnetic methods, suspended below a bridge;
 - (e) Internal inspection on one (1) force main by electromagnetic methods, buried below a river.
 - (f) Data analysis; and
 - (g) Reporting.

D4. DEFINITIONS

- D4.1 When used in this Tender:
 - (a) "ASTM" means American Society for Testing and Materials.
 - (b) "AWWA" means American Water Works Association.
 - (c) "CCTV" means Closed Circuit Television.
 - (d) "Contractor" or "Inspection Contractor" means the Contractor completing the work identified in this tender.
 - (e) "CSA" means Canadian Standards Association.
 - (f) "Proponent" means any Person or Persons submitting a bid.
 - (g) "Site 1" means the Old Forts Bridge Force Mains crossing of the Assiniboine River.
 - (h) "Site 2" means the Provencher Bridge Force Mains crossing of the Red River.
 - (i) "Site 3" means the Norwood Bridge Force Main crossing of the Red River.
 - (j) "Site 5" means the West Perimeter Force Main crossing of the Assiniboine River.
 - (k) "Support Contractor" means a third-party contractor engaged by the City under Tender 507-2021 to provide pipeline access modifications, pipeline cleaning and inspection support services in support of inspection work under this tender.

D5. CONTRACT ADMINISTRATOR

D5.1 The Contract Administrator is AECOM, represented by:

D5.2 At the pre-construction meeting, Mr. Beavis will identify additional personnel representing the Contract Administrator and their respective roles and responsibilities for the Work.

D6. CONTRACTOR'S SUPERVISOR

D6.1 At the pre-construction meeting, the Contractor shall identify his/her designated supervisor and any additional personnel representing the Contractor and their respective roles and responsibilities for the Work.

D7. NOTICES

- D7.1 Except as provided for in C22.4, all notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the Contractor shall be sent to the address or facsimile number identified by the Contractor in Paragraph 2 of Form A: Bid/Proposal.
- D7.2 All notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications to the City, except as expressly otherwise required in D7.3 or elsewhere in the Contract, shall be sent to the attention of the Contract Administrator identified in D5.
- D7.3 All notices, requests, nominations, proposals, consents, approvals, statements, authorizations, documents or other communications required to be submitted or returned to the City Solicitor shall be sent to the following facsimile number:

D8. ACCESSIBLE CUSTOMER SERVICE REQUIREMENTS

- D8.1 The Accessibility for Manitobans Act (AMA) imposes obligations on The City of Winnipeg to provide accessible customer service to all persons in accordance with the Customer Service Standard Regulation ("CSSR") to ensure inclusive access and participation for all people who live, work or visit Winnipeg regardless of their abilities.
- D8.1.1 The Contractor agrees to comply with the accessible customer service obligations under the CSSR and further agrees that when providing the Goods or Services or otherwise acting on the City of Winnipeg's behalf, shall comply with all obligations under the AMA applicable to public sector bodies.
- D8.1.2 The accessible customer service obligations include, but are not limited to:
 - (a) providing barrier-free access to goods and services;
 - (b) providing reasonable accommodations;
 - (c) reasonably accommodating assistive devices, support persons, and support animals;
 - (d) providing accessibility features e.g. ramps, wide aisles, accessible washrooms, power doors and elevators;
 - (e) inform the public when accessibility features are not available;

 - (f) providing a mechanism or process for receiving and responding to public feedback on the accessibility of all goods and services; and
 - (g) providing adequate training of staff and documentation of same.

D9. FURNISHING OF DOCUMENTS

D9.1 Upon award of the Contract, the Contractor will be provided with 'issued for construction' Contract Documents electronically, including Drawings in PDF format only.

SUBMISSIONS

D10. AUTHORITY TO CARRY ON BUSINESS

D10.1 The Contractor shall be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Contractor does not carry on business in Manitoba, in the jurisdiction where the Contractor does carry on business, throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

D11. SAFE WORK PLAN

- D11.1 The Contractor shall provide the Contract Administrator with a Safe Work Plan at least five (5) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract Documents, if applicable.
- D11.2 The Safe Work Plan should be prepared and submitted in the format shown in the City's template which is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/Safety/default.stm
- D11.3 Notwithstanding B13.4 at any time during the term of the Contract, the City may, at its sole discretion and acting reasonably, require an updated COR Certificate or Annual Letter of good Standing. A Contractor, who fails to provide a satisfactory COR Certificate or Annual Letter of good Standing, will not be permitted to continue to perform any Work.

D12. INSURANCE

- D12.1 The Contractor shall provide and maintain the following insurance coverage:
 - (a) commercial general liability insurance, in the amount of at least two million dollars (\$2,000,000.00) inclusive, with The City of Winnipeg added as an additional insured, with a cross-liability clause, such liability policy to also contain contractual liability, unlicensed motor vehicle liability, non-owned automobile liability, broad form property damage cover and products and completed operations, to remain in place at all times during the performance of the Work and throughout the warranty period;
 - (b) if applicable, Automobile Liability Insurance covering all motor vehicles, owned and operated and used or to be used by the Contractor directly or indirectly in the performance of the Work. The Limit of Liability shall not be less than \$2,000,000 inclusive for loss or damage including personal injuries and death resulting from any one accident or occurrence.
 - (c) an all risks Installation Floater carrying adequate limits to cover all machinery, equipment, supplies and/or materials intended to enter into and form part of any installation.
- D12.2 Deductibles shall be borne by the Contractor.
- D12.3 The Contractor shall provide the City Solicitor with a certificate(s) of insurance, in a form satisfactory to the City Solicitor, at least two (2) Business Days prior to the commencement of

- any Work but in no event later than the date specified in C4.1 for the return of the executed Contract Documents, as applicable.
- D12.4 The Contractor shall not cancel, materially alter, or cause each policy to lapse without providing at least thirty (30) Calendar Days prior written notice to the Contract Administrator.

D13. CONTRACT SECURITY

- D13.1 The Contractor shall provide and maintain the performance bond and the labour and material payment bond until the expiration of the warranty period in the form of:
 - (a) a performance bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H1: Performance Bond), in the amount of fifty percent (50%) of the Contract Price; and
 - (b) a labour and material payment bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H2: Labour and Material Payment Bond), in an amount equal to fifty percent (50%) of the Contract Price.
- D13.1.1 Where the contract security is a performance bond, it may be submitted in hard copy or digital format. If submitted in digital format the contract security must meet the following criteria:
 - (a) the version submitted by the Contractor must have valid digital signatures and seals;
 - (b) the version submitted by the Contractor must be verifiable by the City with respect to the totality and wholeness of the bond form, including: the content; all digital signatures and digital seals; with the surety company, or an approved verification service provider of the surety company.
 - (c) the version submitted must be viewable, printable and storable in standard electronic file formats compatible with the City, and in a single file. Allowable formats include pdf.
 - (d) the verification may be conducted by the City immediately or at any time during the life of the bond and at the discretion of the City with no requirement for passwords or fees.
 - (e) the results of the verification must provide a clear, immediate and printable indication of pass or fail regarding D13.1(b).
- D13.1.2 Digital bonds failing the verification process will not be considered to be valid and may be determined to be an event of default in accordance with C18.1. If a digital bond fails the verification process, the Contractor may provide a replacement bond (in hard copy or digital format) within seven (7) Calendar Days of the City's request or within such greater period of time as the City in its discretion, exercised reasonably, allows.
- D13.1.3 Digital bonds passing the verification process will be treated as original and authentic.
- D13.2 The Contractor shall provide the City Solicitor with the required performance and labour and material payment bonds within seven (7) Calendar Days of notification of the award of the Contract by way of an award letter and prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract Documents, if applicable.
- D13.3 The Contractor shall, as soon as practicable after entering into a contract with a Subcontractor:
 - (a) give the Subcontractor written notice of the existence of the labour and material payment bond in D13.1(b); and
 - (b) post a notice of the bond and/or a copy of that bond in a conspicuous location at the Site of the Work.

D14. EQUIPMENT LIST

D14.1 The Contractor shall provide the Contract Administrator with a complete list of the equipment which the Contractor proposes to utilize at least two (2) Business Days prior to the commencement of any Work on the Site.

D15. DETAILED WORK SCHEDULE

- D15.1 The Contractor shall provide the Contract Administrator with a detailed work schedule at least two (2) Business Days prior to the commencement of any Work on the Site.
- D15.2 The detailed work schedule shall consist of the following:
 - (a) a Gantt chart for the Work.
- D15.3 Further to D15.2(a), the schedule shall clearly identify the start and completion dates of all of the following activities/tasks making up the Work as well as showing those activities/tasks (please note the sequence of Site Numbers from Site 1 to 3 and 5 is to accommodate other works outside of this contract):
 - (a) Planning
 - (b) Mobilization;
 - (c) Site 1 Field Inspection;
 - (d) Site 2 Field Inspection;
 - (e) Site 3 Field Inspection;
 - (f) Site 5 Field Inspection;
 - (g) Draft Data Analysis Report; and
 - (h) Final Data Analysis Report

D16. REQUIREMENTS FOR SITE ACCESSIBILITY PLAN

- D16.1 The Contractor shall provide the Contract Administrator with an Accessibility Plan at least five (5) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract Documents, if applicable.
- D16.2 The Accessibility Plan shall demonstrate how the Contractor will accommodate the safe passage of pedestrians and cyclists in accordance with the Manual of Temporary Traffic Control, the Contract Drawings, Staging Plans, and Streets By-Law No. 1481/77 at all times for the duration of the Construction. Unless noted in the Contract, the Accessibility Plan must include a written plan for the following:
 - (a) How the Contractor will maintain at least one crossing in each direction for each intersection (one north/south crosswalk and one east/west crosswalk).
 - (b) How the Contractor will maintain access to bus stops within the site.
 - (c) How the Contractor will maintain access to pedestrian corridors and half signals.
 - (d) How the Contractor will maintain cycling facilities.
 - (e) How the Contractor will maintain access to residents and businesses unless otherwise noted in the Contract.
 - (f) Any required detour signage at adjacent crossings to facilitate sidewalk or active transportation pathway closures.
- D16.3 The Accessibility Plan may also include figures, sketches, or drawings to demonstrate the proposed plan.

- D16.4 The Accessibility Plan shall include written details on how the Contractor intends to review, maintain, and document all items related to the Accessibility Plan on-site during Construction, including, but not limited to:
 - (a) Signage
 - (b) Temporary Ramping
 - (c) Transit Stops
 - (d) Detour Signage
- D16.5 At minimum, the Contractor shall review the site conditions on a daily basis to ensure that all features related to the Accessibility Plan are in place. The site review is intended to correct deficiencies as a result of unforeseen events such as wind, traffic, or the general public.

 Deficiencies that are direct result of the Contractors actions must be corrected immediately.
- D16.6 Any changes to the Accessibility Plan must be approved by the Contract Administrator.
- D16.7 Upon request from the Contract Administrator, the Contractor shall provide records demonstrating that the site has been maintained.
- D16.8 Deficiencies as a direct result of actions by the Contractor that are not immediately corrected and/or failure to produce records that demonstrate that the site was maintained in compliance with the Accessibility Plan may result in a pay adjustment via the monthly Progress Payment. The rate of pay adjustment will be as per the following schedule:
 - (a) First Offence A warning will be issued and documented in the weekly or bi-weekly site meeting.
 - (b) Second Offence A field instruction to immediately correct the site will be issued by the Contract Administrator.
- D16.9 Third and subsequent Offences A pay reduction will be issued in the amount of \$250.00 per instance and per day.

SCHEDULE OF WORK

D17. COMMENCEMENT

- D17.1 The Contractor shall not commence any Work until he/she is in receipt of an award letter from the Award Authority authorizing the commencement of the Work.
- D17.2 The Contractor shall not commence any Work on the Site until:
 - (a) the Contract Administrator has confirmed receipt and approval of:
 - (i) evidence of authority to carry on business specified in D10;
 - (ii) evidence of the workers compensation coverage specified in C6.15;
 - (iii) the Safe Work Plan specified in D11;
 - (iv) evidence of the insurance specified in D12;
 - (v) the contract security specified in D13;
 - (vi) the Equipment List specified in D14;
 - (vii) the Detailed Work Schedule specified in D15;
 - (viii) the Requirements for Site Accessibility Plan specified in D16; and
 - (ix) the direct deposit application form specified in D25.
 - (b) the Contractor has attended a pre-construction meeting with the Contract Administrator, or the Contract Administrator has waived the requirement for a pre-construction meeting.
- D17.3 The City intends to award this Contract by August 26, 2022.

D17.3.1 If the actual date of award is later than the intended date, the dates specified for Critical Stages, Substantial Performance, and Total Performance will be adjusted by the difference between the aforementioned intended and actual dates.

D18. SCHEDULE RESTRICTIONS

- D18.1 Force Main Shutdowns
- D18.1.1 Inspections at Site 1, 2 and 3 are to be completed while the respective force mains remain in service.
- D18.1.2 Inspection at Site 5 requires the force main to be taken out of service and an active flow bypass system installed (by others). Inspections windows are dependent on the City's ability to isolate and dewater the identified force mains for modification and access under Tender 507-2021.
- D18.1.3 Force main shutdowns will be scheduled based on a number of factors including scheduled maintenance and/or repair work, weather and other factors.
- D18.1.4 Work must be scheduled outside of potential wet weather conditions, typically late fall. The City shall endeavour to make the specified time periods available to the Contractor to schedule his Work requiring isolation and draining of various force mains, without limiting the City's control over the operation of the regional sewer system to complete other work, maintain adequate system service and maintain the integrity of the infrastructure. The City shall reserve the right to cancel and/or delay these schedule dates at any time, due to any circumstances that could adversely affect system operation, including but not limited to high service demand, abnormal weather, failures of related system components and/or security concerns.
 - (b) Work at Site 5 requiring lift station shutdown or use of bypass pumping shall not occur before September 15.

D19. CRITICAL STAGES

- D19.1 The Contractor shall achieve critical stages of the Work in accordance with the following requirements:
 - (a) Mobilization for Pipeline Inspection The Contractor shall mobilize and be prepared to undertake the identified inspections by the dates established in D19.2(a) and D19.2(b).
 - (b) Submission of Draft Data Report A draft data report shall be submitted within sixty (60) Calendar Days of completion of the data collection.
 - (c) Submission of Final Data Report A final data report shall be submitted within thirty (30) Calendar Days of receipt of comments from the Contractor Administrator on the submitted draft report.
- D19.2 Final Critical Stage Dates for on site inspection will be established immediately upon receipt of Letter of Award, on a mutually agreeable schedule between the Support Contractor(s), the City of Winnipeg, and the successful Inspection Contractor based on the availability of all parties and procurement of materials. The Contract Administrator will schedule a meeting with all parties within three (3) Business Days of receipt of the Letter of Award. Schedule dates shall be limited by the following dates:
 - (a) Critical Stage- External EM Inspections of pipelines (Sites 1, 2 and 3)- will be available no later than November 14, 2022 and shall be completed within five (5) Calendar Days of being available for inspection.
 - (b) Critical Stage- Internal EM Inspections pipeline (Site 5) will be available no later than November 14, 2022, and shall be completed within seven (7) Calendar Days of being available for inspection.
- D19.3 Once inspection dates are established, the Critical Stage Date(s) identified in D19.2 will be established.

D20.

SUBSTANTIAL PERFORMANCE

- D20.1 The Contractor shall achieve Substantial Performance by January 28, 2023.
- D20.2 When the Contractor considers the Work to be substantially performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Substantial Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.
- D20.3 The date on which the Work has been certified by the Contract Administrator as being substantially performed to the requirements of the Contract through the issue of a certificate of Substantial Performance is the date on which Substantial Performance has been achieved.

D21. TOTAL PERFORMANCE

- D21.1 The Contractor shall achieve Total Performance by March 2, 2023.
- D21.2 When the Contractor or the Contract Administrator considers the Work to be totally performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Total Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.
- D21.3 The date on which the Work has been certified by the Contract Administrator as being totally performed to the requirements of the Contract through the issue of a certificate of Total Performance is the date on which Total Performance has been achieved.

D22. LIQUIDATED DAMAGES

- D22.1 If the Contractor fails to achieve, Critical Stages, Substantial Performance or Total Performance in accordance with the Contract by the days fixed herein for same, the Contractor shall pay the City the following amounts per Calendar Day for each and every Calendar Day following the days fixed herein for same during which such failure continues:
 - (a) Critical Stage- External EM Inspections of pipelines (Sites 1, 2 and 3)- two thousand dollars (\$2000);
 - (b) Critical Stage- Internal EM Inspections pipeline (Site 5) two thousand dollars (\$2000);
 - (c) Substantial Performance one hundred dollars (\$100);
 - (d) Total Performance one hundred dollars (\$100).
- D22.2 The amounts specified for liquidated damages in D22.1 are based on a genuine pre-estimate of the City's losses in the event that the Contractor does not achieve, Critical Stages, Substantial Performance or Total Performance by the days fixed herein for same.
- D22.3 The City may reduce any payment to the Contractor by the amount of any liquidated damages assessed.

D23. COVID-19 SCHEDULE DELAYS

- D23.1 The City acknowledges that the schedule for this Contract may be impacted by the COVID-19 pandemic. Commencement and progress of the Work shall be performed by the Contractor with due consideration to the health and safety of workers and the public, directives from health authorities and various levels of government and in close consultation with the Contract Administrator.
- D23.2 If the Contractor is delayed in the performance of the Work by reason of the COVID-19 pandemic, the Work schedule may be adjusted by a period of time equal to the time lost due to such delay and costs related to such delay will be determined as identified herein.

- D23.3 A minimum of seven (7) Calendar Days prior to the commencement of Work, the Contractor shall declare whether COVID-19 will affect the start date. The Contractor shall provide sufficient evidence that the delay is directly related to COVID-19, including but not limited to evidence related to availability of staff, availability of Material or work by others.
- D23.4 For any delay related to COVID-19 and identified after Work has commenced, the Contractor shall within seven (7) Calendar Days of becoming aware of the anticipated delay declare the additional delay and shall provide sufficient evidence as indicated in D22.3. Failure to provide this notice will result in no additional time delays being considered by the City.
- D23.5 The Work schedule, including the durations identified in D19 to D21 where applicable, will be adjusted to reflect delays accepted by the Contract Administrator. No additional payment will be made for adjustment of schedules except where seasonal work, not previously identified in the Contract, is carried over to the following construction season.
- D23.6 Where Work not previously identified is being carried over solely as a result of delays related to COVID-19, as confirmed by the Contract Administrator, the cost of temporary works to maintain the Work in a safe manner until Work recommences, will be considered by the Contract Administrator. Where the Work is carried over only partially due to COVID-19, a partial consideration of the cost of temporary works will be considered by the Contract Administrator.
- D23.7 Any time or cost implications as a result of COVID-19 and in accordance with the above, as confirmed by the Contract Administrator, shall be documented in accordance with C7.

CONTROL OF WORK

D24. JOB MEETINGS

- D24.1 Regular weekly job meetings will be held at the Site. These meetings shall be attended by a minimum of one representative of the Contract Administrator, one representative of the City and one representative of the Contractor. Each representative shall be a responsible person capable of expressing the position of the Contract Administrator, the City and the Contractor respectively on any matter discussed at the meeting including the Work schedule and the need to make any revisions to the Work schedule. The progress of the Work will be reviewed at each of these meetings.
- D24.2 The Contract Administrator reserves the right to cancel any job meeting or call additional job meetings whenever he/she deems it necessary.

D25. PRIME CONTRACTOR – THE WORKPLACE SAFETY AND HEALTH ACT (MANITOBA)

- D25.1 Further to C6.26, the Support Contractor under City of Winnipeg Bid Opportunity 507-2021 shall be the Prime Contractor and shall serve as, and have the duties of the Prime Contractor in accordance with The Workplace Safety and Health Act (Manitoba) Qualifications.
- D25.2 Further to B13.4, the Contractor/Subcontractor must, throughout the term of the Contract, have a Workplace Safety and Health Program meeting the requirements of The Workplace Safety and Health Act (Manitoba). At any time during the term of the Contract, the City may, at its sole discretion and acting reasonably, require updated proof of compliance, as set out in B13.4.

MEASUREMENT AND PAYMENT

D26. PAYMENT

D26.1 Further to C12, the City shall make payments to the Contractor by direct deposit to the Contractor's banking institution, and by no other means. Payments will not be made until the Contractor has made satisfactory direct deposit arrangements with the City. Direct deposit application forms are at https://winnipeg.ca/finance/files/Direct_Deposit_Form.pdf.

WARRANTY

D27. WARRANTY

D27.1 Notwithstanding C13, Warranty does not apply to this contract.

DISPUTE RESOLUTION

D28. DISPUTE RESOLUTION

- D28.1 If the Contractor disagrees with any opinion, determination, or decision of the Contract Administrator, the Contractor shall act in accordance with the Contract Administrator's opinion, determination, or decision unless and until same is modified by the process followed by the parties pursuant to D27.
- D28.2 The entire text of C21.4 is deleted, and amended to read: "Intentionally Deleted"
- D28.3 The entire text of C21.5 is deleted, and amended to read:
 - (a) If Legal Services has determined that the Disputed Matter may proceed in the Appeal Process, the Contractor must, within ten (10) Business Days of the date of the Legal Services Response Letter, submit his written Appeal Form, in the manner and format set out on the City's Materials Management Website, to the Chief Administrative Officer, and to the Contract Administrator. The Contractor may not raise any other disputes other than the Disputed Matter in his Appeal Form.
- D28.4 Further to C21, prior to the Contract Administrator's issuance of a Final Determination, the following informal dispute resolution process shall be followed where the Contractor disagrees with any opinion, determination, or decision of the Contract Administrator ("Dispute"):
 - (a) In the event of a Dispute, attempts shall be made by the Contract Administrator and the Contractor's equivalent representative to resolve Disputes within the normal course of project dealings between the Contract Administrator and the Contractor's equivalent representative.
 - (b) Disputes which in the reasonable opinion of the Contract Administrator or the Contractor's equivalent representative cannot be resolved within the normal course of project dealings as described above shall be referred to a without prejudice escalating negotiation process consisting of, at a minimum, the position levels as shown below and the equivalent Contractor representative levels:
 - (i) The Contract Administrator;
 - (ii) Supervisory level between the Contract Administrator and applicable Department Head;
 - (iii) Department Head.
- D28.4.1 Names and positions of Contractor representatives equivalent to the above City position levels shall be determined by the Contractor and communicated to the City at the precommencement or kick off meeting.
- D28.4.2 As these negotiations are not an adjudicative hearing, neither party may have legal counsel present during the negotiations.
- D28.4.3 Both the City and the Contractor agree to make all reasonable efforts to conduct the above escalating negotiation process within twenty (20) Business Days, unless both parties agree, in writing, to extend that period of time.
- D28.4.1 If the Dispute is not resolved to the City and Contractor's mutual satisfaction after discussions have occurred at the final escalated level as described above, or the time period set out in D27.4.3, as extended if applicable, has elapsed, the Contract Administrator will issue a Final Determination as defined in C1.1(v), at which point the parties will be governed by the Dispute Resolution process set out in C21.

THIRD PARTY AGREEMENTS

D29. FUNDING AND/OR CONTRIBUTION AGREEMENT OBLIGATIONS

- D29.1 In the event that funding for the Work of the Contract is provided to the City of Winnipeg by the Government of Manitoba and/or the Government of Canada, the following terms and conditions shall apply, as required by the applicable funding agreements.
- D29.2 Further to D28.1, in the event that the obligations in D28 apply, actual costs legitimately incurred by the Contractor as a direct result of these obligations ("Funding Costs") shall be determined by the actual cost to the Contractor and not by the valuation method(s) outlined in C7.4. In all other respects Funding Costs will be processed in accordance with Changes in Work under C7.
- D29.3 For the purposes of D28:
 - (a) "Government of Canada" includes the authorized officials, auditors, and representatives of the Government of Canada; and
 - (b) "Government of Manitoba" includes the authorized officials, auditors, and representatives of the Government of Manitoba.
- D29.4 Modified Insurance Requirements
- D29.4.1 If not already required under the insurance requirements identified in D12, the Contractor will be required to provide wrap-up liability insurance in an amount of no less than two million dollars (\$2,000,000) inclusive per occurrence. Such policy will be written in the joint names of the City, Contractor, Consultants and all sub-contractors and sub-consultants and include twelve (12) months completed operations. The Government of Manitoba and its Ministers, officers, employees, and agents shall be added as additional insureds.
- D29.4.2 If not already required under the insurance requirements identified in D12, the Contractor will be required to provide builders' risk insurance (including boiler and machinery insurance, as applicable) providing all risks coverage at full replacement cost, or such lower level of insurance that the City may identify on a case-by-case basis, such as an installation floater.
- D29.4.3 The Contractor shall obtain and maintain third party liability insurance with minimum coverage of two million dollars (\$2,000,000.00) per occurrence on all licensed vehicles operated at the Site. In the event that this requirement conflicts with another licensed vehicle insurance requirement in this Contract, then the requirement that provides the higher level of insurance shall apply.
- D29.4.4 Further to D12.3, insurers shall provide satisfactory Certificates of Insurance to the Government of Manitoba prior to commencement of Work as written evidence of the insurance required. The Certificates of Insurance must provide for a minimum of thirty (30) days' prior written notice to the Government of Manitoba in case of insurance cancellation.
- D29.4.5 All policies must be taken out with insurers licensed to carry on business in the Province of Manitoba.
- D29.5 Indemnification By Contractor
- D29.5.1 In addition to the indemnity obligations outlined in C17 of the General Conditions for Construction, the Contractor agrees to indemnify and save harmless the Government of Canada and the Government of Manitoba and each of their respective Ministers, officers, servants, employees, and agents from and against all claims and demands, losses, costs, damages, actions, suit or other proceedings brought or pursued in any manner in respect of any matter caused by the Contractor or arising from this Contract or the Work, or from the goods or services provided or required to be provided by the Contractor, except those resulting from the negligence of any of the Government of Canada's or the Government of Manitoba's Ministers, officers, servants, employees, or agents, as the case may be.

- D29.5.2 The Contractor agrees that in no event will Canada or Manitoba, their respective officers, servants, employees or agents be held liable for any damages in contract, tort (including negligence) or otherwise, for:

 - (b) any damage to or loss or destruction of property of any person; or
 - (c) any obligation of any person, including, but not limited to, any obligation arising from a loan, capital lease or other long term obligation;

D29.6 Records Retention and Audits

- D29.6.1 The Contractor shall maintain and preserve accurate and complete records in respect of this Contract and the Work, including all accounting records, financial documents, copies of contracts with other parties and other records relating to this Contract and the Work during the term of the Contract and for at least six (6) years after Total Performance. Those records bearing original signatures or professional seals or stamps must be preserved in paper form; other records may be retained in electronic form.
- D29.6.2 In addition to the record keeping and inspection obligations outlined in C6 of the General Conditions for Construction, the Contractor shall keep available for inspection and audit at all reasonable times while this Contract is in effect and until at least six (6) years after Total Performance, all records, documents, and contracts referred to in D28.6.1 for inspection, copying and audit by the City of Winnipeg, the Government of Manitoba and/or the Government of Canada and their respective representatives and auditors, and to produce them on demand; to provide reasonable facilities for such inspections, copying and audits, to provide copies of and extracts from such records, documents, or contracts upon request by the City of Winnipeg, the Government of Manitoba, and/or the Government of Canada and their respective representatives and auditors, and to promptly provide such other information and explanations as may be reasonably requested by the City of Winnipeg, the Government of Manitoba, and/or the Government of Canada from time-to-time.

D29.7 Other Obligations

- D29.7.1 The Contractor consents to the City providing a copy of the Contract Documents to the Government of Manitoba and/or the Government of Canada upon request from either entity.
- D29.7.2 If the Lobbyists Registration Act (Manitoba) applies to the Contractor, the Contractor represents and warrants that it has filed a return and is registered and in full compliance with the obligations of that Act, and covenants that it will continue to comply for the duration of this Contract.
- D29.7.3 The Contractor shall comply with all applicable legislation and standards, whether federal, provincial, or municipal, including (without limitation) labour, environmental, and human rights laws, in the course of providing the Work.
- D29.7.4 The Contractor shall properly account for the Work provided under this Contract and payment received in this respect, prepared in accordance with generally accepted accounting principles in effect in Canada, including those principles and standards approved or recommended from time-to-time by the Chartered Professional Accountants of Canada or the Public Sector Accounting Board, as applicable, applied on a consistent basis.
- D29.7.5 The Contractor represents and warrants that no current or former public servant or public office holder, to whom the Value and Ethics Code for the Public Sector, the Policy on Conflict of Interest and Post Employment, or the Conflict of Interest Act applies, shall derive direct benefit from this Contract, including any employment, payments, or gifts,

unless the provision or receipt of such benefits is in compliance with such codes and the legislation.

D29.7.6 The Contractor represents and warrants that no member of the House of Commons or of the Senate of Canada or of the Legislative Assembly of Manitoba is a shareholder, director or officer of the Contractor or of a Subcontractor, and that no such member is entitled to any benefits arising from this Contract or from a contract with the Contractor or a Subcontractor concerning the Work.

E2. MOBILIZATION AND DEMOBILIZATION PAYMENT

- E2.1 Description
 - (a) This Specification shall govern mobilization and demobilization from site.
- E2.2 Mobilization and Demobilization will be required for each inspection type unless multiple inspection types can be performed by the same crew during the same mobilization. Mobilization and Demobilization will include, but is not limited to, the following:
 - (a) Mobilization to the site;
 - (b) Provision of tools, personnel, and support equipment for site setup, restoration, and cleanup; and
 - (c) Demobilization from the site.
- E2.3 The City reserves the right to cease inspections at any time due to operational issues, other priorities, emergencies, or safety concerns. Work satisfactorily completed prior to the stoppage will be paid to the Contractor at the specified unit prices.
- E2.4 Measurement and Payment
 - (a) Mobilization and Demobilization will be measured on a unit basis and paid for at the Contract Unit Price for "Mobilization/Demobilization". Number of units to be paid for will be the total number of Mobilization/Demobilization items performed for each inspection type, measured and accepted by the Contract Administrator.
 - (b) 50% of each Mobilization and Demobilization unit price will be paid when inspection crews arrive on site and are ready to commence the inspection.

(c) 100% of each Mobilization and Demobilization unit price will be paid subsequent to completion of each inspection.

E3. SERVICES

- E3.1 The Contractor shall perform non-destructive inspections of critical wastewaterpipelines in accordance with the requirements hereinafter specified.
 - (a) Inspection Planning shall be in accordance with E4.
 - (b) Mobilization/Demobilization shall be in accordance with E2
 - (c) Field Inspection Services. Exterior Electromagnetic Inspections of steel force mains shall be in accordance with E5
 - (d) Interior Electromagnetic Inspections of steel force mains shall be in accordance with E5.
 - (e) Engineering Report shall be in accordance with E5.3(d).
 - (f) Standby Time shall be in accordance with E6.

E4. INSPECTION PLANNING

- E4.1 Inspection planning will include, but is not limited to, the following tasks: preliminary site investigations, historic drawing reviews, planning document preparation, safety plan preparation, inspection-plan document, and meeting attendance with the Contract Administrator.
 - (a) Provide inspection planning services and develop inspection deployment plan
 - (b) Attend one (1) planning and site review meeting in Winnipeg. Assume one full day of a minimum 8 hours to investigate Sites, and attend planning meeting with the City of Winnipeg, Support Contractor and Contract Administrator in attendance. A minimum of one (1) representative of the inspection firm with authority to represent the company in planning discussions shall attend.
 - (c) Review record drawings and construction drawings for sites as provided in the Appendix A
 - (d) Review proposed pipeline modification plans as provided in Appendix B. Identify to the Contract Administrator any concerns with proposed pipeline access modifications that could impact inspection tool deployment.
 - (e) Prepare and submit an inspection plan for each site to the Contract Administrator a minimum of ten (10) Business Days prior to schedule commencement of inspection activities.

E4.2 Measurement and Payment

(a) Inspection Planning will be measured on a lump sum basis. Inspection Planning shall include attending one (1) site investigation and planning session in Winnipeg, review of all provided Records, drawings and specifications, preparation of detailed inspection plan, preparation of project safety plan, review of Support Contractor plans and procedures, and shall be payment in full for works identifies in this Specification.

E5. ELECTROMAGNETIC INSPECTIONS OF STEEL PIPELINES

E5.1 Description

(a) This specification describes minimum technical requirements for provision of Inspection Services, reporting and analysis for ferric metal pipelines.

 - Threshold of Detection (ToD) local wall loss (LWL) on the internal pipe surface to be a 9.5 mm diameter flat bottom hole with a depth equal to 20% of wall thickness.
 - ♦ ToD for LWL on the exterior surface to be a 6.35 mm diameter flat bottom hole with a depth equal to 20% of the wall thickness.
 - ToD for general wall Loss from the inner and outer surfaces is 15% of wall thickness.
- (c) Field Inspection Services
 - (i) An Inspection Support contract (Tender 507-2021) has been issued to provide support services to facilitate inspection under this contract. This includes:

 - ◆ Pipeline Cleaning as outlined in E9.4(d);

- ♦ Inspection Support Services as outlined in E12
- (ii) For Internal EM inspections Inspection Contractor shall provide all tools, personnel and equipment required to complete inspection activities including but not limited to:
 - Provision of electromagnetic inspection platform(s).
 - Provision of means of propulsion of inspection including winches, tow pigs, cables and other equipment required to deploy inspection equipment and obtain inspection data. Winch lines for cleaning shall not cause damage to pipelines or pipeline coatings. Provide synthetic winch line such as Amsteel or cable coated with sacrificial synthetic coating.
 - Provision of gauge pigs and plates as required to ensure that adequate cleaning has been completed and defects or anomalies that may be present in the pipe can be navigated by the inspection tool. Gauge pigs are to be pulled through the line by the Support Contractor as part of the cleaning process. Gauge pigs shall be provided to the Support Contractor a minimum of ten (10) Business Days prior to the agreed upon inspection date unless otherwise agreed to by the Contract Administrator and the Support Contractor.
 - Deploy and retrieve inspection tools, download and obtain inspection data. Provide all labour, tools and equipment to launch and retrieve inspection tools. Support Contractor will provide lifting equipment to aide Inspection Contractor in deploying tools.
 - Complete preliminary review of data to ensure data integrity is acceptable for further analysis. Data review shall be completed within 12 hours of completion of field data collection. Advise Contract Administrator immediately of data integrity concerns.
 - In the event that inspection re-run is required due to data integrity, equipment failure or technical errors, cost of re-running inspection shall be borne by Inspection Contractor.
- (iii) For External EM inspections Inspection Contractor shall provide all tools, personnel and equipment required to complete inspection activities including but not limited to:
 - Provision of electromagnetic inspection platform(s).
 - ◆ Light cleaning to remove debris from pipe
 - ◆ Deploy inspection tools, download and obtain inspection data. Provide all labour, tools and equipment to deploy and retrieve inspection tools. Support Contractor will provide lifting equipment to aide Inspection Contractor in deploying tools
 - Complete preliminary review of data to ensure data integrity is acceptable for further analysis. Data review shall be completed within 12 hours of completion of field data collection. Advise Contract Administrator immediately of data integrity concerns.
 - In the event that inspection re-run is required due to data integrity, equipment failure or technical errors, cost of re-running inspection shall be borne by Inspection Contractor.
 - Provide spot ultrasonic thickness (UT) measurements of each inspection location at a minimum of 100 mm spacing around circumference of the pipe.
 - Where external corrosion is present, clean corrosion and provide pit depth measurements.
 - Provide photographic Record of inspections.
- (iv) The Contractor shall perform all work in such a manner to minimize the chance that equipment used for modifications, cleaning, and inspection, will become stuck in the pipe. Should equipment become stuck that cannot be retrieved by the Contractor, the City will handle the retrieval efforts by any means necessary to restore proper functionality of the pipe. The City will not pay for any resulting tool damage or loss during the equipment retrieval efforts, or claims for loss of use or lost revenue as a result of equipment being lodged in pipe.
- (v) For Site 2, The Inspection Contractor will be permitted to utilize Underbridge Crane (UBC) in accordance with E8.2(b)(x).
- (d) Reporting and Analysis
 - (i) Reporting of inspection shall at a minimum include:

- Overview of inspection including procedures utilized, dates, times and other general notes, inspection concerns or noteworthy items, length of inspected pipe, and field measured pipe data.
- ♦ Inspected results including location, size and depth of defects.
- Analysis of inspected length as recorded by on board odometer devices vs measures survey distance. Report corrected axial location and measured axial location.
- Analysis of average and local wall loss per unit length of pipe.
- ♦ Analysis of location of defects circumferentially around the pipe.
- Findings in tabular and graphical form.
- Actual defect calibration data if available, or provide assumed calibration data.
- (ii) Draft data report shall be submitted to the Contract Administrator for review within sixty (60) Calendar Days of completion of inspection.
- (iii) Contract Administrator and City will review and provide comments on Draft report within thirty (30) Calendar Days of submittal.
- (iv) Final data report shall be submitted within thirty (30) Calendar Days of receipt of comments from the Contract Administrator.

E5.4 Measurement and Payment

- (a) Measurement and Payment shall be made as follows;
 - (i) Field Inspection Services for Site 1, 2 and 3 will be measured on a lump sum basis per site, plus a per unit price per location for inspection length of up to 3 metres per location, successfully completed and reported, and shall be compensation in full for the work and items identified in this specification, and identified on Form B:Prices.
 - (ii) Field Inspection Services for Site 5 will be measured on a lump sum basis per site, plus a per metre unit inspection length successfully completed and reported, and shall be compensation in full for the work and items identified in this specification, and identified on Form B:Prices.
 - (iii) Analysis and Reporting will be measured on a lump sum basis per site as identified on Form B: Prices. The payment will be made as 75% upon submittal of a draft report and 25% upon submittal and acceptance of the final report incorporating comments provided by the Contract Administrator.

E6. STANDBY TIME

- E6.1 Where site conditions are deemed favourable for work and the Contractor has mobilized to the site and is ready to perform the inspections, payment of Standby Time may be made where pipe access has not been made available to the Contractor by the City or their representative(s) causing delays in work.
- E6.2 Site standby rates will be measured on a daily basis as identified on Form B: Prices for each full day of delay in inspection that in the opinion of the Contract Administrator is outside of the control of the Contractor. Partial days and weather related delays will not be considered for payment. Payment for standby rates will include all costs associated with delays as defined herein.

E7. PIPELINE MODIFICATIONS FOR INSPECTION ACCESS

E7.1 Description

- (a) This Specification describes modification of valve chambers, and force mains, as required for cleaning and inspection the river crossing pipelines.
- (b) These modifications and services will be provided by the Support Contractor, and are included for information only.

E7.2 Description of Work

E7.2.1 Piping Modifications:

- (a) Drawings in Appendix B are provided for information purposes to the Inspection Contractor for planning inspection activities.
- (b) Site 1 Old Forts Bridge Force Mains
 - (i) Strip existing cladding and insulation at locations specified on the Drawings, to enable external Electromagnetic inspection.
 - (ii) Repair pipe cladding and make good.
- (c) Site 2
 - (i) Strip existing cladding and insulation at locations specified on the Drawings, to enable external Electromagnetic inspection.
 - (ii) Repair pipe cladding and make good.
- (d) Site 3
 - (i) Strip existing cladding and insulation at locations specified on the Drawings, to enable external Electromagnetic inspection.
 - (ii) Repair pipe cladding and make good.
- (e) Site 5:
 - (i) Install and operate flow bypass piping to isolate crossing pipe.
 - (ii) Install new manhole, gate valve, launch wye assembly, and tapping sleeve on south alignment.
 - (iii) Install new manhole and launch wye assembly on north alignment.
 - (iv) Clean pipeline crossing under river using cleaning pigs, jet flushers, and other equipment as required.
 - (v) Maintain access to pipeline to facilitate inspection.
 - (vi) Restore pipeline.

E8. RIVER CROSSING SITE ACCESS

E8.1 Description

(a) Site Access will be developed by the Support Contractor. Inspection Contractor shall coordinate use of Site Access. The following is provided for information only.

E8.2 Site Access Provisions and Constraints

- (a) Site 1 Old Forts Bridge Force Mains
 - Pipeline is installed below the bridge and accessible inside the bridge abutments and box girders.
 - (ii) Access to pipeline is via existing maintenance hatches located on the northbound lanes sidewalk.
 - (iii) Light-duty trucks may utilize the northbound sidewalk as required to facilitate the work.
 - (iv) Construction trailers and all vehicles not required to complete the work shall be parked on adjacent residential streets.
 - (v) Maintain access to all private approaches.
 - (vi) Support Contractor shall be responsible for providing and maintaining all necessary traffic and pedestrian control.
 - (vii) Support Contractor shall be responsible for providing and maintaining all necessary Confined Space Entry support.
- (b) Site 2 Provencher Bridge Force Mains (Provencher Boulevard / Provencher Bridge from Tache Avenue to Israel Asper Way.
 - (i) Pipeline is suspended below the bridge, external to the existing girders.

 - (ii) Access to abutment chambers on both sides of the river is via access doors located underneath the bridge structure.
 - (iii) Access to the west abutment chamber door is from Provencher Boulevard.
 - (iv) Access to east abutment chamber door is from Tache Avenue.
 - (v) Light duty trucks may utilize multi-use pathways as required to facilitate the work.
 - (vi) Construction trailers and all vehicles not required to complete work shall be parked on adjacent residential streets.
 - (vii) Maintain access to all private approaches.
 - (viii) Support Contractor shall be responsible for providing and maintaining all necessary traffic control.
 - (ix) Support Contractor shall be responsible for providing and maintaining all necessary Confined Space Entry support.
 - (x) Under Bridge Crane
 - (i) For work located at the midspan of the bridge, the City will provide an Under Bridge Crane (UBC) for use by the Support Contractor and Inspection Contractor in the preparation, inspection, and repair of the Provencher Bridge Force Main.
 - (ii) The Support Contractor shall provide notice to the Contract Administrator a minimum of twenty (20) Business Days prior to the scheduled use of the UBC.
 - (iii) The Support Contractor shall provide a detailed schedule for the UBC operations a minimum of five (5) Business Days prior to the scheduled use of the UBC.
 - (iv) All parties shall review and undertake orientation and training detailed in Appendix D, and provide evidence of appropriate training from third party sources.
 - (v) All parties shall provide required PPE including body harness and lanyard.
 - (vi) Only one (1) person other than the City of Winnipeg operator will be permitted in the UBC at any time
 - (vii) City of Winnipeg UBC crew will be fully in charge of operation of UBC. Contractor shall abide by any instruction provided by UBC crew.
 - (viii) The use of the UBC for this work is estimated below. In all cases the Contractor shall minimize use of the equipment and coordinate with the Inspection Contractor to complete the Work as expeditiously as possible;
 - One(1) day for preparation work (by others);
 - ♦ One (1) day for inspection;
 - One (1) day for restoration (by others).
 - (c) Site 3 Norwood Bridge Force Main (Queen Elizabeth Way / Norwood Bridge from Stradbrook Avenue to Lyndale Drive).
 - (i) Pipeline is installed below the bridge and accessible inside the bridge abutments and box girders.
 - (ii) Access to bridge abutments and girders along the bridge is through hatches located on the northbound sidewalk.
 - (iii) Light duty trucks may utilize the northbound sidewalk as required to facilitate the work.
 - (iv) Construction trailers and all vehicles not required to complete work shall be parked on adjacent residential streets.
 - (v) Maintain access to all private approaches.
 - (vi) Contractor shall be responsible for providing and maintaining all necessary traffic control in accordance with E10 and the City of Winnipeg Manual of Temporary Traffic Control.
 - (vii) Support Contractor shall be responsible for providing and maintaining all necessary Confined Space Entry support.

- (d) Site 5 West Perimeter Force Main (Perimeter Highway at the Assiniboine River).
 - (i) Access to lift station and north side of crossing is via Oxbow Bend Road.
 - (ii) Access to the south side of crossing is via northbound Perimeter Highway Manitoba Infrastructure Right-of-Way.
 - (iii) The Support Contractor shall develop site access and work areas as required to complete the work. The Support Contractor shall limit activity to a single access point and the space required to complete the pipeline inspection.
 - (iv) The Support Contractor shall be responsible for providing and maintaining all necessary traffic control in accordance with E10 and the City of Winnipeg Manual of Temporary Traffic Control.
- (e) The Inspection Contractor shall exercise caution to prevent damage to existing pavements, curbs, sidewalks, grassed areas, and trees. Surface restoration outside of the designated construction areas shall be the responsibility of the Inspection Contractor.
- (f) Where site access utilizes grassed right-of-ways, limit access for trucks and equipment to a single pathway directly from street to work area as developed and maintained by the Support Contractor. Protect grassed areas with planking or other measures to minimize rutting and damage.
- (g) Laydown and storage areas shall be staged away from areas prone to damage.
- (h) The Inspection Contractor shall maintain access to all businesses during business hours, except where written authorization has been provided by the business.
- (i) The Inspection Contractor shall not park company or private vehicles inside a barricaded work zone in a matter that will block sightlines for vehicles and pedestrians approaching and crossing intersections.
- (j) The Support Contractor is responsible for maintaining safe vehicular traffic through their work site. The Support Contractor shall rectify any unsafe conditions immediately upon notification. This could include but is not limited to providing flag persons, clearing debris and snow from sites, moving equipment, and erecting additional signage.

E9. CONFINED ENTRY SUPPORT

E9.1 Description

- (a) This specification covers provision of confined entry and access support for specialized Inspection Contractors and inspection personnel.
- (b) Confined Entry Support will be provided by the Support Contractor under Tender 507-2021. Support Contractor is Prime Contractor with respect to Manitoba Workplace Safety and Health Act. Inspection Contractor shall abide by Manitoba Workplace health and Safety Act, regulations and safety requirements of the Prime Contractor. Prime Contractor will provide Site Specific Safety Plans to the Inspection Contractor.
- (c) Notwithstanding E9.1(b), Inspection Contractor is required to prepare their own Site Specific Safety Plan in accordance with Manitoba Acts and Regulations.
- (d) The Contractor's attention is drawn to the Province of Manitoba Workplace Safety and Health Act ('the Act"), and the Regulations and Guidelines there-under pertaining to Confined Space Entry Work and in particular the requirements for conducting hazard/risk assessments and providing personal protective equipment (PPE).

E9.2 Scope of Services

- (a) Inspection Contractors, consultants and City personnel may require dedicated confined entry support services during pipeline inspection of pipeline river crossings. Confined Entry Support will be provided by the Support Contractor. The following sites will require confined entry access on one or both sides of the river crossing for installation and retrieval of in-line inspection tools. For purpose of provision of services, allow for 2 entrants per side and additional support as required for standby and rescue.
 - (i) Site 1: Bridge of the Old Forts Force Main

- (ii) Site 3: Norwood Force Main
- (iii) Site 5 Perimeter West Force Main

E9.3 Equipment

- (a) Support Contractor will provide Safety Retrieval winch and tripod
 - Support Contractor will provide sufficient retrieval winches to support inspection crews on each side of the crossing. A maximum of two entrants is assumed per side.
 - (ii) Support Contractor will provide two body harnesses per entry location, plus additional harnesses for backup and rescue. Inspection Contractor is encouraged to provide own body harnesses.

(b) Air Quality Monitors

(i) Support Contractor will provide a minimum of two multi-gas air quality monitors for each crossing access location. Each monitor shall provide continuous exposure monitoring for oxygen, carbon monoxide, hydrogen sulphide and combustible gases.

E9.4 Methods

- (a) Be fully responsible for confined entry access on site, in accordance to Manitoba Workplace Health and Safety Regulation 217/2006 and subsequent amendments.
- (b) Support services will be required to support one pipeline crossing (one inspection crew) at a time. Each crossing will require support on each side of the river.
- (c) Support Contractor Safety Personnel will be dedicated to confined entry access when inspection personnel are in confirmed areas.
- (d) Support Contractor will maintain confined entry permit logs.

E10. UNDER BRIDGE ACCESS SUPPORT

E10.1 Description

(a) This specification covers provision of pipeline access for utilities suspended under bridges.

E10.2 Scope of Services

- (a) The City of Winnipeg has committed for use of an under bridge crane (UBC) to facilitate access for inspections at the Provencher Bridge Site (Site 2). Access to the site will be limited to one (1) person plus the City of Winnipeg UBC operator.
- (b) Use of the UBC to complete the necessary inspection is limited to one (1) Working Day between the hours of 9:00 a.m. and 3:30 p.m.
- (c) Support Contractor will have access to use of the UBC to prepare the site for inspection, removal of cladding from the main, cleaning the pipe, and restoration of cladding after inspection. The Support Contractor will have access to the UBC one (1) day before and one (1) day after inspection to facilitate work. Use of UBC is limited as per E10.2(b).
- (d) Contractor shall attend orientation with City UBC operator prior to use of crane. Contractor shall provide their own full body harness complete with shock absorbing lanyard. Contractor shall in every way follow instructions of City UBC operator.

E11. PIPELINE CLEANING

E11.1 Description

- (a) This Specification shall cover the supply of foam pipeline cleaning pigs and the cleaning of the pipelines to be inspected.
- (b) Pipeline cleaning services will be provided by Support Contractor. The following is provided for information only.

 - (c) The following pipelines require cleaning prior to inspection:
 - (i) Site 5: Perimeter West Force Main

E11.2 Submittals

E11.2.1 Cleaning Plan

- (a) The Support Contractor will submit in writing a detailed cleaning plan for each pipeline crossing for review by the Contract Administrator. The cleaning plan at a minimum shall include the following:
 - (i) Method(s) of cleaning
 - (ii) Sizes and densities of foam pigs to be used
 - (iii) Means of debris collection and disposal
- (b) The pipeline cleaning plan will be provided to the Inspection Contractor for review.
- (c) No cleaning operations shall be undertaken prior to review of the cleaning plan by the Contract Administrator.

E11.3 Products

E11.3.1 Winch Line

- (a) Winch lines for cleaning shall not cause damage to pipelines or pipeline coatings. Provide synthetic winch line such as Amsteel, cable coated with sacrificial synthetic coating, or braided flusher hose.
- (b) Tether lines used for installing winch lines shall be a minimum of 9 mm synthetic rope.

E11.3.2 Foam Tow Pigs

- (a) If used, the Support Contractor shall provide tow pigs for their use.
- (b) Material: One piece moulded open-cell polyurethane
- (c) Pigs shall be new and packaged for shipping and storage to prevent contamination.
- (d) Pigs shall be supplied complete with a factory installed pulling cable.
- (e) For towed pigs, pigs shall be supplied complete with a steel support disc on both ends suitable for towing pigs. The steel disk shall have a minimum diameter of 100 mm.
- E11.3.3 Gauge Pigs shall be supplied by the Inspection Contractor and shall include instructions for deployment of gauge pig. Inspection Contractor shall examine gauge pig and determine if appropriate level of cleaning has been achieved to support inspection.
- E11.3.4 Water for pig launching may be obtained from fire hydrants in accordance with CW 1120.
- E11.4 Internal pipeline diameters based on the best available record information. The Contractor is responsible to confirm the inner pipe diameters prior to undertaking cleaning work:

E11.5 Methods

E11.5.1 Pigging

- (a) Where applicable, Support Contractor shall provide pig launch tubes, pipe and fittings, including valves.
- (b) Winch lines shall be inserted into the pipelines for cleaning purposes. Winch lines may be inserted by high pressure flusher nozzle, flow drone or other approved method.
- (c) Cleaning is to be completed sufficiently to accommodate in-line inspection tools, typically 25 millimetres smaller than pipe inside diameter.

 - (d) Minimum cleaning requirements per pipeline crossing:
 - (i) Pull one 25 mm undersized medium density foam cleaning pig (prove bore prior to pulling the gauge pig).
 - (ii) Pull one full sized low density foam cleaning pig (debris removal).
 - (e) The use of foam cleaning pigs shall not introduce air into pipeline river crossings below river levels. Many pipelines are weighted bottom installations, or shallow cover, and susceptible to floatation. Pipelines shall be kept full behind pigs.
 - (f) Foam cleaning pigs shall be tethered on each end and be capable of being winched in either direction.
 - (g) A gauge pig will be pulled through the pipe during the cleaning operation to determine the effectiveness of the cleaning operation. Gauge pig shall be tethered on each end and be capable of being winched in either direction.
 - (h) Cleaning operations will continue until the Inspection Contractor and Contract Administrator are satisfied that the pipe is passable by the inspection tools. This shall be proved by passing of the supplied gauge pig through the line.
 - (i) Upon completion of cleaning, a tag line will be left in the pipeline and securely fastened, for future use by the Inspection Contractor.
 - (j) The Support Contractor will be prepared to remove hard debris from the pipe during cleaning process to the extent required to pass the supplied gauge pig.
 - (k) It is anticipated that pipeline cleaning will take a maximum of one day per pipeline.

E11.6 Provisional Flushing and Hydrovac Services

(a) Where requested by the Contract Administrator, the Support Contractor will provide provisional flushing and hydrovactor services to assist in inspection operations.

E12. INSPECTION SUPPORT SERVICES

E12.1 Support Services Requirements

E12.1.1 General

- (a) Support services will be provided by Support Contractor as described below.
- (b) Coordinate work hours with pipeline Support Contractor. Support Contractor and pipeline Inspection Contractor shall agree on time for commencement of work by the pipeline Support Contractor. The Support Contractor will be permitted reasonable time for preparation of activities prior to arrival of pipeline Inspection Contractor. Excessive site support time in advance of agreed site hours will not be measured for payment.
- (c) Pipeline inspections typically will require one day of onsite support per pipeline. It is intended that onsite support services will run on consecutive days. More than one site may be commenced on any day. No more than one inspection will occur at a time.
- (d) The pipeline Inspection Contractor may require time to configure their tooling prior to pipeline inspections. Scheduling of the inspections will be made after award of the contract.
- (e) Support Contractor will provide support labour to assist the pipeline Inspection Contractor's crews with handling of equipment, setup, and access.
- (f) Support Contractor will provide minimum of two support persons, including small hand and power tools to assist the pipeline Inspection Contractor's crew, including:
 - (i) Portable hammer drills for setting anchor bolts in concrete (minimum 12 mm drive chuck)
 - (ii) Shovels
 - (iii) Hand tools
 - (iv) Light duty transportation truck(s)
 - (v) Portable ladders (two per crossing)

- (vi) Gas powered air compressor with 5 gallon tank (minimum) and capable of supplying 8 cfm at 90 psi.
- (vii) Disinfection solution and equipment for the purposes of spray and swap disinfection of pipeline Inspection Contractor's equipment, including but not limited to: inspection tools, launch equipment, winch lines, and any other equipment entering the pipeline.
- (g) Support Contractor personnel will assist the pipeline Inspection Contractor's crews with access, removal of gratings, covers, installation of concrete anchors, where required, installation of flow diversion equipment, and any other general assistance to crews for completion of inspections.
- (h) The Support Contractor will provide a heated space at each site for storage and setup of the inspection tools when atmospheric temperatures are below 5°C. The space shall be a minimum of 5 x 2.5 m.
- (i) Lifting Equipment

(i) Support Contractor will provide mobile lifting equipment, boom truck, loader or other equipment capable of lifting, moving and lowering inspection equipment into pipelines in accordance to the following:

(j) The Support Contractor is fully responsible for confined entry access on site, in accordance with Manitoba Workplace Safety and Health Regulation 217/2006 and subsequent amendments. The Support Contractor shall provide confined entry support for the pipeline Inspection Contractor's crews, and AECOM personnel as needed, in accordance with E9, where required to facilitate pipeline inspections.

E12.1.2 Lighting

- (a) Where required for night work, Support Contractor will provide adequate lighting.
- (b) For internal bridge girder inspections, Support Contractor shall provide adequate task lighting.

E12.1.3 Shop Space

- (a) The Support Contractor shall provide wash facilities and a heated shop space for the pipeline Inspection Contractor for configuration and storage of inspection tools.
 - A wash bay for cleaning the inspection tool for transport complete with a pressure washer capable of supplying 7 LPM at 10,300 kPa.
- (b) The Support Contractor shall provide a work shop to facilitate maintenance and conversion of inspection tools by the pipeline Inspection Contractor. The work shop shall meet the following minimum requirements:
 - (i) Floor space 80 m².
 - (ii) Overhead door adequate for unloading of inspection tools and equipment with forklift or wheel loader. Minimum dimensions - 3.66 m x 3.66 m.
 - (iii) The shop must be heated.
 - (iv) Lifting hoist or forklift availability.
 - (v) Electric air compressor with 20 gallon tank (minimum) and capable of supplying 5 cfm at 90 psi.
 - (vi) Power two (2) 15 amp, 120 volt AC power circuits.
 - (vii) Work tables complete with vice.
- (c) The shop will be accessible to the pipeline Inspection Contractor after hours and during weekends.

E12.1.4 Under Bridge Crane

- (a) If required due to elevated river levels, the City will provide an Under Bridge Crane (UBC) for use by the Support Contractor and Inspection Contractor in the preparation, inspection, and repair of the St. Vital Bridge Force Main.
- (b) The Support Contractor will provide notice a minimum of twenty (20) Business Days prior to the scheduled use of the UBC.
- (c) The Contractor shall review and undertake orientation and training provided in Appendix D, and provide evidence of appropriate training from third party sources.
- (d) Contractor shall provide required PPE including body harness and lanyard.
- (e) Only one (1) person other than the City of Winnipeg operator will be permitted in the UBC at any time.
- (f) City of Winnipeg UBC crew will be fully in charge of operation of UBC. Contractor shall abide by any instruction provided by UBC crew.

E13. PIPE ACCESS

- E13.1 The Contract Administrator will coordinate pipe access for inspection purposes. The City or their representative(s) will provide the following:
 - (a) Access to the pipe via valve chambers, lift stations, manholes, or excavation trenches;
 - (b) All valve operations;
 - (c) Opening of all manholes, hatches, or buildings;
 - (d) Removal of blind flanges or other fittings; and
 - (e) Initial dewatering of chambers and pipes to allow for tool insertion.
- E13.2 Access to the inside of the pipe for tool insertion will be facilitated by the Support Contractor.
- E13.3 Separate payment for access to the inside of the pipe will not be made and will be included in the price for inspections.

E14. INCOMPLETE INSPECTIONS

- E14.1 Re-perform the inspections where the Contract Administrator has determined the requirements of the specification have not been satisfied, or where data is lost or incomplete, as scheduling allows, and at no cost to the City.
- E14.2 Segments of inspections where the requirements of the specification have not been satisfied, or where data is lost or is incomplete, will not be paid for.

PART F - SECURITY CLEARANCE

F1. SECURITY CLEARANCE

- F1.1 Each individual proposed to perform the following portions of the Work:
 - (a) any Work on private property;
 - (b) any Work within City facilities other than:
 - (i) an underground structure such as a manhole, and
 - (ii) in areas and at times normally open to the public.
 - (c) communicating with residents and homeowners in person or by telephone;
- F1.1.1 Each Individual shall be required to obtain a Police Information Check from the police service having jurisdiction at his/her place of residence. Or
 - (a) Sterling BackCheck for existing account holders, log into your account to send individual invitations to employees requiring security clearance. - F1.2 Prior to the award of Contact, and during the term of the Contract if additional or replacement individuals are proposed to perform Work, the Contractor shall supply the Contract Administrator with a Police Information Check obtained not earlier than one (1) year prior to the Submission Deadline, or a certified true copy thereof, for each individual proposed to perform such Work.
- F1.3 Any individual for whom a Police Information Check is not provided, or for whom a Police Information Check indicates any convictions or pending charges related to property offences or crimes against another person will not be permitted to perform any Work specified in F1.1.
- F1.4 Any Police Information Check obtained thereby will be deemed valid for the duration of the Contract subject to a repeated records search as hereinafter specified.
- F1.5 Notwithstanding the foregoing, at any time during the term of the Contract, the City may, at its sole discretion and acting reasonably, require an updated Police Information Check. Any individual who fails to provide a satisfactory Police Information Check as a result of a repeated Police Information Check will not be permitted to continue to perform any Work specified in F1.1.
