### **PART B - BIDDING PROCEDURES**

#### B1. CONTRACT TITLE

B1.1 VALOUR COMMUNITY CENTRE - SPRAY PAD AND PLAYGROUND

#### B2. SUBMISSION DEADLINE

- B2.1 The Submission Deadline is 12:00 noon Winnipeg time, February 27, 2024.
- B2.2 The Contract Administrator or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

#### B3. SITE INVESTIGATION

- B3.1 Further to C3.1, the Proponent may make an appointment to view the Site by contacting the Contract Administrator.
- B3.2 The Proponent may request a viewing of the electrical service in the adjacent buildings (Community Centre and maintenance shed) and the existing water and sewer pits by making arrangements with the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- B3.3 The Proponent shall not be entitled to rely on any information or interpretation received at the Site investigation unless that information or interpretation is the Proponent's direct observation, or is provided by the Contract Administrator in writing.
- B3.4 The Proponent is responsible for inspecting the Site, the nature of the Work to be done and all conditions that might affect their Proposal or their performance of the Work, and shall assume all risk for conditions existing or arising in the course of the Work which have been or could have been determined through such inspection.
- B3.5 The Proponent is responsible for determining:
  - (a) the location of any utility which can be determined from the records or other information available at the offices of any public authority or person, including a municipal corporation and any board or commission thereof, having jurisdiction or control over the utility;
  - (b) the nature of the surface and subsurface conditions at the Site;
  - (c) the location, nature, quality or quantity of the materials to be removed or to be employed in the performance of the Work;
  - (d) the nature, quality or quantity of the Plant needed to perform the Work;
  - (e) all matters concerning access to the Site, power supplies, location of existing services, utilities or materials necessary for the completion of the Work; and
  - (f) all other matters which could in any way affect their Proposal or the performance of the Work.

#### B4. ENQUIRIES

- B4.1 All enquiries shall be directed to the Contract Administrator identified in D4.1.
- B4.2 If the Proponent finds errors, discrepancies or omissions in the proposal, or is unsure of the meaning or intent of any provision therein, the Proponent shall promptly notify the Contract Administrator of the error, discrepancy or omission at least five (5) Business Days prior to the Submission Deadline.
- B4.3 Responses to enquiries which, in the sole judgment of the Contract Administrator, require a correction to or a clarification of the Request for Proposal will be provided by the Contract Administrator to all Proponents by issuing an addendum.
- B4.4 Responses to enquiries which, in the sole judgment of the Contract Administrator, do not require a correction to or a clarification of the Request for Proposal will be provided by the Contract Administrator only to the Proponent who made the enquiry.

- B4.5 All correspondence or contact by Proponents with the City in respect of this RFP must be directly and only with the Contract Administrator. Failure to restrict correspondence and contact to the Contract Administrator may result in the rejection of the Proponents Proposal Submission.
- B4.6 The Proponent shall not be entitled to rely on any response or interpretation received pursuant to B4 unless that response or interpretation is provided by the Contract Administrator in writing.

#### B5. CONFIDENTIALITY

- B5.1 Information provided to a Proponent by the City or acquired by a Proponent by way of further enquiries or through investigation is confidential. Such information shall not be used or disclosed in any way without the prior written authorization of the Contract Administrator. The use and disclosure of the confidential information shall not apply to information which:
  - (a) was known to the Proponent before receipt hereof; or
  - (b) becomes publicly known other than through the Proponent; or
  - (c) is disclosed pursuant to the requirements of a governmental authority or judicial order.
- B5.2 The Proponent shall not make any statement of fact or opinion regarding any aspect of the Request for Proposal to the media or any member of the public without the prior written authorization of the Contract Administrator.

#### B6. ADDENDA

- B6.1 The Contract Administrator may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Request for Proposal, or clarifying the meaning or intent of any provision therein.
- B6.2 The Contract Administrator will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B6.3 Addenda will be available on the MERX website at <u>www.merx.com</u>.
- B6.4 The Proponent is responsible for ensuring that they have received all addenda and is advised to check the MERX website for addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.
- B6.5 The Proponent shall acknowledge receipt of each addendum in Paragraph 10 of Form A: Bid/Proposal. Failure to acknowledge receipt of an addendum may render a Proposal non-responsive.
- B6.6 Notwithstanding B4, enquiries related to an Addendum may be directed to the Contract Administrator indicated in D4.

#### B7. SUBSTITUTES

- B7.1 The Work is based on the Plant, Materials and methods specified in the Request for Proposal.
- B7.2 Substitutions shall not be allowed unless application has been made to and prior approval has been granted by the Contract Administrator in writing.
- B7.3 Requests for approval of a substitute will not be considered unless received in writing by the Contract Administrator at least five (5) Business Days prior to the Submission Deadline.
- B7.4 The Proponent shall ensure that any and all requests for approval of a substitute:

- (a) provide sufficient information and details to enable the Contract Administrator to determine the acceptability of the Plant, Material or method as either an approved equal or alternative;
- (b) identify any and all changes required in the applicable Work, and all changes to any other Work, which would become necessary to accommodate the substitute;
- (c) identify any anticipated cost or time savings that may be associated with the substitute;
- (d) certify that, in the case of a request for approval as an approved equal, the substitute will fully perform the functions called for by the general design, be of equal or superior substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance;
- (e) certify that, in the case of a request for approval as an approved alternative, the substitute will adequately perform the functions called for by the general design, be similar in substance to that specified, is suited to the same use and capable of performing the same function as that specified and can be incorporated into the Work, strictly in accordance with the proposed work schedule and the dates specified in the Supplemental Conditions for Substantial Performance and Total Performance.
- B7.5 The Contract Administrator, after assessing the request for approval of a substitute, may in their sole discretion grant approval for the use of a substitute as an "approved equal" or as an "approved alternative", or may refuse to grant approval of the substitute.
- B7.6 The Contract Administrator will provide a response in writing, at least two (2) Business Days prior to the Submission Deadline, to the Proponent who requested approval of the substitute.
- B7.6.1 The Contract Administrator will issue an Addendum, disclosing the approved materials, equipment, methods and products to all potential Proponents. The Proponent requesting and obtaining the approval of a substitute shall be responsible for disseminating information regarding the approval to any person or persons they wish to inform.
- B7.7 If the Contract Administrator approves a substitute as an "approved equal", any Proponent may use the approved equal in place of the specified item.
- B7.8 If the Contract Administrator approves a substitute as an "approved alternative", any Proponent bidding that approved alternative may base their Total Bid Price upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in accordance with B23.
- B7.9 No later claim by the Contractor for an addition to the Total Bid Price because of any other changes in the Work necessitated by the use of an approved equal or an approved alternative will be considered.

#### B8. PROPOSAL SUBMISSION

- B8.1 The Proposal shall consist of the following components:
  - (a) Form A: Bid/Proposal;
  - (b) Form B: Prices;
  - (c) Form C: Economic Analysis.
- B8.2 The Proposal should also consist of the following components:
  - (a) Design Drawings in accordance with B12;
  - (b) Project Workplan, in accordance with B13;
  - (c) Systems Integration, in accordance with B14.
- B8.3 Further to B8.1, all components of the Proposal shall be fully completed or provided in the order indicated, and submitted by the Proponent no later than the Submission Deadline, with all required entries made clearly and completely.

- B8.4 Further to B8.2, all components of the Proposal should be fully completed or provided in the order indicated, and submitted by the Proponent no later than the Submission Deadline, with all required entries made clearly and completely.
- B8.5 Proposal format, including number of pages, size of pages and, font, etc., will not be regulated, except that the Proposal should contain a table of contents, page numbering and should be in the Sections identified above. Proponents are encouraged to use their creativity to submit a Proposal which provides the requested information for evaluation and other information which illustrates the strength of their proposed solution.
- B8.6 The Proposal shall be submitted electronically through MERX at <u>www.merx.com</u>.
- B8.6.1 Proposals will **only** be accepted electronically through MERX.
- B8.7 Proponents are advised that inclusion of terms and conditions inconsistent with the Request for Proposal, will be evaluated in accordance with B23.1(a).
- B8.8 Any cost or expense incurred by the Proponent that is associated with the preparation of the Proposal shall be borne solely by the Proponent.

#### B9. PROPOSAL

- B9.1 The Proponent shall complete Form A: Bid/Proposal, making all required entries.
- B9.2 Paragraph 2 of Form A: Bid/Proposal shall be completed in accordance with the following requirements:
  - (a) if the Proponent is a sole proprietor carrying on business in their own name, their name shall be inserted;
  - (b) if the Proponent is a partnership, the full name of the partnership shall be inserted;
  - (c) if the Proponent is a corporation, the full name of the corporation shall be inserted;
  - (d) if the Proponent is carrying on business under a name other than their own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B9.2.1 If a Proposal is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B9.2.
- B9.3 In Paragraph 3 of Form A: Bid/Proposal, the Proponent shall identify a contact person who is authorized to represent the Proponent for purposes of the Proposal.
- B9.4 Paragraph 13 of Form A: Bid/Proposal shall be signed in accordance with the following requirements:
  - (a) if the Proponent is a sole proprietor carrying on business in their own name, it shall be signed by the Proponent;
  - (b) if the Proponent is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
  - (c) if the Proponent is a corporation, it shall be signed by their duly authorized officer or officers and the corporate seal, if the corporation has one, should be affixed;
  - (d) if the Proponent is carrying on business under a name other than their own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B9.4.1 The name and official capacity of all individuals signing Form A: Bid/Proposal should be entered below such signatures.
- B9.5 If a Proposal is submitted jointly by two or more persons, the word "Proponent" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Proponents in the Proposal and the Contract, when awarded, shall be both joint and several.

#### B10. PRICES

- B10.1 The Proponent shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- B10.2 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Proposals.
  - (a) The Proponent shall state a separate price in Canadian funds for each of the following items of Work on Form B Prices:
    - Separate Price to be deducted from Total Bid Price Item No. 1 shall be the amount deducted from the Total Bid Price if the Water Filling Station is deleted in accordance with B23.5(b);
    - Separate Price to be deducted from Total Bid Price Item No. 2 shall be the amount deducted from the Total Bid Price if the Proposed Berms are deleted in accordance with B23.5(b);
    - Separate Price to be deducted from Total Bid Price Item No. 3 shall be the amount deducted from the Total Bid Price if the Perennial Planting is deleted in accordance with B23.5(b); and
    - (iv) Separate Price to be deducted from Total Bid Price Item No. 4 shall be the amount deducted from the Total Bid Price if the Shrub Planting is deleted in accordance with B23.5(b).
    - (v) Separate Price to be deducted from Total Bid Price Item No. 5 shall be the amount deducted from the Total Bid Price if the Tree Planting are deleted in accordance with B23.5(b).
    - (vi) Separate Price to be deducted from Total Bid Price Item No. 6 shall be the amount deducted from the Total Bid Price if the Granite Boulders are deleted in accordance with B23.5(b).
    - (vii) Separate Price to be deducted from Total Bid Price Item No. 7 shall be the amount deducted from the Total Bid Price if the Picnic Shelter is deleted in accordance with B23.5(b).
- B10.3 The quantities for which payment will be made to the Contractor are to be determined by the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications.
- B10.4 Payments to Non-Resident Contractors are subject to Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).

#### B11. ECONOMIC ANALYSIS

B11.1 The Proponent shall complete Form C: Economic Analysis, for the Spray Pad, providing values based upon the Proponent's design and local water and electrical rates.

#### B12. DESIGN DRAWINGS

- B12.1 The Proponent should submit spray pad drawings that show:
  - (a) The proposed design of the spray pad, clearly demonstrating the <u>layout & details</u> of features and how they relate to the Site;
  - (b) Separation / location of age appropriate play zones;
  - (c) The overall quality of the design and its aesthetic appeal;
  - (d) Compliance with the City of Winnipeg Accessibility Design Standards; and,
  - (e) Overall play experiences.
- B12.2 Design drawings should include at a minimum:
  - (a) A site context plan including:

- (i) location and configuration of the spray pad in association with the surrounding park and amenities;
- (ii) proposed site works such as pathways, fencing, and site furniture;
- (iii) indication of site services; and,
- (iv) any connections that are required or will be considered beneficial.
- (b) A plan of the spray pad clearly showing the location and orientation of all spray components within the context of the site plan including:
  - (i) component spray zones,
  - (ii) spray pad over spray zone,
  - (iii) manifold cabinet location,
  - (iv) drain locations, and
  - (v) schematics of site services and any modifications, relocations and connections.
- (c) Further to E46.2 any proposed changes to the design of the spray pad shall be clearly shown.
- (d) A concise written description of the design rationale,
- (e) Perspective sketches, renderings, sections, details and other graphic representations sufficient to illustrate the proposed design.
- (f) An itemized list of proposed spray components with a legend that relates them to their graphic representation on the plan.
- (g) Component descriptions and/or cut sheets outlining specifications of spray components and the quality, durability and warranty of materials.
- B12.3 Refer to F1 Appendix A Diagram 1 "Valour Community Centre Spray Pad Design Element Concepts"

#### B13. PROJECT WORKPLAN

- B13.1 The Proponent should submit a Project Work Plan that clearly demonstrates the Proponent's understanding of the Work, including:
  - (a) a methodology and schedule to construct both a playground and a spray pad.
  - (b) a methodology and schedule to decommission and remove the existing wading pool, building and outdoor hockey rink.
  - (c) a methodology and schedule for delivering a fully operational and commissioned spray pad by the Substantial Performance deadline.
- B13.2 The Project Work Plan should include at a minimum:
  - (a) A detailed methodology demonstrating the Proponent's thorough knowledge of the project and the desired deliverables, including:
    - (i) design and permitting;
    - (ii) description of the commissioning process;
    - (iii) description of the training being proposed;
    - (iv) quality assurance;
    - (v) budget control and assurance; and,
    - (vi) risk management.
  - (b) A list or chart of key personnel involved in the project, including all subcontractors, detailing their roles, relationships and responsibilities.
  - (c) A proposed project schedule in a Ghant chart format, including but not limited to:
    - (i) a timeframe for drawings and permitting;
    - (ii) a timeframe for play equipment and spray component delivery;
    - (iii) all construction operations;
    - (iv) sodding and sod maintenance;
    - (v) commissioning; and,
    - (vi) all project milestones.

(d) Subcontractor coordination should be clearly demonstrated in the project schedule. All subcontractors should sign off on the proposed schedule to demonstrate that they have agreed to undertake the Work and can do so in the allotted timeframe. Subcontractors may either sign next to their respective place in the schedule or submit a letter acknowledging said information. The letter(s) may be appended at the end of the proposal.

#### B14. SYSTEMS INTEGRATION

- B14.1 The Proponent should submit:
  - (a) Civil, Mechanical and Electrical system schematics developed in sufficient detail to describe the intended operation of the spray pad;
  - (b) Controller sequence(s) showing which features will be operating at the same time and which features will be operated by which controller;
  - (c) A description of the controls and a brief narrative about how the controls can be adjusted or modified should this prove to be necessary, as well as anticipated costs for the same; and,
  - (d) A maintenance schedule and anticipated maintenance costs associated with the spray pad features and mechanical system being proposed.

#### B15. DISCLOSURE

- B15.1 Various Persons provided information or services with respect to this Work. In the City's opinion, this relationship or association does not create a conflict of interest because of this full disclosure. Where applicable, additional material available as a result of contact with these Persons is listed below.
- B15.2 The Persons are:
  - (a) Colcat Enterprises, regarding play equipment and budgets.

#### B16. CONFLICT OF INTEREST AND GOOD FAITH

- B16.1 Further to C3.2, Proponents, by responding to this RFP, declare that no Conflict of Interest currently exists, or is reasonably expected to exist in the future.
- B16.2 Conflict of Interest means any situation or circumstance where a Proponent or Key Personnel proposed for the Work has:
  - (a) other commitments;
  - (b) relationships;
  - (c) financial interests; or
  - (d) involvement in ongoing litigation;

that could or would be seen to:

- (i) exercise an improper influence over the objective, unbiased and impartial exercise of the independent judgment of the City with respect to the evaluation of Proposals or award of the Contract; or
- (ii) compromise, impair or be incompatible with the effective performance of a Proponent's obligations under the Contract.
- (e) has contractual or other obligations to the City that could or would be seen to have been compromised or impaired as a result of their participation in the RFP process or the Project; or
- (f) has knowledge of confidential information (other than confidential information disclosed by the City in the normal course of the RFP process) of strategic and/or material relevance to the RFP process or to the Project that is not available to other proponents and that could or would be seen to give that Proponent an unfair competitive advantage.
- B16.3 In connection with their Proposal, each entity identified in B16.2 shall:
  - (a) avoid any perceived, potential or actual Conflict of Interest in relation to the procurement process and the Project;

- (b) upon discovering any perceived, potential or actual Conflict of Interest at any time during the RFP process, promptly disclose a detailed description of the Conflict of Interest to the City in a written statement to the Contract Administrator; and
- (c) provide the City with the proposed means to avoid or mitigate, to the greatest extent practicable, any perceived, potential or actual Conflict of Interest and shall submit any additional information to the City that the City considers necessary to properly assess the perceived, potential or actual Conflict of Interest.
- B16.4 Without limiting B16.3, the City may, in their sole discretion, waive any and all perceived, potential or actual Conflicts of Interest. The City's waiver may be based upon such terms and conditions as the City, in their sole discretion, requires to satisfy itself that the Conflict of Interest has been appropriately avoided or mitigated, including requiring the Proponent to put into place such policies, procedures, measures and other safeguards as may be required by and be acceptable to the City, in their sole discretion, to avoid or mitigate the impact of such Conflict of Interest.
- B16.5 Without limiting B16.3, and in addition to all contractual or other rights or rights at law or in equity or legislation that may be available to the City, the City may, in their sole discretion:
  - (a) disqualify a Proponent that fails to disclose a perceived, potential or actual Conflict of Interest of the Proponent or any of their Key Personnel;
  - (b) require the removal or replacement of any Key Personnel proposed for the Work that has a perceived, actual or potential Conflict of Interest that the City, in their sole discretion, determines cannot be avoided or mitigated;
  - (c) disqualify a Proponent or Key Personnel proposed for the Work that fails to comply with any requirements prescribed by the City pursuant to B16.4 to avoid or mitigate a Conflict of Interest; and
  - (d) disqualify a Proponent if the Proponent, or one of their Key Personnel proposed for the Project, has a perceived, potential or actual Conflict of Interest that, in the City's sole discretion, cannot be avoided or mitigated, or otherwise resolved.
- B16.6 The final determination of whether a perceived, potential or actual Conflict of Interest exists shall be made by the City, in their sole discretion.

#### B17. QUALIFICATION

- B17.1 The Proponent shall:
  - (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Proponent does not carry on business in Manitoba, in the jurisdiction where the Proponent does carry on business; and
  - (b) be financially capable of carrying out the terms of the Contract; and
  - (c) have all the necessary experience, capital, organization, and equipment to perform the Work in strict accordance with the terms and provisions of the Contract.
- B17.2 The Proponent and any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
  - (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="https://www.winnipeg.ca/matmgt/Templates/files/debar.pdf">https://www.winnipeg.ca/matmgt/Templates/files/debar.pdf</a>.
- B17.3 The Proponent and/or any proposed Subcontractor (for the portion of the Work proposed to be subcontracted to them) shall:
  - (a) have successfully carried out work similar in nature, scope and value to the Work; and
  - (b) be fully capable of performing the Work required to be in strict accordance with the terms and provisions of the Contract; and
  - (c) have a written workplace safety and health program, if required, pursuant to The Workplace Safety and Health Act (Manitoba);

- (d) have a valid Canadian Certified Playground Inspector;
- (e) have completed the Accessible Customer Service online training required by the Accessibility for Manitobans Act (AMA) (see B17.5 and D7).
- B17.4 Further to B17.3(c), should the Total Bid Price exceed \$100,000.00, the Proponent shall within five (5) Business Days of a request by the Contract Administrator, provide proof satisfactory to the Contract Administrator that the Proponent /Subcontractor has a workplace safety and health program meeting the requirements of The Workplace Safety and Health Act (Manitoba), by providing:
  - (a) Written confirmation of a safety and health certification meeting SAFE Work Manitoba's SAFE Work Certified Standard (e.g., COR<sup>™</sup> and SECOR<sup>™</sup>) in the form of:
    - a copy of their valid Manitoba COR certificate and Letter of Good Standing (or Manitoba equivalency) as issued under the Certificate of Recognition (COR) Program administered by the Construction Safety Association of Manitoba or by the Manitoba Heavy Construction Association's WORKSAFELY<sup>™</sup> COR<sup>™</sup> Program; or
    - a copy of their valid Manitoba SECOR<sup>™</sup> certificate and Letter of Good Standing (or Manitoba equivalency) as issued under the Small Employer Certificate of Recognition Program (SECOR<sup>™</sup>) administered by the Construction Safety Association of Manitoba or by the Manitoba Heavy Construction Association's WORKSAFELY<sup>™</sup> COR<sup>™</sup> Program; or
  - (b) a report or letter to that effect from an independent reviewer acceptable to the City. (A list of acceptable reviewers and the review template are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <u>http://www.winnipeg.ca/matmgt/</u>.
- B17.5 Further to B17.3(e), the Proponent acknowledges they and all Subcontractors have obtained training required by the Accessibility for Manitobans Act (AMA) available at <a href="http://www.accessibilitymb.ca/training.html">http://www.accessibilitymb.ca/training.html</a> for anyone that may have any interaction with the public on behalf of the City of Winnipeg.
- B17.6 The Proponent shall submit, within three (3) Business Days of a request by the Contract Administrator, proof satisfactory to the Contract Administrator of the qualifications of the Proponent and of any proposed Subcontractor.
- B17.7 The Proponent shall provide, on the request of the Contract Administrator, full access to any of the Proponent's equipment and facilities to confirm, to the Contract Administrator's satisfaction, that the Proponent's equipment and facilities are adequate to perform the Work.

#### B18. OPENING OF PROPOSALS AND RELEASE OF INFORMATION

- B18.1 Proposals will not be opened publicly.
- B18.2 After award of Contract, the Contract amount and the name of the successful Proponent and their address will be available on the MERX website at <u>www.merx.com</u>.
- B18.3 The Proponent is advised any information contained in any Proposal Submission may be released if required by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law or by City policy or procedures (which may include access by members of City Council).
- B18.3.1 To the extent permitted, the City shall treat as confidential information, those aspects of a Proposal Submission identified by the Proponent as such in accordance with and by reference to Part 2, Section 17 or Section 18 or Section 26 of The Freedom of Information and Protection of Privacy Act (Manitoba), as amended.
- B18.4 Following the award of Contract, a Proponent will be provided with information related to the evaluation of their submission upon written request to the Contract Administrator.

#### B19. IRREVOCABLE OFFER

B19.1 The Proposal(s) submitted by the Proponent shall be irrevocable for the time period specified in Paragraph 11 of Form A: Bid/Proposal.

B19.2 The acceptance by the City of any Proposal shall not release the Proposals of the other responsive Proponents and these Proponents shall be bound by their offers on such Work until a Contract for the Work the time period specified in Paragraph 11 of Form A: Bid/Proposal.

#### B20. WITHDRAWAL OF OFFERS

B20.1 A Proponent may withdraw their Proposal without penalty prior to the Submission Deadline.

#### B21. INTERVIEWS

B21.1 The Contract Administrator may, in their sole discretion, interview Proponents during the evaluation process.

#### B22. NEGOTIATIONS

- B22.1 The City reserves the right to negotiate details of the Contract with any Proponent. Proponents are advised to present their best offer, not a starting point for negotiations in their Proposal Submission.
- B22.2 The City may negotiate with the Proponents submitting, in the City's opinion, the most advantageous Proposals. The City may enter into negotiations with one or more Proponents without being obligated to offer the same opportunity to any other Proponents. Negotiations may be concurrent and will involve each Proponent individually. The City shall incur no liability to any Proponent as a result of such negotiations.
- B22.3 If, in the course of negotiations pursuant to B22.2, the Proponent amends or modifies a Proposal after the Submission Deadline, the City may consider the amended Proposal as an alternative to the Proposal already submitted without releasing the Proponent from the Proposal as originally submitted.

#### B23. EVALUATION OF PROPOSALS

- B23.1 Award of the Contract shall be based on the following evaluation criteria:
  - (a) compliance by the Proponent with the requirements of the Request for Proposal or acceptable deviation therefrom: (pass/fail)
  - (b) qualifications of the Proponent and the Subconsultants, if any, pursuant to B17: (pass/fail)

(c)	Total Bid Price;	10%
(d)	Economic Analysis	10%
(e)	Design Drawings and Component Descriptions	45%
(f)	Project Work Plan	25%
(g)	Systems Integration	10%

- B23.2 Further to B23.1(a), the Award Authority may reject a Proposal as being non-responsive if the Proposal Submission is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Proposal, or waive technical requirements or minor informalities or irregularities if the interests of the City so require.
- B23.3 Further to B23.1(b), the Award Authority shall reject any Proposal submitted by a Proponent who does not demonstrate, in their Proposal or in other information required to be submitted, that it is qualified.
- B23.4 If, in the sole opinion of the City, a Proposal does not achieve a pass rating for B23.1(a) and B23.1(b), the Proposal will be determined to be non-responsive and will not be further evaluated.
- B23.5 Further to B23.1(c) the Award Authority may reject a Proposal as being non-responsive if it exceeds the funds available as shown in D2.3.
- B23.6 Further to B23.1(c) the Total Bid Price shall be evaluated with a weighing of 10 points out of a total of 100 possible points. As such, the lowest Proponent shall receive the full 10 points, and the second lowest Proponent and subsequent Proponents shall be pro-rated accordingly.

- B23.7 Further to B23.1(c) the Total Bid Price shall be the sum of the quantities multiplied by the unit prices for each item shown on Form B: Prices adjusted, if necessary, as follows:
  - (a) if the lowest evaluated responsive Proposal submitted by a responsible and qualified Proponent is within the budgetary provision for the Work, no adjustment will be made to the Total Bid Price; or
  - (b) if the lowest evaluated responsive Proposal submitted by a responsible and qualified Proponent exceeds the budgetary provision for the Work, the Total Bid Prices of all responsive Bids submitted by responsible and qualified Proponents will be adjusted by progressively deducting items 1, 2, 3, 4, 5, 6, and 7 from 'Separate Prices to be deducted from Total Bid Price' noted on Form B: Prices in the order listed here until a Total Bid Price within budgetary provision is achieved.
- B23.7.1 In the event that a unit price is not provided on Form B: Prices, the City will determine the unit price by dividing the Amount (extended price) by the approximate quantity, for the purposes of evaluation and payment.
- B23.8 Further to B23.1(d) the Economic Analysis shall be evaluated with the weighing of 10 points out of 100 possible points. As such, the lowest Proponent shall receive the full 10 points, and the second lowest Proponent and subsequent Proponents shall be pro-rated accordingly.
- B23.9 Further to B23.1(e) the Design Drawings and Component Descriptions shall be evaluated with a weighting of 45 points out of a total of 100 possible points, as per B12.
- B23.9.1 The Design Drawings and Component Descriptions for the Spray Pad shall be evaluated on the following criteria:
  - (a) The clarity of the drawings, including a site context plan, and supportive imagery and literature, to effectively communicate the design, intent and function of the spray pad and features (5 points).
  - (b) The quality, nature and diversity of play components and play experiences on the spray pad (15 points);
  - (c) The design aesthetic, including the implementation of a consistent and appropriate theme (5 points);
  - (d) The layout of the spray components in relation to each other and as organized on the spray pad. Implementation of appropriate age zones are deemed part of the proposal (10 points); and,
  - (e) The quality, durability and warranty of materials (10 points).
- B23.10 Further to B23.1(f) the Project Work Plan for the **entire** project shall be evaluated with a weighting of 25 points out of a possible 100 points, as per B13.
- B23.10.1 The Project Work Plan shall be evaluated on the following criteria:
  - (a) The project delivery methodology and understanding of the functional and technical issues (10 points);
  - (b) The clarity and appropriateness of the proposed project schedule (10 points); and
  - (c) The organizational chart with Contractor and Subcontractor experience and acknowledgment (5 points).
- B23.11 Further to B23.1(g) the Systems Integration shall be evaluated with a weighting of 10 points out of a possible 100 points as per B14.
- B23.11.1 The Systems Integration for the Spray Pad shall be evaluated on the following criteria:
  - (a) Clarity and completeness of Civil, Mechanical and Electrical system schematics (4 points);
  - (b) Review of operational considerations (3 points);
  - (c) Maintenance schedule and anticipated maintenance costs (3 points).
- B23.12 Where references are requested, the reference checks to confirm information provided may not be restricted to only those submitted by the Proponent, and may include organizations representing Persons, known to have done business with the Proponent.

#### B24. AWARD OF CONTRACT

- B24.1 The City will give notice of the award of the Contract, or will give notice that no award will be made.
- B24.2 The City will have no obligation to award a Contract to a Proponent, even though one or all of the Proponents are determined to be qualified, and the Proposals are determined to be responsive.
- B24.2.1 Without limiting the generality of B24.2 the City will have no obligation to award a Contract where:
  - (a) the prices exceed the available City funds for the Work;
  - (b) the prices are materially in excess of the prices received for similar work in the past;
  - (c) the prices are materially in excess of the City's cost to perform the Work, or a significant portion thereof, with their own forces;
  - (d) only one Proposal is received; or
  - (e) in the judgment of the Award Authority, the interests of the City would best be served by not awarding a Contract.
- B24.3 Where an award of Contract is made by the City, the award shall be made to the qualified Proponent submitting the most advantageous offer.
- B24.3.1 Following the award of Contract, a Proponent will be provided with information related to the evaluation of their Proposal upon written request to the Contract Administrator.
- B24.4 The City may, at their discretion, award the Contract in phases.
- B24.4.1 Further to B24.4 the City reserves the right to negotiate and award future phases to the successful Proponent.
- B24.5 Further to Paragraph 7 of Form A: Bid/Proposal and C4, the City may issue an award letter to the successful Proponent in lieu of execution of Contract Documents
- B24.5.1 The Contract documents as defined in C1.1(o)(ii) in their entirety shall be deemed to be incorporated in and to form a part of the award letter notwithstanding that they are not necessarily attached to or accompany said award letter.
- B24.6 Following the award of contract, a Proponent will be provided with information related to the evaluation of his/her Proposal upon written request to the Contract Administrator.
- B24.7 If, after the award of Contract, the Project is cancelled, the City reserves the right to terminate the Contract. The Proponent will be paid for all Services rendered up to time of termination.

## **PART C - GENERAL CONDITIONS**

#### C0. GENERAL CONDITIONS

- C0.1 The *General Conditions for Construction* (Revision 2020-01-31) are applicable to the Work of the Contract.
- C0.1.1 The General Conditions for Construction are available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="http://www.winnipeg.ca/matmgt/gen\_cond.stm">http://www.winnipeg.ca/matmgt/gen\_cond.stm</a>.
- C0.2 A reference in the Request for Proposal to a section, clause or subclause with the prefix "**C**" designates a section, clause or subclause in the *General Conditions for Construction*.

## **PART D - SUPPLEMENTAL CONDITIONS**

#### GENERAL

#### D1. GENERAL CONDITIONS

D1.1 In addition to the *General Conditions for Construction*, these Supplemental Conditions are applicable to the Work of the Contract.

#### D2. SCOPE OF WORK

- D2.1 The Work to be done under the Contract shall consist of the decommissioning and removal of a wading pool and building, the supply and construction of a new "spray to drain" spray pad, and the associated site development.
- D2.2 The major components of the Work are as follows:
  - (a) Removal of the east rink (boards, surround, paving), shed and associated foundations and granular base course;
  - (b) Removal and decommissioning of existing light standards and associated foundations (fixtures to be salvaged by the City);
  - (c) Removal and decommissioning of a wading pool;
  - (d) Design and construction of a straight-to-drain spray pad, including but not limited to all associated fixtures, drains, piping, electrical works and concrete spray basin, complete with all required permitting;
  - (e) Supply and installation of a concrete spray pad and associated walkways and sitting areas;
  - (f) Supply and Installation of water spray features;
  - (g) Sewer, water and electrical connections;
  - (h) Commissioning of the spray pad;
  - (i) Removal of an existing playground (equipment and safety surfacing);
  - (j) Supply and installation of playground equipment;
  - (k) Supply and installation of rubberized protective surfacing and engineered protective surfacing complete with concrete curb edging;
  - (I) Supply and installation of site furniture, signage, and receptacles;
  - (m) Supply and installation of chain link fencing;
  - (n) Supply and installation of a picnic shelter complete with helical piles, metal roof, and permitting;
  - (o) Supply and installation of planting and planting beds;
  - (p) Site restoration including site grading, topsoil, and sodding.
- D2.3 The funds available for this Contract are 1,400,000.

#### D3. SITE INVESTIGATION DUE DILIGENCE AND RISK

D3.1 Notwithstanding C3.1, the Contractor acknowledges that the site investigation reports and other site information included in this Tender have been provided to it and may be relied upon by the Contractor to the extent that the Contractor uses Good Industry Practice in interpreting such report(s) and site information and carries out the Work in accordance with Good Industry Practice based upon such report(s) and the information contained in them and such other site information. In the event that a site condition related to:

- (a) the location of any utility which can be determined from the records or other information available at the offices of any public authority or person, including a municipal corporation and any board or commission thereof, having jurisdiction or control over the utility;
- (b) the Site conditions, including but not limited to subsurface hazardous materials or other concealed physical conditions;
- (c) the location, nature, quality or quantity of the materials to be removed or to be employed in the performance of the Work;
- (d) the nature, quality or quantity of the Plant needed to perform the Work;
- (e) all matters concerning access to the Site, power supplies, location of existing services, utilities or materials necessary for the completion of the Work; and
- (f) all other matters which could in any way affect the performance of the Work;

that could not have been "properly inferable", "readily apparent" and readily discoverable" using Good Industry Practice by the Contractor, results in additional Work which is a direct result of this newly discovered site condition, such additional Work will be considered by the City under Changes in Work.

#### D4. DEFINITIONS

- D4.1 When used in this Request for Proposal:
  - (a) Supply Chain Disruption" means an inability by the Contractor to obtain goods or services from third parties necessary to perform the Work of the Contract within the schedule specified therein, despite the Contractor making all reasonable commercial efforts to procure same. Contractors are advised that increased costs do not, in and of themselves, amount to a Supply Chain Disruption.

#### D5. CONTRACT ADMINISTRATOR

D5.1 The Contract Administrator is Scatliff + Miller + Murray, represented by:

- D5.2 Before commencement of Work, Jennifer Wagner will identify additional personnel representing the Contract Administrator and their respective roles and responsibilities for the Work.
- D5.3 At the pre-commencement meeting, the Contract Administrator will identify additional personnel representing the Contract Administrator and their respective roles and responsibilities for the Work.

#### D6. CONTRACTOR'S SUPERVISOR

- D6.1 Further to C6, the Contractor shall employ and keep on the Work, at all times during the performance of the Work, a competent supervisor and assistants, if necessary, acceptable to the Contract Administrator. The supervisor shall represent the Contractor on the Site. The supervisor shall not be replaced without the prior consent of the Contract Administrator unless the supervisor proves to be unsatisfactory to the Contractor and ceases to be in their employ.
- D6.1.1 Further to D6.1, the Contractor must have the following on site at all times:
  - (a) Approved construction drawings on site (full-size);
  - (b) Approved Specification package; and
  - (c) One copy of the annotated work schedule with dates for inspections by the CA.
- D6.1.2 Further to D6.1.1(c), this schedule will be used to record the date of CA inspection and approval of the outlined tasks prior to the Contractor proceeding to the subsequent tasks.

- D6.2 Before commencement of Work, the Contractor shall identify their designated supervisor and any additional personnel representing the Contractor and their respective roles and responsibilities for the Work.
- D6.2.1 Further to C5, Contract Administrator may give instructions or orders to the Contractor's supervisor and such instructions or orders shall be deemed to have been given to the Contractor.

#### D7. ACCESSIBLE CUSTOMER SERVICE REQUIREMENTS

- D7.1 The Accessibility for Manitobans Act (AMA) imposes obligations on The City of Winnipeg to provide accessible customer service to all persons in accordance with the Customer Service Standard Regulation ("CSSR") to ensure inclusive access and participation for all people who live, work or visit Winnipeg regardless of their abilities.
- D7.1.1 The Contractor agrees to comply with the accessible customer service obligations under the CSSR and further agrees that when providing the Goods or Services or otherwise acting on the City of Winnipeg's behalf, shall comply with all obligations under the AMA applicable to public sector bodies.
- D7.1.2 The accessible customer service obligations include, but are not limited to:
  - (a) providing barrier-free access to goods and services;
  - (b) providing reasonable accommodations;
  - (c) reasonably accommodating assistive devices, support persons, and support animals;
  - (d) providing accessibility features e.g. ramps, wide aisles, accessible washrooms, power doors and elevators;
  - (e) inform the public when accessibility features are not available;
  - (f) providing a mechanism or process for receiving and responding to public feedback on the accessibility of all goods and services; and
  - (g) providing adequate training of staff and documentation of same.

#### D8. UNFAIR LABOUR PRACTICES

- D8.1 Further to C3.2, the Contractor declares that in bidding for the Work and in entering into this Contract, the Contractor and any proposed Subcontractor(s) conduct their respective business in accordance with established international codes embodied in United Nations Universal Declaration of Human Rights (UDHR) <u>https://www.un.org/en/about-us/universal-declaration-of-human-rights</u> International Labour Organization (ILO) <u>https://www.ilo.org/global/lang-en/index.htm</u> conventions as ratified by Canada.
- D8.2 The City of Winnipeg is committed and requires its Contractors and their Subcontractors, to be committed to upholding and promoting international human and labour rights, including fundamental principles and rights at work covered by ILO eight (8) fundamental conventions and the United Nations Universal Declaration of Human Rights which includes child and forced labour.
- D8.3 Upon request from the Contract Administrator, the Contractor shall provide disclosure of the sources (by company and country) of the raw materials used in the Work and a description of the manufacturing environment or processes (labour unions, minimum wages, safety, etc.).
- D8.4 Failure to provide the evidence required under D8.3, may be determined to be an event of default in accordance with C18.
- D8.5 In the event that the City, in its sole discretion, determines the Contractor to have violated the requirements of this section, it will be considered a fundamental breach of the Contract and the Contractor shall pay to the City a sum specified by the Contract Administrator in writing ("Unfair Labour Practice Penalty"). Such a violation shall also be considered an Event of Default, and

shall entitle the City to pursue all other remedies it is entitled to in connection with same pursuant to the Contract.

- D8.5.1 The Unfair Labour Practice Penalty shall be such a sum as determined appropriate by the City, having due regard to the gravity of the Contractor's violation of the above requirements, any cost of obtaining replacement goods/ services or rectification of the breach, and the impact upon the City's reputation in the eyes of the public as a result of same.
- D8.5.2 The Contractor shall pay the Unfair Labour Practice Penalty to the City within thirty (30) Calendar Days of receiving a demand for same in accordance with D8.5. The City may also hold back the amount of the Unfair Labour Practice Penalty from payment for any amount it owes the Contractor.
- D8.6 The obligations and rights conveyed by this clause survive the expiry or termination of this Contract, and may be exercised by the City following the performance of the Work, should the City determine, that a violation by the Contractor of the above clauses has occurred following same. In no instance shall the Unfair Labour Practice Penalty exceed the total of twice the Contract value.

#### SUBMISSIONS

#### D9. AUTHORITY TO CARRY ON BUSINESS

D9.1 The Contractor shall be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Contractor does not carry on business in Manitoba, in the jurisdiction where the Contractor does carry on business, throughout the term of the Contract, and shall provide the Contract Administrator with evidence thereof upon request.

#### D10. SAFE WORK PLAN

- D10.1 The Contractor shall provide the Contract Administrator with a Safe Work Plan at least five (5) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract.
- D10.2 The Safe Work Plan should be prepared and submitted in the format shown in the City's template which is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <a href="http://www.winnipeg.ca/matmgt/safety/default.stm">http://www.winnipeg.ca/matmgt/safety/default.stm</a>.
- D10.3 Notwithstanding B17.4 at any time during the term of the Contract, the City may, at their sole discretion and acting reasonably, require an updated COR Certificate or Annual Letter of good Standing. A Contractor, who fails to provide a satisfactory COR Certificate or Annual Letter of good Standing, will not be permitted to continue to perform any Work.

#### D11. INSURANCE

- D11.1 The Contractor shall provide and maintain the following insurance coverage:
  - (a) commercial general liability insurance, in the amount of at least two million dollars (\$2,000,000.00) inclusive, with The City of Winnipeg and Scatliff+Miller+Murray added as an additional insured; such liability policy to also contain a cross-liability clause, contractual liability clause, non-owned automobile liability and products and completed operations cover, to remain in place at all times during the performance of the Work;
  - (b) if applicable, Automobile Liability Insurance covering all motor vehicles, owned and operated and used or to be used by the Contractor directly or indirectly in the performance of the Work. The Limit of Liability shall not be less than \$2,000,000 inclusive for loss or

damage including personal injuries and death resulting from any one accident or occurrence;

- (c) all risks course of construction insurance, including testing and commissioning, in the amount of 100% of the total contract price, written in the name of the Contractor and the City of Winnipeg to remain in place until the date of substantial performance and all testing and commissioning is completed.
- D11.2 The Contractor shall ensure that any consultants or subconsultants hired in connection with the Design Services provide and maintain the following minimum insurance coverage:
  - (a) Commercial general liability insurance in the amount of at least \$2,000,000.00. Products and completed operations endorsement, cross liability clause, contractual liability and The City of Winnipeg to be added as an additional insured;
  - (b) Professional liability insurance in the amount of at least \$1,000,000.00 per claim and \$1,000,000.00 in the aggregate to remain in place during the performance of the services and for 12 months following completion of the Work.
- D11.3 Deductibles shall be borne by the Contractor.
- D11.4 All policies shall be taken out with insurers licensed to carry on business in the Province of Manitoba.
- D11.5 The Contractor shall provide the Contract Administrator with a certificate(s) of insurance, referencing the Request for Proposal number and/or the Scope of Work D2 and Specifications PART E - to be performed, in a form satisfactory to the City Solicitor, at least two (2) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract Documents, as applicable.
- D11.6 The Contractor shall not cancel, materially alter, or cause the policy to lapse without providing at least thirty (30) Calendar Days prior written notice to the Contract Administrator.

#### D12. CONTRACT SECURITY

- D12.1 If the Contract Price exceeds twenty-five thousand dollars (\$25,000.00), the Contractor shall provide and maintain contract security until the expiration of the warranty period in the form of:
  - (a) a performance bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H1: Performance Bond), in the amount of fifty percent (50%) of the Contract Price; and
  - (b) a labour and material payment bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H2: Labour and Material Payment Bond), in an amount equal to fifty percent (50%) of the Contract Price; or
  - (c) an irrevocable standby letter of credit issued by a bank or other financial institution registered to conduct business in Manitoba and drawn on a branch located in Winnipeg, in the form attached to these Supplemental Conditions (Form H3: Irrevocable Standby Letter of Credit), in the amount of fifty percent (50%) of the Contract Price; or
  - (d) a certified cheque or draft payable to "The City of Winnipeg", drawn on a bank or other financial institution registered to conduct business in Manitoba, in the amount of fifty percent (50%) of the Contract Price.
- D12.1.1 Where the contract security is a performance bond, it may be submitted in hard copy or digital format. If submitted in digital format the contract security must meet the following criteria:
  - (a) the version submitted by the Contractor must have valid digital signatures and seals;
  - (b) the version submitted by the Contractor must be verifiable by the City with respect to the totality and wholeness of the bond form, including: the content; all digital

signatures and digital seals; with the surety company, or an approved verification service provider of the surety company.

- (c) the version submitted must be viewable, printable and storable in standard electronic file formats compatible with the City, and in a single file. Allowable formats include pdf.
- (d) the verification may be conducted by the City immediately or at any time during the life of the bond and at the discretion of the City with no requirement for passwords or fees.
- (e) the results of the verification must provide a clear, immediate and printable indication of pass or fail regarding D12.1.1(b).
- D12.1.2 Digital bonds failing the verification process will not be considered to be valid and may be determined to be an event of default in accordance with C18.1. If a digital bond fails the verification process, the Contractor may provide a replacement bond (in hard copy or digital format) within seven (7) Calendar Days of the City's request or within such greater period of time as the City in their discretion, exercised reasonably, allows.
- D12.1.3 Digital bonds passing the verification process will be treated as original and authentic.
- D12.1.4 Where the contract security is in the form of a certified cheque or draft, it will be deposited by the City. The City will not pay any interest on certified cheques or drafts furnished as contract security.
- D12.2 The Contractor shall provide the Contract Administrator identified in D4 with the required contract security within seven (7) Calendar Days of notification of the award of the Contract by way of Purchase Order or an award letter and prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract Documents, if applicable.
- D12.3 Where the contract security is provided in accordance with D12.1(a) and D12.1(b), the Contractor shall, as soon as practicable after entering into a contract with a Subcontractor:
  - (a) give the Subcontractor written notice of the existence of the labour and material payment bond in D12.1(b); and
  - (b) post a notice of the bond and/or a copy of that bond in a conspicuous location at the Site of the Work.

#### D13. SUBCONTRACTOR LIST

D13.1 The Contractor shall provide the Contract Administrator with a complete list of the Subcontractors whom the Contractor proposes to engage (Form J: Subcontractor List) at least two (2) Business Days prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract Documents, as applicable.

#### D14. DETAILED WORK SCHEDULE

- D14.1 Within seven (7) Working Days of receipt of the notice of award, the Contractor shall review and update the detailed work schedule laid out in the Proponent's Project Work Plan with the Contract Administrator.
- D14.2 The detailed work schedule shall be in a format acceptable to the Contract Administrator.
- D14.3 The Contractor shall provide the Contract Administrator with an updated detailed construction schedule at least two (2) Business Days prior to the commencement of any Work on the Site.
- D14.4 The detailed work schedule shall include but not be limited to:
  - (a) Final drawing submissions for the spray pad,
  - (b) Permitting,

- (c) Ordering of spray components,
- (d) Delivery of spray components,
- (e) Ordering of playground equipment,
- (f) Delivery of playground equipment,
- (g) Start of Work on site,
- (h) Removal of East Rink, Building and Lighting,
- (i) Wading pool removals,
- (j) Water and sewer connections or disconnections,
- (k) Excavation and site preparation,
- (I) Civil, Mechanical, and Electrical Work,
- (m) Concrete pour(s),
- (n) Installation of spray components,
- (o) Installation of playground equipment,
- (p) Installation of playground surfacing,
- (q) Installation of topsoil and sodding,
- (r) Installation of site furnishings, signage, receptacles,
- (s) Installation of fencing,
- (t) Site restoration,
- (u) Commissioning, Winterization and Start-up,
- (v) Substantial Performance,
- (w) Total Performance, and
- (x) All other project milestones.
- D14.5 Each item on the schedule shall clearly identify the anticipated start and completion dates.

#### D15. REQUIREMENTS FOR SITE ACCESSIBILITY PLAN

- D15.1 The Contractor shall provide the Contract Administrator with an Accessibility Plan at least five
   (5) Business Days prior to the commencement of any Work on the Site but in no event later
   than the date specified in C4.1 for the return of the executed Contract Documents, if applicable.
- D15.2 The Accessibility Plan shall demonstrate how the Contractor will accommodate the safe passage of pedestrians and cyclists in accordance with the Manual of Temporary Traffic Control, the Contract Drawings, Staging Plans, and Streets By-Law No. 1481/77 at all times for the duration of the Construction. Unless noted in the Contract, the Accessibility Plan must include a written plan for the following:
  - (a) How the Contractor will maintain at least one crossing in each direction for each intersection (one north/south crosswalk and one east/west crosswalk).
  - (b) How the Contractor will maintain access to bus stops within the site.
  - (c) How the Contractor will maintain access to pedestrian corridors and half signals.
  - (d) How the Contractor will maintain cycling facilities.
  - (e) How the Contractor will maintain access to residents and businesses unless otherwise noted in the Contract.
  - (f) Any required detour signage at adjacent crossings to facilitate sidewalk or active transportation pathway closures.
- D15.3 The Accessibility Plan may also include figures, sketches, or drawings to demonstrate the proposed plan.

- D15.4 The Accessibility Plan shall include written details on how the Contractor intends to review, maintain, and document all items related to the Accessibility Plan on-site during Construction, including, but not limited to:
  - (a) Signage
  - (b) Temporary Ramping
  - (c) Transit Stops
  - (d) Detour Signage
- D15.5 At minimum, the Contractor shall review the site conditions on a daily basis to ensure that all features related to the Accessibility Plan are in place. The site review is intended to correct deficiencies as a result of unforeseen events such as wind, traffic, or the general public. Deficiencies that are direct result of the Contractors actions must be corrected immediately.
- D15.6 Any changes to the Accessibility Plan must be approved by the Contract Administrator.
- D15.7 Upon request from the Contract Administrator, the Contractor shall provide records demonstrating that the site has been maintained.
- D15.8 Deficiencies as a direct result of actions by the Contractor that are not immediately corrected and/or failure to produce records that demonstrate that the site was maintained in compliance with the Accessibility Plan may result in a pay adjustment via the monthly Progress Payment. The rate of pay adjustment will be as per the following schedule:
  - (a) First Offence A warning will be issued and documented in the weekly or bi-weekly site meeting.
  - (b) Second Offence A field instruction to immediately correct the site will be issued by the Contract Administrator.
- D15.9 Third and subsequent Offences A pay reduction will be issued in the amount of \$250.00 per instance and per day.

#### SCHEDULE OF WORK

#### D16. COMMENCEMENT

- D16.1 The Contractor shall not commence any Work until they are in receipt of a notice of award from the City authorizing the commencement of the Work.
- D16.2 The Contractor shall not commence any Work on the Site until:
  - (a) the Contract Administrator has confirmed receipt and approval of:
    - (i) evidence of authority to carry on business specified in D8;
    - (ii) evidence of the workers compensation coverage specified in C6.17;
    - (iii) the Safe Work Plan specified in D10;
    - (iv) evidence of the insurance specified in D11;
    - (v) the contract security specified in D12;
    - (vi) the Subcontractor list specified in D13;
    - (vii) the detailed work schedule specified in D14;
    - (viii) the Requirements for Site Accessibility Plan as specified in D15; and
    - (ix) the direct deposit application form specified in D32.
  - (b) the Contractor has attended a pre-construction meeting with the Contract Administrator, or the Contract Administrator has waived the requirement for a pre-construction meeting.
- D16.3 The Contractor shall not commence the Work on the Site before permitting is in place for all Work.

- D16.4 The City intends to award this Contract by March 29, 2024.
- D16.4.1 If the actual date of award is later than the intended date, the dates specified for Commencement, Critical Stages, Substantial Performance, and Total Performance will be adjusted by the difference between the aforementioned intended and actual dates.
- D16.5 The Contractor shall confirm the playground equipment and spray pad equipment through shop drawings with the Contract Administrator within fourteen (14) Working Days of receipt of the award letter.
- D16.6 Work on the demolition of the wading pool, east rink and existing shed shall commence no later than May 31<sup>st</sup>, 2024.

#### D17. WORK BY OTHERS

- D17.1 Further to C6.25, the Contractor's attention is directed to the fact that other Contractors, the personnel of Utilities and the staff of the City may be working within the project limit, approach roadway, adjacent roadways or right-of-way. The activities of these agencies may coincide with the Contractors execution of work and it will be the Contractor's responsibility to cooperate to the fullest extent with other personnel working in the area, and such cooperation is an obligation of the Contractor under the terms of Contract.
- D17.2 Work by others on or near the Site will include but not necessarily be limited to:
  - (a) Asphalting of the remaining outdoor rink;
  - (b) Community Centre site maintenance.
- D17.3 Further to D17.1 the Contractor shall cooperate and coordinate all activities with all parties performing required Work by Others. The Contractor must include and accommodate Work by Others identified in D17.2 or additional parties, in their construction schedule as per D14 and accommodate the necessary area on Site required for the Work by Others to complete the Work.

#### D18. CRITICAL STAGES

- D18.1 The Contractor shall achieve critical stages of the Work in accordance with the following requirements:
  - (a) Sod installation is to be complete and placed on maintenance by September 15, 2024.

#### D19. SUBSTANTIAL PERFORMANCE

- D19.1 The Contractor shall achieve Substantial Performance by September 30<sup>th</sup>, 2024.
- D19.2 When the Contractor considers the Work to be substantially performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Substantial Performance. Any defects or deficiencies in the Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.
- D19.3 The date on which the Work has been certified by the Contract Administrator as being substantially performed to the requirements of the Contract through the issue of a certificate of Substantial Performance is the date on which Substantial Performance has been achieved.

#### D20. TOTAL PERFORMANCE

- D20.1 The Contractor shall achieve Total Performance by October 15<sup>th,</sup> 2024
- D20.2 When the Contractor or the Contract Administrator considers the Work to be totally performed, the Contractor shall arrange, attend and assist in the inspection of the Work with the Contract Administrator for purposes of verifying Total Performance. Any defects or deficiencies in the

Work noted during that inspection shall be remedied by the Contractor at the earliest possible instance and the Contract Administrator notified so that the Work can be reinspected.

D20.3 The date on which the Work has been certified by the Contract Administrator as being totally performed to the requirements of the Contract through the issue of a certificate of Total Performance is the date on which Total Performance has been achieved.

#### D21. LIQUIDATED DAMAGES

- D21.1 If the Contractor fails to achieve Critical Stages, Substantial Performance or Total Performance in accordance with the Contract by the days fixed herein for same, the Contractor shall pay the City the following amounts per Working Day for each and every Working Day following the days fixed herein for same during which such failure continues:
  - (a) Critical Stages five hundred dollars (\$500);
  - (b) Substantial Performance five hundred dollars (\$500);
  - (c) Total Performance five hundred dollars (\$500).
- D21.2 The amount specified for liquidated damages in D21.1 is based on a genuine pre-estimate of the City's damages in the event that the Contractor does not achieve Substantial Performance or Total Performance by the days fixed herein for same.
- D21.3 The City may reduce any payment to the Contractor by the amount of any liquidated damages assessed.

#### D22. SUPPLY CHAIN DISRUPTION SCHEDULE DELAYS

- D22.1 The City acknowledges that the schedule for this Contract may be impacted by Supply Chain Disruption. Commencement and progress of the Work shall be performed by the Contractor with due consideration to the in close consultation with the Contract Administrator.
- D22.2 If the Contractor is delayed in the performance of the Work by reason of the Supply Chain Disruption, the Work schedule may be adjusted by a period of time equal to the time lost due to such delay and costs related to such delay will be determined as identified herein.
- D22.3 A minimum of seven (7) Calendar Days prior to the commencement of Work, the Contractor shall declare whether a Supply Chain Disruption will affect the start date. The Contractor shall provide sufficient evidence that the delay is directly related to a Supply Chain Disruption, including but not limited to evidence related to ordering of Material or Goods, production and/or manufacturing schedules or availability of staff as appropriate.
- D22.4 For any delay related to Supply Chain Disruption and identified after Work has commenced, the Contractor shall within seven (7) Calendar Days of becoming aware of the anticipated delay declare the additional delay and shall provide sufficient evidence as indicated in D22.3. Failure to provide this notice will result in no additional time delays being considered by the City.
- D22.5 The Work schedule, including the durations identified in D18 to D20 where applicable, will be adjusted to reflect delays accepted by the Contract Administrator. No additional payment will be made for adjustment of schedules except where seasonal work, not previously identified in the Contract, is carried over to the following construction season.
- D22.6 Where Work not previously identified is being carried over solely as a result of delays related to Supply Chain Disruption, as confirmed by the Contract Administrator, the cost of temporary works to maintain the Work in a safe manner until Work recommences, will be considered by the Contract Administrator. Where the Work is carried over only partially due to Supply Chain Disruption, a partial consideration of the cost of temporary works will be considered by the Contract Administrator.
- D22.7 Any time or cost implications as a result of Supply Chain Disruption and in accordance with the above, as confirmed by the Contract Administrator, shall be documented in accordance with C7.

#### D23. SCHEDULED MAINTENANCE

- D23.1 The Contractor shall perform the following scheduled maintenance in the manner and within the time periods required by the Specifications:
  - (a) Sodding as specified in E29.4;
  - (b) Planting as specified in E28.4;
  - (c) Winterization and Spring Start-up as specified in E48.2.
- D23.2 Determination of Substantial Performance and Total Performance shall be exclusive of scheduled maintenance identified herein. All scheduled maintenance shall be completed prior to the expiration of the warranty period. Where the scheduled maintenance cannot be completed during the warranty period, the warranty period shall be extended for such period of time as it takes the Contractor to complete the scheduled maintenance.

#### CONTROL OF WORK

#### D24. JOB MEETINGS

- D24.1 Regular weekly job meetings will be held at the Site. These meetings shall be attended by a minimum of one representative of the Contract Administrator, one representative of the City and one representative of the Contractor. Each representative shall be a responsible person capable of expressing the position of the Contract Administrator, the City and the Contractor respectively on any matter discussed at the meeting including the Work schedule and the need to make any revisions to the Work schedule. The progress of the Work will be reviewed at each of these meetings.
- D24.2 The Contract Administrator reserves the right to cancel any job meeting or call additional job meetings whenever they deem it necessary.

#### D25. PRIME CONTRACTOR – THE WORKPLACE SAFETY AND HEALTH ACT (MANITOBA)

D25.1 Further to C6.26, the Contractor shall be the Prime Contractor and shall serve as, and have the duties of the Prime Contractor in accordance with The Workplace Safety and Health Act (Manitoba).

#### D26. THE WORKPLACE SAFETY AND HEALTH ACT (MANITOBA) – QUALIFICATIONS

D26.1 Further to B17.4, the Contractor/Subcontractor must, throughout the term of the Contract, have a Workplace Safety and Health Program meeting the requirements of The Workplace Safety and Health Act (Manitoba). At any time during the term of the Contract, the City may, at their sole discretion and acting reasonably, require updated proof of compliance, as set out in B17.4.

#### D27. PLANT AND MATERIALS

D27.1 Plant and Material that is the property of the City shall not be removed from the Site, disposed of or used except for the purposes of the Work without the prior consent of the Contract Administrator.

#### D28. SAFETY

- D28.1 Further to C6, the Contractor shall be solely responsible for safety at the Site and for compliance with all laws, rules, regulations and practices required by the applicable safety legislation.
- D28.2 The Contractor shall be solely responsible for securing the Site, and any existing facility thereon, and for the proper care and protection of the Work already performed.

- D28.3 The Contractor shall do whatever is necessary to ensure that:
  - (a) no person, property, right, easement or privilege is injured, damaged or infringed by reason of the Contractor's activities in performing the Work;
  - (b) the health and safety of all persons employed in the performance of the Work or otherwise is not endangered by the method or means of their performance;
  - (c) adequate medical services are available to all persons employed on the Work and at all times during the performance of the Work;
  - (d) adequate sanitation measures are taken and facilities provided with respect to the Work;
  - (e) pedestrian and other traffic on any public or private road or waterway is not unduly impeded, interrupted or endangered by the performance or existence of the Work or Plant;
  - (f) fire hazards in or about the Work are eliminated.

#### D29. SITE CLEANING

- D29.1 The Contractor shall maintain the Site and the Work in a tidy condition and free from the accumulation of waste and debris, other than that caused by the City or by other contractors.
- D29.1.1 As the Work progresses, the Contractor shall remove any Plant and Material not required for the performance of the remaining Work. He shall also remove waste and debris other than that caused by the City or other contractors, and leave the Site and the Work clean and suitable for occupancy by the City unless otherwise specified.
- D29.1.2 Total Performance shall not be considered to have been achieved until the Contractor has cleaned up the Site and has removed all Plant, surplus Material, waste and debris, other than that left by the City or other contractors.

#### D30. INSPECTION

- D30.1 Further to D6.1.2, before beginning or resuming operations upon any portion of the Work, the Contractor shall notify the Contract Administrator so as to enable him / her to arrange for inspection. If the Contractor fails to notify the Contract Administrator, the Contractor shall, if and when required by the Contract Administrator, forthwith take down or expose and redo that portion of the Work required to facilitate inspection. The cost of such taking down or exposure, and redoing, if any, shall be borne by the Contractor.
- D30.2 If and when required by the Contract Administrator, the Contractor shall take down or expose forthwith any portion of the Work where the Contract Administrator determines that the Work is not in accordance with the Contract. The cost of such taking down or exposure, and redoing, if any, shall fall upon the City if the taking down or exposure indicates that the portion exposed was properly performed, but if otherwise the cost shall be borne by the Contractor.

#### D31. DEFICIENCIES

- D31.1 Further to C11, the Contract Administrator may order the Contractor to alter or improve their methods, to increase or improve their Plant, to furnish additional or more suitable Material, or to employ additional or more qualified labour if, at any time, the Contract Administrator determines that:
  - (a) the Work is not being, or will likely not be, performed satisfactorily; or
  - (b) progress is not being, or will likely not be, maintained in accordance with the work schedule.
- D31.2 If the Work or any part thereof is taken out of the Contractor's control pursuant to C19.7, all Plant and Material, and the interest of the Contractor in all licences, powers and privileges acquired, used or provided by the Contractor under the Contract shall be assigned by the Contractor to the City without compensation to the Contractor.

- D31.3 The City shall have the right to take possession of and use any of the Contractor's material and property of every kind provided by the Contractor for the purpose of the Work, and to procure other Plant or Material for the completion thereof.
- D31.4 When the Contract Administrator certifies that any Plant, Material or any interest of the Contractor referred to in D31.2, is no longer required for the purposes of the Work, or that it is not in the best interest of the City to retain that Plant, Material or interest, it shall revert to the Contractor.

#### **MEASUREMENT AND PAYMENT**

#### D32. PAYMENT

D32.1 Further to C12, the City shall make payments to the Contractor by direct deposit to the Contractor's banking institution, and by no other means. Payments will not be made until the Contractor has made satisfactory direct deposit arrangements with the City. Direct deposit application forms are at <a href="https://winnipeg.ca/finance/files/Direct\_Deposit\_Form.pdf">https://winnipeg.ca/finance/files/Direct\_Deposit\_Form.pdf</a>.

#### WARRANTY

#### D33. WARRANTY

- D33.1 Notwithstanding C13.2, the warranty period shall begin on the date of Total Performance and shall expire one (1) year thereafter unless extended pursuant to C13.2.1 or C13.2.2, in which case it shall expire when provided for thereunder.
- D33.1.1 Manufacturer's warranties on spray pad and playground equipment shall apply
  - (a) For the purpose of contract security, the warranty period shall be one (1) year.
- D33.2 Notwithstanding C13.2, the Contract Administrator may permit the warranty period for a portion or portions of the Work to begin prior to the date of Total Performance if a portion of the Work cannot be completed because of unseasonable weather or other conditions reasonably beyond the control of the Contractor but that portion does not prevent the balance of the Work from being put to its intended use.
- D33.2.1 In such case, the date specified by the Contract Administrator for the warranty period to begin shall be substituted for the date specified in C13.2 for the warranty period to begin.
- D33.3 Notwithstanding C13.2, the warranty period for tree and shrub planting shall begin on the date of Total Performance and shall expire two (2) years thereafter unless extended pursuant to C13.2.1 or C13.2.2, in which case it shall expire when provided for thereunder.
- D33.3.1 Warranty period for plant material installed after September 15, 2024 shall commence on May 15<sup>th</sup>, 2025 and shall expire two years after that date.

#### D34. DISPUTE RESOLUTION

- D34.1 If the Contractor disagrees with any opinion, determination, or decision of the Contract Administrator, the Contractor shall act in accordance with the Contract Administrator's opinion, determination, or decision unless and until same is modified by the process followed by the parties pursuant to D34.
- D34.2 The entire text of C21.4 is deleted, and amended to read: "Intentionally Deleted"
- D34.3 The entire text of C21.5 is deleted, and amended to read:
  - (a) If Legal Services has determined that the Disputed Matter may proceed in the Appeal Process, the Contractor must, within ten (10) Business Days of the date of the Legal Services Response Letter, submit their written Appeal Form, in the manner and format set out on the City's Materials Management Website, to the Chief Administrative Officer, and to

the Contract Administrator. The Contractor may not raise any other disputes other than the Disputed Matter in their Appeal Form.

- D34.4 Further to C21, prior to the Contract Administrator's issuance of a Final Determination, the following informal dispute resolution process shall be followed where the Contractor disagrees with any opinion, determination, or decision of the Contract Administrator ("Dispute"):
  - (a) In the event of a Dispute, attempts shall be made by the Contract Administrator and the Contractor's equivalent representative to resolve Disputes within the normal course of project dealings between the Contract Administrator and the Contractor's equivalent representative.
  - (b) Disputes which in the reasonable opinion of the Contract Administrator or the Contractor's equivalent representative cannot be resolved within the normal course of project dealings as described above shall be referred to a without prejudice escalating negotiation process consisting of, at a minimum, the position levels as shown below and the equivalent Contractor representative levels:
    - (i) The Contract Administrator;
    - (ii) Supervisory level between the Contract Administrator and applicable Department Head;
    - (iii) Department Head.
- D34.4.1 Names and positions of Contractor representatives equivalent to the above City position levels shall be determined by the Contractor and communicated to the City at the precommencement or kick off meeting.
- D34.4.2 As these negotiations are not an adjudicative hearing, neither party may have legal counsel present during the negotiations.
- D34.4.3 Both the City and the Contractor agree to make all reasonable efforts to conduct the above escalating negotiation process within twenty (20) Business Days, unless both parties agree, in writing, to extend that period of time.
- D34.4.4 If the Dispute is not resolved to the City and Contractor's mutual satisfaction after discussions have occurred at the final escalated level as described above, or the time period set out in D34.4.3, as extended if applicable, has elapsed, the Contract Administrator will issue a Final Determination as defined in C1.1(v), at which point the parties will be governed by the Dispute Resolution process set out in C21.

#### INDEMNITY

#### D35. INDEMNITY

- D35.1 Indemnity shall be as stated in C17.
- D35.2 Notwithstanding C17.1, the Contractor shall save harmless and indemnify the City in the amount of twice the Contract Price or five million dollars (\$5,000,000), whichever is greater, against all costs, damages or expenses arising from actions, claims, demands and proceedings, by whomsoever brought, made or taken as a result of negligent acts or negligent omissions of the Contractor, their Subcontractors, employees or agents in the performance or purported performance of the Work, and more particularly from:
  - (a) accidental injury to or death of any person whether retained by or in the employ of the contractor or not, arising directly or indirectly by reason of the performance of the Work, or by reason of any trespass on or damage to property;
  - (b) damage to any property owned in whole or in part by the City, or which the City by duty or custom is obliged, directly or indirectly, in any way or to any degree, to construct, repair or maintain;
  - (c) damage to, or trespass or encroachment upon, property owned by persons other than the City;

- (d) any claim for lien or trust claim served upon the City pursuant to The Builders' Liens Act;
- (e) failure to pay a Workers Compensation assessment, or Federal or Provincial taxes;
- (f) unauthorized use of any design, device, material or process covered by letters patent, copyright, trademark or trade name in connection with the Work;
- (g) inaccuracies in any information provided to the City by the Contractor.
- D35.3 Further to C17, The City shall save harmless and indemnify the Contractor in the amount of twice the Contract Price or five million dollars (\$5,000,000), whichever is greater, against all costs, damages or expenses arising from actions, claims, demands and proceedings, by whomsoever brought, made or taken as a result of negligent acts or negligent omissions of the City, their employees or agents in the performance of its obligation under the Contract.

#### THIRD PARTY AGREEMENTS

#### D36. FUNDING AND/OR CONTRIBUTION AGREEMENT OBLIGATIONS

- D36.1 Funding for the Work of the Contract is being provided to the City of Winnipeg by the Government of Manitoba and/or the Government of Canada and accordingly, as required by the applicable funding agreements, the following terms and conditions shall apply.
- D36.2 For the purposes of D36:
  - (a) **"Government of Canada"** includes the authorized officials, auditors, and representatives of the Government of Canada; and
  - (b) **"Government of Manitoba"** includes the authorized officials, auditors, and representatives of the Government of Manitoba.
- D36.3 Indemnification By Contractor
- D36.3.1 In addition to the indemnity obligations outlined in C17 of the General Conditions for Construction, the Contractor agrees to indemnify and save harmless the Government of Canada and the Government of Manitoba and each of their respective Ministers, officers, servants, employees, and agents from and against all claims and demands, losses, costs, damages, actions, suit or other proceedings brought or pursued in any manner in respect of any matter caused by the Contractor or arising from this Contract or the Work, or from the goods or services provided or required to be provided by the Contractor, except those resulting from the negligence of any of the Government of Canada's or the Government of Manitoba's Ministers, officers, servants, employees, or agents, as the case may be.
- D36.3.2 The Contractor agrees that in no event will Canada or Manitoba, their respective officers, servants, employees or agents be held liable for any damages in contract, tort (including negligence) or otherwise, for:
  - (a) any injury to any person, including, but not limited to, death, economic loss or infringement of rights;
  - (b) any damage to or loss or destruction of property of any person; or
  - (c) any obligation of any person, including, but not limited to, any obligation arising from a loan, capital lease or other long term obligation;

in relation to this Contract or the Work.

- D36.4 Records Retention and Audits
- D36.4.1 The Contractor shall maintain and preserve accurate and complete records in respect of this Contract and the Work, including all accounting records, financial documents, copies of contracts with other parties and other records relating to this Contract and the Work during the term of the Contract and for at least six (6) years after Total Performance. Those records bearing original signatures or professional seals or stamps must be preserved in paper form; other records may be retained in electronic form.

- D36.4.2 In addition to the record keeping and inspection obligations outlined in C6 of the General Conditions for Construction, the Contractor shall keep available for inspection and audit at all reasonable times while this Contract is in effect and until at least six (6) years after Total Performance, all records, documents, and contracts referred to in D36.4.1 for inspection, copying and audit by the City of Winnipeg, the Government of Manitoba and/or the Government of Canada and their respective representatives and auditors, and to produce them on demand; to provide reasonable facilities for such inspections, copying and audits, to provide copies of and extracts from such records, documents, or contracts upon request by the City of Winnipeg, the Government of Manitoba, and/or the Government of Canada and their respective representatives and auditors, and to promptly provide such other information and explanations as may be reasonably requested by the City of Winnipeg, the Government of Manitoba, and/or the Government of Canada from time-to-time.
- D36.5 Other Obligations
- D36.5.1 The Contractor consents to the City providing a copy of the Contract to the Government of Manitoba and/or the Government of Canada upon request from either entity.
- D36.5.2 If the Lobbyists Registration Act (Manitoba) applies to the Contractor, the Contractor represents and warrants that it has filed a return and is registered and in full compliance with the obligations of that Act, and covenants that it will continue to comply for the duration of this Contract.
- D36.5.3 The Contractor shall comply with all applicable legislation and standards, whether federal, provincial, or municipal, including (without limitation) labour, environmental, and human rights laws, in the course of providing the Work.
- D36.5.4 The Contractor shall properly account for the Work provided under this Contract and payment received in this respect, prepared in accordance with generally accepted accounting principles in effect in Canada, including those principles and standards approved or recommended from time-to-time by the Chartered Professional Accountants of Canada or the Public Sector Accounting Board, as applicable, applied on a consistent basis.

# GENERAL

## E1. APPLICABLE SPECIFICATIONS AND DRAWINGS

- E1.1 These Specifications shall apply to the Work.
- E1.2 *The City of Winnipeg Standard Construction Specifications* in its entirety, whether or not specifically listed on Form B: Prices, shall apply to the Work.
- E1.2.1 *The City of Winnipeg Standard Construction Specifications* is available on the Information Connection page at The City of Winnipeg, Corporate Finance, Materials Management Division website at <u>http://www.winnipeg.ca/matmgt/Spec/Default.stm</u>
- E1.2.2 The version in effect three (3) Business Days before the Submission Deadline shall apply.
- E1.2.3 Further to C2.4(d), Specifications included in the Request for Proposal shall govern over *The City* of *Winnipeg Standard Construction Specifications*.
- E1.3 Proponents are reminded that requests for approval of substitutes as an approved equal or an approved alternative shall be made in accordance with B7. In every instance where a brand name or design specification is used, the City will also consider approved equals and/or approved alternatives in accordance with B7.

## E2. DRAWINGS AND SPECIFICATIONS

- E2.1 The Contractor shall maintain one full size set of Drawings and Specifications on Site at all times during construction. This shall include the Contractor's final design and shop drawings, complete construction details, schematic diagrams and plan and elevation views of the spray pad mechanical system, change orders and any other information pertinent to the construction of the project. The drawings shall be printed in colour if colour is used to convey information.
- E2.2 The Contractor shall maintain a set of Record Drawings on Site marking all Changes in Work. These are to include but not be limited to buried line locations and runs dimensioned from existing site features. The information shall be transferred to an AutoCAD drawing and submitted to the Contract Administrator at Total Performance. There shall be no separate payment for Record Drawings but they shall be considered a part of the Commissioning.

#### E3. HAZARDOUS MATERIALS

E3.1 If asbestos or other hazardous materials are encountered during the Work of the Contract, the Contractor shall stop all work and notify the Contract Administrator immediately. Removal of hazardous materials shall be dealt with by the City and the Contractor shall await further instruction by the Contract Administrator.

# E4. COMPLETE PROJECT

E4.1 The Contractor is to deliver a complete project including all permits, inspections, demolition/removals, connections, tie-ins, and restorations required to operate and maintain the project.

## E5. EXAMINATION OF THE SITE

- E5.1 Further to C3.1, prior to commencing actual construction work, the Contractor shall check field conditions, obtain and confirm actual site dimensions, examine surface conditions, etc. as required to ensure correct fabrication and execution of the Work.
- E5.2 Information, if shown on the plans or provided in the specifications, related to past works in the area is based on record information which has been, in part, prepared by others. While this information is believed to be reliable, the Contract Administrator cannot assure its accuracy or for any errors or omissions which may have been incorporated as a result. The Contractor is hereby advised to obtain independent verification of accuracy of all information provided before applying it for any purpose.
- E5.3 Commencement of construction or any part thereof constitutes acceptance of existing conditions, and means dimensions have been considered, verified and are acceptable.
- E5.4 The Contractor shall bear all costs for onsite review and examination.

## E6. EXISTING SERVICES AND UTILITIES

E6.1 No responsibility will be assumed by the City for correctness or completeness of the Drawings, when provided, with respect to the existing utilities, pipes or other objects either underground or on the surface; the City shall not be liable for the incorrectness and inadequacy thereof. It shall be the responsibility of the Contractor to determine the location of all such utilities, pipes and other objects and to make good any damage done to them.

#### E7. ACCESS TO SITE

- E7.1 Access to the Site as required by the Contractor shall be provided and maintained by the Contractor at their own expense and approved by the Contract Administrator.
- E7.2 The Contractor's operations shall be limited to the minimum area necessary for undertaking the Work and they shall be responsible for all damage resulting from their Work on private property.
- E7.3 The Contractor shall be restricted to the Site access locations and routes only so that there is a minimum of disturbance to the existing ground surface. Damage to areas beyond the marked routes shall be repaired by and at the expense of the Contractor to the satisfaction of the Contract Administrator.

#### E8. CONSTRUCTION FACILITIES AND STAGING

E8.1 The Contractor shall be responsible for providing their own storage and handling of all construction operations. The use of public right-of-ways will not be allowed.

#### E9. PERMITS, NOTICES, LICENSES, CERTIFICATES, LAWS AND RULES

- E9.1 Further to C6.13, the Contractor shall give all necessary notices, obtain all necessary permits and pay all fees in order that the Work may be carried out. The Contractor shall submit all plans required by any inspection authority and obtain approval of same before proceeding with the Work, and pay any cost attached to the inspection of such plans.
- E9.2 The Contractor shall comply with all laws, ordinances, rules and regulations that would relate to the Work.
- E9.3 All notices, consents, approvals, statements, authorizations, documents or other communications to the City shall be submitted to the Contract Administrator.
- E9.4 All Work shall be performed in compliance with the Manitoba Workplace Health and Safety Act.

- E9.5 All Work shall be performed in compliance with the Manitoba Workplace Health and Safety Fall Protection guidelines.
- E9.6 The Contractor and Sub-contractors must be fully aware of all Work involving hazardous materials. All Work must be performed in compliance with the Manitoba Department of Labour Workplace Health and Safety Guidelines and all other applicable codes. The Contractor is responsible for the immediate notification to the Contract Administrator of their encountering of suspected hazardous material during their course of Work.

## E10. DAMAGE TO EXISTING STRUCTURES, TREES AND PROPERTY

- E10.1 All necessary precautions shall be exercised by the Contractor so as not to remove, disturb, or damage any existing trees, shrubs, sod, pavements, streets, roads, boulevards, poles, hydrants, water pipes, gas pipes, electrical wires, cables, conduits, sewers or other existing facilities and equipment at the Site of the Work. For all damage incurred in the performance of the Work (either directly or indirectly), the Contractor shall either replace and repair such damage, whichever may be deemed necessary in the opinion of, and acceptable to City of Winnipeg Contract Administrator, and the cost of which shall be borne entirely by the Contractor. The Contractor shall also indemnify and save harmless the City from all claims made directly or indirectly against it in respect to any such damage.
- E10.2 The Contractor shall take the following precautionary steps to prevent damage from construction activities to existing park trees within the limits of the construction area:
  - (a) A 2.4m Tree Protection Zone shall be fenced off for all trees within the Construction Boundary. The Contractor shall not stockpile materials and soil or park vehicles and equipment within 2.4 metres of trees.
  - (b) Trees identified to be at risk by the Contract Administrator are to be strapped with 25x100x2400 wood planks, or suitable protection as approved by the Contract Administrator.
  - (c) Excavation shall be performed in a manner that minimizes damage to the existing root systems. Where possible, excavation shall be carried out such that the edge of the excavation shall be a minimum of 1.5 times the diameter (measured in inches), with the outcome read in feet, from the closest edge of the trunk. Where roots must be cut to facilitate excavation, they shall be pruned neatly at the face of excavation.
  - (d) Operation of equipment within the drip line of the trees shall be kept to a minimum required to perform the Work required. Equipment shall not be parked, repaired, refuelled; construction materials shall not be stored, and earth materials shall not be stockpiled within the drip lines of trees. The drip line of a tree shall be considered to be the ground surface directly beneath the tips of its outermost branches. The Contractor shall ensure that the operations do not cause flooding or sediment deposition on areas where trees are located.
  - (e) Repair, replace and maintain tree protection materials during construction until the Project completion.
  - (f) Carefully remove safety fencing and strapping material without harming the trees as soon as the construction and restoration Work is complete.
- E10.3 All damage to existing trees caused by the Contractor's activities shall be repaired to the requirements and satisfaction of the Contract Administrator and the City Forester or their designate.
- E10.4 No separate measurement or payment will be made for the protection of trees.

## E11. PEDESTRIAN SAFETY AND TRAFFIC MANAGEMENT

- E11.1 Further to CW 1130, the Contractor shall take such measures as are necessary to ensure safe and convenient pedestrian ingress and egress is maintained to private properties while they are working near them. Any damage caused by the negligence of the Contractor or their Sub- Contractors to the adjacent Works or properties, shall be promptly repaired by him at their own expense, to the satisfaction of the Contract Administrator.
- E11.2 Ambulance/ Emergency vehicle access must be maintained at all times.

## E12. PROTECTION OF THE SURVEY INFRASTRUCTURE

- E12.1 Notwithstanding clause 4 "Persons and municipalities to protect Outline Monuments"; under <u>The</u> <u>Surveys Act</u>, of Manitoba, the Contractor shall be responsible to protect the Survey Infrastructure from damage as a result of the Work.
- E12.2 Further to C6.26 (g), at least 72 hours prior to the commencement of the On-Site Work the Contractor shall contact the City of Winnipeg, Geomatics Services Branch at 204-918-1360 (8:00 am to 4:00 pm Monday to Friday, excluding holidays) to obtain underground clearance. Geomatics Services will locate and mark all known outline survey monuments and geodetic control monuments and confirm the physical condition of those monuments upon completion of construction, at no cost to the Contractor.
- E12.3 Where a survey post, bar or control monument lies in the line of the proposed Work and must be disturbed, the Contractor shall provide the Contract Administrator with 48 hours' notice to permit referencing for future replacement, at no cost to the Contractor. Failure to provide the specified notice shall result in the Contractor paying for all costs associated with replacing or relocating the disturbed outline survey monuments and geodetic control monuments. Survey monuments and geodetic control monuments. Survey monuments and geodetic control monuments at or adjacent to the Site, not in the line of the proposed construction that are damaged or disturbed by the Contractor shall be replaced or relocated by the City or their agent and all associated costs shall be paid for by the Contractor.
- E12.4 An approximate estimate of the cost to restore a legal survey monument is \$1,000 per bar and \$3,000 per control monument. Contractors shall ensure their landscaping and other subcontractors are aware of this clearance procedure and the potential restoration costs. Where possible, amounts owed to the City in accordance with the above will be deducted from payments to be made by the City to the Contractor.

#### E13. SITE ENCLOSURES

- E13.1 Temporary Site enclosures, as determined necessary at the pre-construction meeting, shall be erected and maintained as required for the duration of the construction period.
- E13.2 Site enclosures shall, at a minimum, consist of sectional 1.8m high, non-climbable metal fencing.
- E13.3 Site enclosures shall be considered incidental to the Contract Work.

#### E14. STAKES AND MARKS

- E14.1 The Contractor is responsible for the identification and staking of the property lines and the establishment of the layout of all Work. Key grade stakes shall be identified at the pre- construction meeting.
- E14.2 The Contract Administrator shall be advised of the staking of the layout and site grades at least twentyfour (24) hours in advance in order that the layout and site grades may be inspected and adjusted as required prior to construction.
- E14.3 The Contractor is responsible for the establishment and maintenance of the fixed bench mark, layout and grade stakes throughout the construction process.
- E14.4 The Contractor shall determine the meaning and correctness of the stakes and marks before starting the Work. If an error is suspected in the Drawings, Specifications or directions of the Contract Administrator, Work will be discontinued until the error is rectified. No claim will be made due to alleged inaccuracies in the stakes and marks and for delay in the Work to rectify an error.

#### E15. SHOP DRAWINGS

- E15.1 Further to CW 1110, the Contractor shall provide within fourteen (14) Calendar days of Award, at a minimum the following Shop Drawings:
  - (a) Play equipment and spray component plans, layouts, and details;
  - (b) Drawings/charts confirming the colours of play equipment, rubberized surfacing and spray components;

- (c) Water and sewer connections;
- (d) Spray pad layout and piping diagrams, including the vault and cabinet details;
- (e) Electrical drawings including connection to existing service and grounding of the spray components, fencing and any other required objects;
- (f) Anchoring drawings for the spray features; and
- (g) Picnic Shelter and helical piles.

## E16. SAMPLES

- E16.1 Samples called for in the Specification or requested by the Contract Administrator shall be submitted within fifteen (15) Calendar Days of request.
  - (a) Identify samples with name of project, date, name of Contractor, name of supplier/manufacturer and use of material represented by sample.
  - (b) Do not proceed with delivery of materials until samples are reviewed by the Contract Administrator. No deviation is permitted after approval of sample.
  - (c) Approval of samples does not imply acceptance of finished Work.
  - (d) Where required, submit a range of samples, as may be reasonable.

# E17. TEST REPORTS

- E17.1 Where required by the Contract Administrator, the Contractor shall provide certified copies of tests upon materials to be used in construction of the Work, indicating that the materials comply with the Specifications.
- E17.2 Submit test results to the Contract Administrator within ten (10) Calendar Days of request.
- E17.3 All testing costs shall be the responsibility of the Contractor.

# SITE DEVELOPMENT - GENERAL

#### E18. PROTECTION

- E18.1 The Contractor shall be responsible for protecting their Work until the Work has been completed and for protecting other surfaces during execution of Work in accordance with the Specifications.
- E18.2 Experience has shown that a security guard is required at all times during the critical concrete and rubberized surfacing curing stages to prevent trespassing onto the Site. Security fencing is not sufficient to prevent such trespassing.
- E18.3 Should the Work be suspended for any cause whatsoever, the Contractor shall assume all responsibility for proper protection during such period.

#### E19. DECOMMISSIONING OF WADING POOL AND REMOVALS

- E19.1 General description
  - (a) This specification shall cover the decommissioning and removal of the electrical, sewer and water connections for the wading pool.
  - (b) This specification and as shown on the drawings shall cover the removal of:
    - (i) the light fixtures, posts, and bases with decommissioning of existing electrical service to these fixtures. Light fixtures shall be given to the City of Winnipeg upon removal.
    - (ii) the bollards,
    - (iii) the east rink and shed and any electrical associated with the shed,
    - (iv) the playground equipment,
    - (v) the playground surfacing and edging,
    - (vi) the asphalt paths,

- (vii) the concrete wading pool and mechanical,
- (viii) the chain link fencing,
- (ix) the site furniture, and
- (x) the selected trees.
- (c) All items not slated for removal shall be protected during construction to the satisfaction of the Contract Administrator.
- (d) Work shall include all necessary permitting, inspections and approvals.
- E19.2 Existing Services
  - (a) All existing services, not identified for removal, shall be located and protected.
  - (b) The Contractor shall not commence the demolition Work until:
    - (i) he/she has contacted the City's Water and Waste Department, Water Billing, at 204- 986-2455 and arranged to have the water turned off and meter removed; and,
    - (ii) he/she has obtained the necessary Service Permits from the City's Public Works Department.
  - (c) The Contractor shall disconnect, cap, plug or divert as required existing water and sewer lines within the property as required for the execution of the Work, in conformity with the requirements of the authorities having jurisdiction.
    - (i) Immediately notify the Contract Administrator and utility company concerned in case of damage to any utility or service, designated to remain in place.
    - (ii) Immediately notify the Contract Administrator should unchartered utility or service be encountered, and await instruction in writing regarding remedial action.
- E19.3 Water and Sewer Services
  - (a) The existing pool mechanical system shall be removed.
  - (b) Pipes on site, once properly disconnected, shall be removed.
  - (c) Water service to the seasonal water service pit is to remain and be shut off.
  - (d) The existing sewer line service to the pool drain is to be abandoned and capped in accordance with CW 2130. Contractor to remove any portion of existing line if it conflicts with new service to the spray pad.
- E19.4 Removals Methods
  - (a) Equipment to be used for breaking up of concrete and removals shall be approved by the Contract Administrator.
  - (b) All concrete and asphalt shall be removed entirely. Base materials may be left in place to the satisfaction of the Contract Administrator if the area is to be used as a staging area for Contractor materials and equipment.
  - (c) All drains and other mechanical fixtures contained within the pool shall be removed.
  - (d) Play equipment, surfacing and edging, and chain link fencing shall be removed in their entirety, as indicated on Drawings. Any play equipment to be salvaged shall be at the coordination and direction of the Owner.
  - (e) Site furnishings to be removed in their entirety shall be identified at the start-up meeting.
  - (f) Selected light fixtures, posts and bases to be removed in their entirety as indicated on Drawings. Owner to confirm if light fixtures are to be salvaged for City use.
  - (g) All trees, as noted on the drawing, to be removed shall be removed in its entirety including root mass.
  - (h) Any buildings or structures to be removed are to be removed in its entirety including foundations.
  - (i) Any holes left by the removal of piles, posts or foundations shall be filled with compacted clean clay fill to meet the adjacent grades and be restored to match surrounding conditions to the satisfaction of the Contract Administrator. This shall be incidental to the Work.

- (j) Any holes left by the removal of posts or foundations shall be filled with compacted clean clay fill to meet the adjacent grades and be restored to match surrounding conditions to the satisfaction of the Contract Administrator. This shall be incidental to the Work.
- (k) All materials, to be salvaged, are to be coordinated at the direction of the Owner.
- (I) All materials, to be demolished and removed, are to be removed from the Site and disposed of in a safe and legal manner. Excavated materials shall be recycled or legally disposed of off-site.

## E19.5 Backfill

- (a) The demolished wading pool excavation shall be backfilled to depth required to construct the concrete spray pad using common material approved by the City of Winnipeg and compacted to achieve a minimum compaction of 95% Proctor Density.
- (b) The Contractor shall provide compaction tests of the subgrade prior to placement of granular base material.
- E19.6 Method of Measurement and Basis of Payment
- E19.6.1 Method of measurement shall be as follows:
  - (a) Removals will be measured on a lump sum basis for:
    - (i) "Removals and Modifications" on Form B: Prices.

## E19.6.2 Basis of Payment

(a) Removals will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.

## E20. SITE GRADING

- E20.1 General Description
  - (a) Further to CW 3170, this specification shall cover the Site grading, including:
    - (i) The cut and fill required to achieve the proposed Site grades.
    - (ii) The cut and fill required for the construction of the spray pad.

#### E20.2 Methods

- (a) The construction area is to be excavated or filled to achieve rough grade.
  - (i) Rough grade is to be to levels, profiles and contours allowing for surface treatment as indicated on Drawings.
- (b) Wherever the proposed Site grading is to meet existing Site grades, the grades are to match and positive Site drainage is to be maintained. Where sloped areas meet flat areas, at both top and bottom of slopes, the transition shall be rounded to the extent that future maintenance by turf mowing equipment can be easily done.
- (c) In fill areas around the proposed spray pad, the Contractor shall scarify the existing ground to a minimum depth of 150mm prior to the placement of any fill. Should imported clean fill be required, it shall be considered incidental to the Work.
  - (i) Compaction shall include the use of sheep's foot or other suitable compaction equipment as approved by the Contractor to achieve a minimum compaction of 95% Proctor Density.
  - (ii) The Contractor shall provide compaction tests of the subgrade prior to placement of granular base material.
- (d) In fill areas for proposed berms, the Contractor shall scarify the existing ground to a minimum depth of 150mm prior to the placement of any fill. The Contractor shall use approved stockpiled granular base course to construct the core of the berm in addition to approved material excavated for stormwater management / proposed ponding area.
  - (i) Granular shall be placed in 150mm lifts and compacted to a minimum 98% Proctor Density.
  - (ii) Granular base course shall be covered with a minimum 300mm depth of clean fill and compacted in 100mm lifts to achieve a minim compaction of 95% Proctor Density

- (iii) Berms shall be graded to be 100mm below proposed finished grade to allow for placement of topsoil and sod.
- (e) All surplus or unsuitable materials shall be disposed of off Site in a legal manner and as directed by the Contractor.
- (f) Following rough grading and compaction, the Work area shall be fine graded to provide a maximum deviation of 25mm in 10m from the design grade with no low areas to hold water. The finished surface of all disturbed areas shall be dragged smooth in such a manner that there are no loose soil particles greater than 25mm in maximum dimensions.
- E20.3 Method of Measurement and Basis of Payment
- E20.3.1 Method of measurement shall be as follows:
  - (a) Payment for Work, specified under this section, other than for the construction of the proposed berms, shall be incidental to the other Items of Work and no separate payment will be made for Site Grading.
  - (b) Proposed Berms will be measured on a cubic meter basis:
    - (i) "Proposed Berms" on Form B: Prices.
- E20.3.2 Basis of Payment
  - (a) Payment for proposed berms shall be paid out for the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.

## E21. STORMWATER MANAGEMENT AND SITE DRAINAGE

- E21.1 General Description
  - (a) Further to CW 2130, this specification and as shown on the drawings shall cover the supply and installation of stormwater catch basins.
- E21.2 Associated Work
  - (a) Site Grading
  - (b) Concrete Spray Pad
  - (c) Sub-Surface Drainage (play areas)
  - (d) Topsoil and Sodding
- E21.3 Materials
  - (a) Standard Pre-Cast Concrete Catch Basin c/w Outlet Restrictor as per SD-025B complete with standard frame and grated cover.
  - (b) Sewer Service Connection As per SD-014.
    - (i) Drainpipe and all associated fittings as specified on drawings
- E21.4 Methods
  - (a) Supply and Install catch basins and drain lines in accordance with CW 2030 and CW 2130 and SD-014.
  - (b) All pipe installations through roads or paved surfaces shall be completed with trenchless methods. Any open trench constructions on site shall be as follows:
    - (i) Class 'B' Bedding to SD-001
    - (ii) Backfill to SD-002: Class '2" in gravel, hard-surfaces and traveled areas; Class'4' or '5' in landscaped and untraveled areas.
  - (c) Upon completion of sub-grade work, Contractor shall arrange an inspection by the City of Winnipeg and Civil Engineer prior to backfilling.
    - (i) Upon acceptance of work, the Contractor, shall complete work and restore surfacing (sod or asphalt) to City of Winnipeg Standards.

- E21.5 Method of Measurement and Basis of Payment
- E21.5.1 Method of measurement shall be as follows:
  - (a) Site Catch Basin will be measured on a lump sum basis:
    - (i) "Supply and Install Stormwater Catch Basin" on Form B: Prices
  - (b) Sub-Grade Drainpipe will be measured on a per linear meter basis:
    - (i) "Supply and Install Sub-Grade Drainpipe" on Form B:Prices

# E21.5.2 Basis of Payment

(a) Stormwater Management and Site Drainage will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. Surfacing restoration is considered incidental to the scope of work and no additional payment will be issued. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.

# E22. CONCRETE WALKWAYS

- E22.1 General Description
  - (a) Further to CW 3110 and CW 3310, this specification shall cover the supply and installation Concrete Walkways including excavation, base construction, and concrete paving.
- E22.2 Associated Work
  - (a) Granular Base for Rubberized Protective Surfacing for the Playground.
  - (b) Concrete Spray Pad.
  - (c) The Concrete Walkways may be divided into separate pours to suit the scheduling of the playground and spray pad Work, in consultation with the Contract Administrator.
- E22.3 Layout and Grading
  - (a) The sitting areas and pathways around the perimeter of the spray pad are to be located outside of the overspray zone and are to drain away from the spray pad.

  - (ii) Concrete Walkways as shown on the Drawings, with thickened edge where it meets the Concrete Spray Pad.
  - (iii) Light broom finish with a slip resistant surface. Contractor to have sample of concrete finish approved by Contract Administrator prior to any concrete being poured.

- (iv) Saw cut locations are to be reviewed by the Contract Administrator prior to implementation.
- E22.6 Method of Measurement and Basis of Payment

  - (a) Picnic Shelter will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.

# E27. PLANTING BEDS

- E27.1 General Description
  - (a) This specification shall cover all work associated with the construction of planting beds as indicated on the Drawings.
- E27.2 Reference
  - (a) CW 3170 Earthwork and Grading
  - (b) CW 3540 Topsoil and Finish Grading
  - (c) Tree & Shrub Planting in E28
- E27.3 Materials
  - (a) Planting Soil
    - Screened, clay-textured or loam-textured dark topsoil, containing by volume, a minimum of four (4%) percent for clay loams and two (2%) percent for sandy loams to a maximum twenty-five (25%) percent organic matter (peat, rotted manure or composted material), capable of sustaining vigorous plant growth.
    - (ii) Free of subsoil contamination, roots, stones over 25mm in diameter, baler twine or subsoil clay lumps over 25mm in diameter and other extraneous matter.
    - (iii) Containing no quackgrass rhizomes, Canada thistle roots or other noxious weeds.
    - (iv) Upon delivery or thirty (30) days following delivery, salinity rating shall be less than 4.0mm hos/cm on a saturated paste basis. The pH range shall be between 6.0 and 8.0.

- (b) Wood Mulch: locally produced, uncoloured wood chip mulch free of stones, soil, bark, twigs, roots, sawdust or other deleterious material or pieces larger than 4"
  - (i) In the situation that the Planting Bed is directly adjacent to a Play Area with Engineered Wood Fibre Safety Surfacing, the Wood Mulch is to be substituted for Engineered Wood Fibre Surfacing to the same depth as indicated on the Drawings.
- (c) Water to be potable and free of minerals which may be detrimental to plant growth.

## E27.4 Execution

- (a) Excavation
  - (i) Locate, mark and protect all underground utilities prior to commencement of excavation.
  - (ii) Mark and review layout of beds with Contract Administrator prior to excavation.
  - (iii) Excavated to the finished depth shown on Drawings. Protect base of excavation from freezing.
  - (iv) Remove water which enters excavations prior to planting. In the case that water is found to be ground water, cease planting activities and notify Contract Administrator.
  - (v) Prior to placing topsoil scarify subsurface to depth of 150mm minimum.
- (b) Planting Beds
  - (i) Fill excavated planting beds and raised planting areas with planting soil in 150mm lifts, lightly compact after each lift. After filling, top of bed shall be level with surrounding grade. Soil should be firmly compacted and indicated soil depths shall be depths after light compaction.
  - (ii) Provide a planting bed with a crisp spade edge or as indicated on Drawings.
  - (iii) Install landscape fabric only in areas indicated on Drawings. Fabric shall be adequately overlapped and pinned, no fabric shall be visible upon installation of mulch.
- (c) Tree Pits
  - (i) Tree Pit depth shall be such that the top of the root ball is even with the existing grade, taking into account that proper planting depth requires the root flare to be slightly above the finished grade.
  - (ii) Bottom of excavation shall be scarified to a depth as indicated on the Drawings.
  - (iii) Install tree and fill pit as indicated in E28 "Tree, Shrub and Perennial Planting".
- (d) Topping
  - (i) Hand spread Topping to a consistent depth over entire planting bed area.
  - (ii) Topping type and depth to be as indicated on the Drawings.
  - (iii) No Topping shall be placed within 75mm (3in.) of the trunks of trees.
  - (iv) Care shall be taken when installing Topping not to cover or damage plants.
- E27.5 Method of Measurement and Basis of Payment
- E27.5.1 Method of Measurement shall be as follows:
  - (a) Planting Beds will be measured on a square metre basis for:
    - (i) "Supply & Install of Planting Beds" on Form B: Prices.
- E27.5.2 Basis of Payment
  - (a) Planting Beds will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.

#### E28. TREE, SHRUB & PERENNIAL PLANTING

- E28.1 General Description
  - (a) The Work to be done by the Contractor under this Specification shall include the furnishing of all superintendence, overhead, labour, materials, equipment, tools, supplies and all other things necessary for and incidental to the satisfactory performance and completion of all Work as shown

on the Drawings and as hereinafter specified, including, but not necessarily confined to the following:

(i) Supply and installation of trees, shrubs and perennials, as listed in this specification and indicated on the drawings.

## E28.2 Reference

- (a) Supply plants in accordance with the Canadian Nursery Stock Standards Current Edition, published by the Canadian Nursery Landscape Association, except where specified otherwise.
- E28.3 Source Quality Control
  - (a) All plant material shall be randomly inspected at the source upon request of the Contract Administrator.
  - (b) Plants are to be grown in nurseries in accordance with the Canadian Nursery Stock Standard Current Edition, published by the Canadian Nursery Landscape Association.
  - (c) Only those plants that have been grown for at least the four (4) previous years in local Manitoba nurseries located in an Agriculture Canada Plant Hardiness Zone designation of 2(a or b) or 3(a or b) and within a 250-kilometre radius of Winnipeg, will be accepted. Trees that have been grown in plant hardiness zones 1 and 4 or greater will be rejected.

## E28.4 Maintenance

- (a) The Contractor shall be responsible for the maintenance of the plants for a period of two (2) year from the date of Total Performance. Any areas planted after September 15th, the maintenance period will commence on May 15<sup>th</sup> of the following year or such date as mutually agreed upon by all parties.
- (b) All newly plantings shall be watered on a weekly basis between spring (May 15<sup>th</sup>) continuing through to early fall (October 15<sup>th</sup>), for the first year and two-year maintenance period thereafter to keep the soil in and around the root ball moist. With the Contract Administrator's or designate's approval, adjustments may be made in watering frequency depending on soil type, weather, drainage, tree species, and weekly amounts of rainfall.
- (c) Ensure watering techniques do not cause erosion.
- (d) Turf and weed growth shall be removed from in and around planting site bi-monthly throughout the two-year maintenance and warranty period.
- (e) Wood chips or other approved mulch shall be topped up as required.
- (f) Reform damaged watering saucers.
- (g) If required to control insects, fungus and disease, use appropriate control methods in accordance with Federal, Provincial and Municipal regulations. Obtain product approval from Contract Administrator prior to application.
- (h) Remove dead, broken or hazardous branches from plant material.
- (i) Keep trunk protection and tree supports in proper repair and adjustment.
- (j) Remove trunk protection, tree supports and level watering saucers at end of warranty period.
- (k) Remove and replace dead plants and plants not in healthy growing condition. Make replacements in same manner as specified for original plantings.
- (I) Submit monthly written reports to Contract Administrator identifying:
  - (i) Maintenance work carried out.
  - (ii) Development and condition of plant material.
  - (iii) Preventative or corrective measures required which are outside Contractor's responsibility.

# E28.5 Warranty

(a) The Contractor shall, at his/her expense, warrant the Work against any and all defects or deficiencies resulting from insect infestation, disease and mechanical damage due to improper handling, installation or maintenance, for a period of two (2) years from the date of the Total Performance. Nursery stock damaged by vandalism or reasons beyond the control of the Contractor shall be replaced by the client.

- (b) End-of-Warranty inspection will be conducted by the Contract Administrator.
- (c) The Contract Administrator reserves the right to request material replacement or extend the Contractor's Maintenance responsibilities for an additional one (1) year if, at the end of the Warranty Period, leaf development and growth are not sufficient to ensure future survival of the plant material.
- E28.6 Replacements
  - (a) During the Maintenance Period, the Contractor shall remove from Site any plant material that has died or failed to grow satisfactorily as determined by the Contract Administrator and replace as per Specifications within a maximum ten (10) day period from notification.
  - (b) Defective plants shall be replaced within three (3) Business Days' of notification to the Contractor.
  - (c) The Contractor shall extend Maintenance and Warranty on replacement tree for a period equal to the original Maintenance and Warranty Periods.
  - (d) The Contractor shall continue such replacement, Maintenance and Warranty until tree is acceptable.

# E28.7 Materials

- (a) Miscellaneous Materials
  - (i) Water shall be potable and free of minerals which may be detrimental to plant growth.
  - (ii) Stakes shall be metal T-Bar, steel, 40x40x5x2440mm.
  - (iii) ArborTie flat woven polyester guying.
  - (iv) Trunk Protection shall be plastic perforated spiral strip.
  - (v) Armoured Trunk Protection shall be 50 x 50mm gridded, #16-gauge welded stucco wire mesh.
- (b) Plant Material
  - (i) All nursery stock supplied shall be Canadian Prairie nursery grown, and of species and sizes indicated in the plant list on the drawings. Its quality shall be in accordance with the "Canadian Nursery Stock Standards of the Canadian Nursery Landscape Association".
  - (ii) Nomenclature of specified plants is to conform to the International Code of Nomenclature for Cultivated Plants and is to be in accordance with he approved scientific names given in the latest edition of the Standardized Plant Names.
  - (iii) Plants are to be characteristically developed for their species and structurally sound, wellbranches, healthy and vigorous and densely foliated when in leaf. The tree is to have a health, well developed, fibrous root system which may be verified through a testing procedure that destructively samples one or more randomly selected root balls.
  - (iv) Any nursery stock dug from native stands, wood lots, orchards, or neglected nurseries and which do not meet the Canadian Nursery Stock Standard of the Canadian Nursery Landscape Association shall be designated as "collected plants". The use of "collected plants" will not be permitted unless specified below.
  - (v) Plants larger than specified may be used if approved by the Contract Administrator. The use of such plants shall not increase the Contract price.
  - (vi) Plants shall be free of disease, insect infestation, rodent damage, or environmental stress.
- (c) Tree Quantity and Size
  - (i) Trees are to be planted at the quantities and caliper listed on the Plant Lists which are shown on the drawings. Any variation from the specified quantity is to be clearly identified on the Schedule of Prices. Any variations to species, size or caliper of specified trees will require a request for approval from the Contract Administrator.
  - (ii) Any changes in planting locations will be determined on-site by the Contract Administrator.
  - (iii) The Contractor shall supply trees as indicated in the Schedule of Prices and Plant Lists.
  - (iv) Trees are to conform to the measurements specified on the drawings and Plant Lists, except that trees larger than specified may be used if approved by the Contract Administrator.
- (d) Shipment and Pre-Planting Care

- (i) Coordinate shipping of trees and excavation of holes to ensure minimum time lapse between digging and planting.
- (ii) Protect trees against branch breakage, abrasion and other mechanical damage, exposure and extreme temperature change during transit. Avoid binding of trees with rope or wire which would damage bark, break branches or destroy natural shape of tree. Give full support to root ball of trees during lifting.
- (iii) Cover tree foliage with tarpaulin, and protect bare roots by means of dampened straw, peat moss, saw dust or other acceptable material to prevent loss of moisture during transit and storage.
- (iv) Remove broken and damaged roots with sharp, sterile pruning shears to make clean cuts. Pruning shears to be sterilized between uses.
- (v) Keep roots moist and protected from sun and wind. Heel-in trees which cannot be planted immediately in shaded areas and water well to prevent drying out of root system.

# E28.8 Construction Methods

- (a) Workmanship
  - (i) All areas and locations provided for planting shall be staked out or painted on Site by the Contractor according to layout shown on the Drawings. Excavation shall not proceed until the layout has been inspected and approved by the Contract Administrator. Excavation shall be undertaken until all underground utilities have been located and protected.
  - (ii) Coordinate operations. Keep Site clean and planting holes drained. Immediately remove soil or debris spilled onto street pavement, grass or sidewalk.
- (b) Planting Time
  - (i) Trees noted for spring planting only, must be planted in dormant period.
  - (ii) Plant only under conditions that are conducive to health and physical conditions of trees.
  - (iii) Provide planting schedule to Contract Administrator. Extending planting operations over long period using limited crew will not be accepted.
  - (iv) The Contractor must obtain all above and below ground clearances from all the utilities as well as the appropriate District Operations Branch in a timely manner so as not to jeopardize the schedule of the complete tree planting Contract.
- (c) Excavation
  - (i) Tree Pit and Tree Trenches to be dug with back hoe.
  - (ii) Excavate tree pits and trenches in accordance to layout and dimensions shown on the Drawings.
  - (iii) Protect bottom of excavations against freezing.
  - (iv) Remove water which enters excavations prior to planting. Ensure source of water is not ground water and notify Contract Administrator if standing water persists past removal.
  - (v) Tree pit and trench depth shall be such that the top of the root ball is even with the existing grade, and the root flare to be at or slightly above the finished grade. Determine how deep the root flare is in the root ball before excavation or before the tree is placed in the planting hole. If necessary, at installation, raise the top of the root ball until the root flare is at the proper planting depth through the addition of a topsoil atop the scarified layer.
  - (vi) Upon excavation of the planting bed, the excavation shall be backfilled with a topsoil mixture to a depth to permit adequate installation and stabilization of the plant material. Topsoil shall be placed in accordance with City of Winnipeg Standard Construction Specifications CW3540 to a 300mm depth
- (d) Installation
  - (i) All nursery stock shall be set plumb in the centre of pits and at levels as shown on the planting details after settlement has taken place.
  - (ii) Nursery stock shall be faced to give the best appearance or relationship to adjacent structure and to the approval of the City of Winnipeg representative.
  - (iii) Each tree must be planted such that the trunk flare is visible at the top of the root ball. Trees where the trunk flare is not visible shall be considered a deficiency and payment for the planting will not be received until the deficiency is addressed. Do not cover the top of the root ball with soil.

- (iv) Planting shall be done during periods of suitable weather conditions and in accordance with locally accepted practice.
- (v) No tree pit is to be left open at the end of the Contractor's Work Day. Planting program is to be planned to ensure that all approved trees delivered to the Site at designated planting locations are installed and thoroughly watered the same day as delivery.
- (vi) With balled and burlapped root balls and root balls in wire baskets, burlap shall be loosened and cut away from the top 1/3 without disturbing root ball. Wire shall be cut away and removed from the top 1/3 of the root ball. Burlap or rope shall not be pulled from under root ball. All twine and non-biodegradable wrapping shall be removed.
- (vii) Backfill with topsoil and gently tamp soil around the root ball. Thoroughly water the root ball and planting pit.
- (viii) Each tree is to have an earth saucer at its base having a diameter as large as the excavation with a berm no greater than 10cm in height and width formed at the perimeter of the saucer to retain water.
- (ix) Install tree trunk protection around the base of each tree trunk. Armoured protection only to be installed on trees between Kingston Row and the Red River.
- (x) Install wood chips or other approved mulch.
  - Mulch shall be a clean bark or wood chip free of leaves, branches and other extraneous matter.
  - Mulch shall consist of chips not less than fifteen (15) mm nor larger than seventy-five (75) mm in size and not more than twenty (20) mm thick.
  - Mulch shall be to the depth of no more than fifty (50mm) or two (2") inches to one hundred (75mm) or three (3") inches and must not be placed within eight (10cm) or three (4") inches of the trunks of trees.
- (xi) Apply water to area around planting hole immediately after planting.
- (xii) Install stakes and straps (do not use wire in garden hose) as necessary, or as directed by Contract Administrator or designate.
- (e) Pruning
  - (i) The Contractor shall provide a qualified arborist for each work crew or work site in accordance with the Forest Health Protection Act and Arborist Regulations for each work crew or work site.
  - (ii) Remove dead, broken and injured branches. All pruning will be done in accordance with the most current edition of the American National Standards Institute (ANSI) A300 and the most current edition of the companion publication "Best Management Practices – Tree Pruning". Pruning shears to be sterilized between uses.
  - (iii) No Pruning work is permitted on elm trees for the period April 1<sup>st</sup> to July 31<sup>st</sup> as directed in the Manitoba Forest Health Protection Act and Regulations unless deemed a safety hazard by the Contract Administrator.
- (f) Watering
  - (i) Trees are to be watered during the planting procedure as described previously, and once a week thereafter, or more frequently if required, between spring (May 15) and early fall (October 15) as described previously in Maintenance. With the Contract Administrator's or designate's approval, adjustments may be made in watering frequency depending on soil type, weather, drainage, tree species, and weekly amounts of rainfall.
  - (ii) A complete record is to be kept of each series of waterings for all planted trees noting: 1) location, and 2) date of watering. This record shall be sent bi-weekly to the Contract Administrator.
  - (iii) The area in and around the planting site shall be watered to allow enough time for the water to penetrate the soil to a depth of 15 to 30cm.
  - (iv) Watering must be done slowly to ensure that water does not run away from the root zone and so the top 30cm of the soil around the root system of the tree are well saturated. The water stream must not gouge out a hole in the soil or mulch.
  - (v) The Contractor shall provide a water supply, all costs to provide water for the watering operation and all associated costs shall be borne by the Contractor. These costs may include hydrant permit and meter rental fees.

- (vi) Water shall be free of oils, acids, alkalis, salts and other substances that may be detrimental to plant growth. Water suitable for human consumption shall be acceptable without testing.
- (vii) Water from rivers and streams shall not be used without prior approval of the Contract Administrator.
- (viii) Should the Contract Administrator determine that water quality testing is necessary, an approved testing laboratory shall perform the test at the sole expense of the Contractor.
- E28.9 Method of Measurement and Basis of Payment
- E28.9.1 Method of Measurement shall be as follows:
  - (a) Tree & shrub planting will be measured on a per unit basis for:
    - (i) "Supply & Install of Tree Planting",
    - (ii) "Supply & Install of Shrub Planting", and
    - (iii) "Supply & Install of Perennial Planting" on Form B: Prices.

## E28.9.2 Basis of Payment

(a) Tree, Shrub & Perennial Planting will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.

## E29. TOPSOIL AND SODDING

- E29.1 General Description
  - (a) This specification shall cover the site preparation and the supply and installation of topsoil and sod.

#### E29.2 Materials

- (a) Topsoil: As per CW 3540.
- (b) Sodding:
  - (i) As per CW 3510.
  - (ii) Sod shall be mineral base.
- (c) Organic based 3-4-3 starter fertilizer.

#### E29.3 Methods

- (a) Areas to be sodded shall be excavated and/or filled with clean fill and graded to meet the grades required for the installation of topsoil and sod and as shown on the Drawings. Surplus materials shall be removed off-site in a legal manner.
- (b) Topsoil shall be installed to a minimum of 75mm compacted depth.
- (c) Fertilizer Rate: applied at manufacturer's stated rates to topsoil prior to sodding. Bag tags to be supplied to the Contract Administrator.
- (d) No area for Sodding shall be less than the width of a full piece of sod.
- (e) Where Sodding meets existing turf, the edges are to be cut neatly in straight lines using a sod cutter and new sod is to be installed to match the existing grades of the surrounding turf.
- (f) Seams between new and old turf are to be topdressed, seeded and rolled.
- E29.4 Maintenance Period
  - (a) The Contractor shall maintain the sod for thirty (30) Calendar Days after the completion of the installation or until such a time as the turf is established in accordance with CW 3510.
- E29.5 Method of Measurement and Basis of Payment
- E29.5.1 Method of Measurement shall be as follows:
  - (a) Topsoil and sodding will be measured on a square metre basis for:

(i) "Supply & Install of Sod" on Form B: Prices

# E29.5.2 Basis of Payment

- (a) Topsoil and sodding will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.
- (b) Payment under this section shall be in accordance with the following:
  - (i) Seventy-five percent (75%) following the supply and installation of the topsoil and sod.
  - (ii) Twenty-five percent (25%) following termination of the maintenance period.

# E30. SITE CLEAN UP

- E30.1 The Contractor shall, upon the completion of Work each day, load and dispose of all spoiled concrete, reinforcing steel, granular and other material associated with the Works from the Work Site. The Contractor shall secure or remove all of his machinery and equipment at the end of each day from the immediate Work Site. The Contractor will not be permitted to store machinery, equipment, or materials on public roads overnight. Any costs in connection with the above mentioned works are incidental.
- E30.2 Unless otherwise specified the Contractor shall restore all areas which have been disturbed by his operations to as good as or better than original condition including removal of all construction debris, repair all vegetation, sod, concrete pavement, concrete curbs, concrete sidewalk and asphalt paving to remain etc. to the satisfaction of the Contract Administrator. Any costs incurred in connection with the above mentioned Work are incidental to unit prices bid under this Contract.
- E30.3 Total Performance of the Work shall not be attained until the Contractor has cleaned up the Site and has removed all tools, equipment, waste, debris and surplus foundation earth to the satisfaction of the Contract Administrator. Unless otherwise specified, the Contractor shall restore all areas of the Site beyond the established limit of Work, which have been disturbed by the Contractor's operations to as good as or better than the original condition to the satisfaction of the Contract Administrator. The Contractor shall pay all costs associated with this Work.
- E30.4 Sod and Topsoil (repair to damaged areas). The Contractor shall install mineral sod and a minimum 75mm compacted thickness of topsoil, as required, and in accordance with the most recent versions of CW 3510 and CW 3540.

# SITE DEVELOPMENT - PLAYGROUND

# E31. SUB-SURFACE DRAINAGE

- E31.1 General Description
  - (a) This specification shall cover the supply and installation of a geocomposite prefabricated drain system and/or a perforated HDPE drainage pipe to take water out of the engineered wood fibre play area and to an emitter as, shown on the Drawings.
    - (i) This drainage system is in addition to any sub-surface drainage called for by the manufacturer of the engineered wood fibre play protective surfacing.
    - (ii) Work shall be executed as per CW 3120, CW 3130, SCD-650, and SCD-661.
- E31.2 Materials
  - (a) Drainage Pipe may be either:
    - (i) 150mm Multi-Flow Drain System or approved substitute in accordance with B7. Size shall be 150mm as shown on Drawings. All fittings shall be sized to fit and approved for use with Multi-Flow or approved substitute by the manufacturer.
      - Manufacturer: Varicore Technologies, <u>http://www.multi-flow.com</u>
    - (ii) "Goldline" 100mm Ø high density polyethylene (HDPE) perforated drainage pipe, complete with fittings and polyester sock, or approved substitute in accordance with B7.
      - Manufacturer: Prinsco Water Management Solutions, <u>http://www.prinsco.com</u>

# (b) Fittings

- (i) The fittings used with the drainage system shall be of a snap together design. In no case shall any product be joined without the use of the manufacturer's connector designed specifically for the purpose.
- (c) Outlet Pipe
  - (i) Pipe for drain outlets shall be 100mm (4") high density polyethylene pipe meeting the requirements of AASHTO M252.2.4.
  - (ii) A rodent screen made of 7.6 mm by 7.6 mm square opening size, 1.6 mm gauge, stainless steel or galvanized welded mesh shall be installed in each outlet line. When using galvanized welded wire mesh, the rodent screen shall be galvanized after it has been formed to the shape and dimensions required.
- (d) Emitter
  - (i) Shall be a 75mm (3") polyolefin pop-up drainage emitter with elbow joint, product reference no. NDS# 620 or approved substitute in accordance with B7. Drain pipe shall be connected to emitter by using manufacturer's adaptor for connecting drainage pipe to 75mm round orifice on appropriate hardware.
  - (ii) Contact for Emitter:
    - Consolidated Turf 986 Powell Avenue Winnipeg, Manitoba R3H 0H6 Tel: 1-204-633-72276
- (e) Granular Backfill
  - (i) Backfill for the trenches shall be as per SCD-661.
- (f) Geotextile Fabric
  - (i) Non-woven, to CW 3130.

# E31.3 Methods

- (a) The Work shall be as per Drawings.
- (b) The layout of the sub-drain and proposed elevations are to be marked on Site and reviewed by the Contract Administrator. The multi-flow pipe may be installed vertically or horizontally as required by the grades.
- (c) The layout of the sub-drain is to be coordinated with the layout of the play equipment so that there is no conflict between the sub-drain and the post holes.
- (d) Sub-drain is to be installed on the prepared subgrade surface to facilitate cross movement of water. Sub-drain shall be installed below geotextile and as shown on the Drawings.
  - (i) Play area is to be graded to drain towards the sub-drain. This sub-drain is to be used in conjunction with the appropriate wood fibre drainage system to bring water out of the play area.
  - (ii) The geotextile shall be considered incidental to sub-drain system and the Wood Fibre Protective Surfacing.
- (e) Trenches are to be excavated with a trenching machine or by hand. Locations, where the trench crosses existing utilities, irrigation pipes and all other sub-surface pipes or fixtures, are to be excavated by hand. The amount of trench excavated at any time shall not exceed the amount of drain that can be set and backfilled completely prior to the end of that Working Day. Trench width shall be as specified on the Drawings.
- (f) The bottom surface of the trench is to be free of loose particles and is to have the slope shown on the Drawings. Over excavation in the bottom of the trench shall be backfilled to the proper grade with the excavated material or sand prior to the placement of the drain. Where sand or excavated material is used to fill the trench to the proper elevation that material shall be compacted to 95% of standard proctor density using appropriate means. Where the trench is to pass through an area of existing turf, the excavated material is not to remain on the grassed surface for a period of longer than 24 hours. All excavated material shall be removed from the Site daily and disposed of legally.
- (g) Trenches are to be inspected by the Contract Administrator prior to backfilling.

- (h) Drain pipe is to be placed in the trench and the trench is to be backfilled according to detail Drawings. Backfill is to be lightly tamped into place to eliminate any voids.
- (i) Fittings for the drain shall be installed in accordance with manufacturer's recommendations.
- (j) Contractor is to protect the subdrain from excessive weight during the duration of construction. Any damaged drain system shall be replaced or repaired by splicing in an undamaged section of like material at the Contractor's expense.
- (k) Drainage layer required as part of the protective surfacing installation shall be considered incidental to the Wood Fibre Protective Surfacing.
- (I) The Contractor shall be responsible for restoration of any surfaces damaged during the Work under this section.
- E31.4 Basis of Payment
  - (a) Payment for Work, specified under this section, shall be incidental to the other Items of Work and no separate payment will be made for Sub-surface Drainage.

## E32. CONCRETE CURB

- E32.1 General Description
  - (a) Further to CW 3110 and CW 3310, this specification shall cover the supply and installation Concrete Curb including excavation, base construction, and placement of concrete.

## E32.2 Reference

- (a) Work to follow:
  - (i) CW 3110 Base Course Construction
  - (ii) CW 3310 Concrete Pavement Works
  - (iii) SCD-643 Concrete Playsurface Edging

#### E32.3 Materials

- (a) Base material to CW 3110:
  - (i) 19mm down crushed stone to depth shown on the Drawings.
- (b) All concrete Work to CW 3310 and as specified on the Drawings.
  - (i) Epoxy coated rebar sized as per Drawings.

#### E32.4 Methods

- (a) Further to E20 and CW 3170, the construction area is to be excavated or filled to achieve rough grade.
  - (i) Rough grade is to be to levels, profiles and contours allowing for surface treatments.
- (b) Excavated materials are to be removed as per E20.2(e)
- (c) Compacted granular base:

  - (ii) Granular base and formwork are to be reviewed on Site by the Contract Administrator prior to pouring concrete.

  - (iii) Ensure top of curb to be flushed with finished grade of adjacent concrete walkways and sod.

  - (b) If substitute to Zeagar Woodcarpet or Fibar FibarSystem 200 or 300 is proposed, it must meet the following conditions:
    - (i) Materials must be IPEMA certified Engineered Wood Fiber.
    - (ii) Material must consist of random-sized, clean, engineered hardwood chips. Standard wood chips or bark mulch are not acceptable.
    - (iii) Materials must meet or exceed ASTM F1292 standards for impact attenuation.
    - (iv) Materials must be certified by the CSA and approved for playground use.
    - (v) Materials must comply with ASTM F1951 for accessibility under the Canadians with Disabilities Act

  - (d) Wood Fibre surfacing shall be supplied by an authorized distributor and delivery slips are to be submitted to the Contract Administrator prior to installation.
- E33.4 Methods
  - (a) Sub grade preparation shall be inspected by the Contract Administrator prior to installation of protective surfacing.

- (b) Granular drainage layer shall be installed to 100mm depth. Geotextile fabric shall be installed to separate materials as shown on Drawings.
- (c) Sub-surface drainage Work specified in E31 shall be coordinated with the safety surfacing drainage system to create a total working system.
- (d) Wood Fibre shall be installed within the play area, as defined by the timber edging to a minimum depth of 300 mm (after compaction). The depth of material is to directly correspond to maximum fall height of play equipment in accordance with manufacturer's specifications and based on the most recent CSA safety requirements.
- (e) The installation of the Wood Fibre shall be done immediately after the play equipment has been installed.
- (f) Installation of entire system, including fibre, geotextile fabric, subsurface drainage and mats shall be done according manufacturer's instructions. Adequate drainage within play equipment area must be ensured as per same.
- (g) Geotextile fabric must be cut and fit around playground equipment footings and overlap seams by 300mm.
- (h) The mats are to be installed directly on top of the geotextile fabric and secured in place with two

- (i) Installation shall be done by equipment sized to suit the Work being done and the Wood Fibre shall be spread by hand as necessary in the immediate vicinity of the play equipment so as not to damage same. The play equipment shall be swept clean to the satisfaction of the Contract Administrator after installation of the Wood Fibre.

- E34.4 Methods
  - (a) The subgrade shall be prepared, including the removal and disposal of silt, organics, and unsuitable materials, as per CW 3170.

- (i) The subgrade shall be filled as required with suitable native clay compacted in 150mm layers to 95% SPD.
- (ii) Geotextile shall be installed under the granular to CW 3130.
- (b) The Contractor shall provide compaction tests of the granular base materials.
- (c) Base for Rubberized Surfacing

  - (h) Freeze/thaw: no change after 30 days at minus 50 in a 24 hour period
- E35.4 Materials

- (e) The temperature must be above 5 degrees C for the entire period of the installation. Humidity must be monitored as well as moisture to ensure proper bonding and cure times.
- (f) Rubber Base
  - (i) Base mat thickness to vary depending on the fall height compliance required.
  - (ii) Depth of material to directly correspond to maximum fall height of play equipment in accordance with manufacturer's specifications and based on the most recent CSA safety requirements.
  - (iii) The crumb rubber/resin base layer shall be mixed to manufacturer's specifications.
  - (iv) Base is to fully cure as per manufacturer's specifications.
- (g) EPDM Top Coats
  - (i) Rubberized layer to be spread over the entire base layer to 38 mm thickness
  - (ii) Top Layer to be spread and troweled out to 12.7 mm Thickness
- (h) The play equipment and concrete paving shall be kept clean to the satisfaction of the Contract Administrator.

# E36. CONCRETE FOUNDATIONS

- E36.1 General Description
- E36.1.1 This Specification shall supplement CW 2160 and cover the supply and installation of cast- inplace concrete foundations for Site Furnishings, Play Equipment, and Swing Sets.
  - (a) All underground cast-in-place concrete foundations for Site Furnishings, Play Equipment, and Swing Set posts, bases and anchors are to be set in concrete footings or piles per CW 2160 to ensure stability and prevent frost heaving.
- E36.1.2 The Work to be completed by the Contractor under this Specification shall include the supply of all materials, and the furnishings of all superintendence, overhead, labour, equipment, tools, and all other things necessary for and incidental to the satisfactory completion of all the Work shown on the Drawings and specified herein.
- E36.2 General Instructions
- E36.2.1 Quality Control
  - (a) Testing and Approval of Materials
    - (i) Material testing may be required as per this Specification and as directed by the Contract Administrator.

## E36.3 Materials

- E36.3.1 All materials as per CW 2160.
  - (a) Concrete
    - (i) Maximum Size of aggregate: 20 mm, nominal;
    - (ii) Compression Strength: 28 day compressive strength of 30 Mpa;
    - (iii) Slump/Flow: 80 +/- 20mm;
    - (iv) Sulphate resistant, Type 50 Cement; and
    - (v) Maximum water/cement ratio: 0.49.
    - (vi) Air Content: 4-7%
- E36.4 Construction Methods
- E36.4.1 Construction Methods as per CW 2160.
  - (a) If concrete testing is required, do not place concrete until material testing is performed and reviewed by Contract Administrator.
  - (b) All concrete foundations for site furnishings as per the Drawings.
- E36.4.2 Playground Equipment Footing
  - (a) Holes for concrete footing for play equipment and swings must be inspected and approved by the Contract Administrator prior to installation of concrete. Contractor to provide min. two (2) Business Days' notice for inspection.
  - (b) All concrete footings for play equipment and swing sets shall be in accordance with Manufacturer's specifications. Proponents are to include drawings showing Manufacturer's Footing Specification in their Bid Submission.
  - (c) All posts and supports shall be centred in the concrete footing such that there is a complete collar of concrete around each post and support. Where posts are not perfectly centred there should be a minimum of 50mm (2") concrete at any point around the post.
  - (d) The full depth of the manufacturer's specified footing must be below subgrade. If required for specified embedment of post in the footing, footing shall extend in sonotube through the granular drainage layer. Footing must not extend into the wood fibre protective surface.
- E36.4.3 Cold Weather Concreting
  - (a) Cold weather concreting shall be as per Section 3.9 of CW 2160 and CSA A23.1.
    - (i) All material and equipment needed for adequate protection and curing shall be on hand and ready to use before concrete placement is started.

- (ii) Before concrete is placed all ice, snow, and frost shall be removed from formwork and all surfaces against which concrete will be placed.
  - Temperatures of adjacent surfaces shall be raised to and maintained at 5° C minimum, prior to and during concreting.
  - Calcium chloride or other de-icing salts shall not be used as a de-icing agent in the forms.
- (iii) Heating equipment and enclosures shall be per CW 2160 and CSA A23.1.
- E36.5 Method of Measurement and Basis of Payment
- E36.5.1 Method of Measurement shall be as follows:
  - (a) No separate measurement for Cast-in-Place Concrete Foundations shall be made for Site Furnishings or Play Equipment, as Foundations are incidental to the Works therein.
- E36.5.2 Basis of Payment shall be as follows:
  - (a) No additional payment for Cast-in-Place Concrete Foundations shall be made for Site Furnishings or Play Equipment, as Foundations are incidental to the Works therein.

# PLAY STRUCTURE AND EQUIPMENT

## E37. GENERAL

- E37.1 This specification shall cover the supply and installation of the Play Equipment as listed below and specified herein.
- E37.2 The Contractor shall furnish all labour, materials, equipment and services necessary to complete the Work according to the drawings and specifications.
- E37.3 The Contractor shall be responsible for the layout of all play equipment and thus the extent of the timber edging and protective surfacing required to comply with CSA standards.
- E37.4 The Contractor shall confirm with the Contract Administrator the final design, layout and colours of the play equipment prior to ordering the equipment.

### E38. CANADIAN STANDARDS ASSOCIATION

- E38.1 This Specification shall cover the supply and installation of play equipment in accordance with applicable Specification sections, the Drawings, and in compliance with the current CAN/CSA Z1614.
  - (a) If Contractor states play equipment components are compliant with CSA Standards and they are found to be not compliant, liquidated damages may incur until equipment is deemed acceptable by the Contract Administrator and City of Winnipeg Parks Department.

#### E39. PLAY STRUCTURE

- E39.1 This specification shall cover the supply and installation of the Play Structures, as shown on the Drawings.
- E39.2 Products

- (a) Further to CW 1110, shop drawings shall be submitted to the Contract Administrator for all the play equipment specified in this Section, within fourteen (14) Calendar Days of receipt of a Purchase Order.

  - (i) Layout and configuration of equipment including required safety zones,
  - (ii) Colours

# E39.4 Materials

- (a) Posts / Caps
  - (i) All posts shall be a minimum of 127 mm (5") O.D. round tubing.
  - (ii) All posts shall be fabricated from either aluminum 3 mm (0.125") 11 ga min. wall thickness or galvanized steel 3 mm (0.120") 11 ga min. wall thickness tubing. All fabrication cuts, drill holes and weld joints shall be sprayed with a corrosion resistant coating. The bottom end of the posts is to be sealed with a moisture barrier.

#### E44. DESIGN SERVICES

- E44.1 For the purposes of the RFP, the Proponent should utilize design consultants for the design and presentation of information for the spray pad.
- E44.2 The Contractor's consultants shall meet the following qualifications:
  - (a) Utilize professionals where required by legislation;
  - (b) A Professional Engineer registered to practice in the Province of Manitoba shall seal structural, mechanical, civil and electrical design drawings, if required; and
  - (c) Utilize other professional expertise as required to design the Work.
- E44.3 The Contractor shall provide consulting services as required in order to:
  - (a) Obtain approvals and permitting from the necessary authorities including but not limited to:
    - (i) City of Winnipeg, Environmental Health Services Branch,
    - (ii) City of Winnipeg Zoning Permits Branch, Water and Waste Dept., and
    - (iii) Other agencies as required.
  - (b) Prepare design drawings, specifications, documentation and instructions required for the completion of the Work.
  - (c) Design to the minimum standards set out in *The City of Winnipeg Standard Construction* Specifications. The Contractor shall obtain the Contract Administrator's approval if the design will deviate from *The City of Winnipeg Standard Construction Specifications*.
  - (d) Design to the City of Winnipeg Accessibility Design Standards <u>http://www.winnipeg.ca/ppd/Universal\_Design.stm</u>
- E44.4 Errors and Omissions shall be the responsibility of the Contractor who at their discretion may obtain Errors and Omissions Insurance.
- E44.5 Further to E15, the Contractor shall submit final design drawings and specifications to the Contract Administrator for review prior to permitting. They shall include, but not be limited to:
  - (a) Layout Plan and Details with spray basin, tie-in to adjacent walkways, and spray features

- (b) Site Servicing Plan
- (c) Mechanical and Electrical Systems
- E44.6 All consultant services are to be considered incidental to the Work.

#### E45. CIVIL / MECHANICAL / ELECTRICAL SYSTEMS

- E45.1 General Description
  - (a) This specification shall cover the supply and installation of water and sewer connections, and all mechanical, plumbing and electrical required to construct a fully functioning spray pad.
  - (b) The spray pad system is to be a drain away system connected to a City water service. The design and detailing of the systems are to be approved by the Contract Administrator and the City of Winnipeg prior to start of construction.
- E45.2 RFP Submissions
  - (a) Further to B12 and B14, the location of the water service meter pit, the sewer connection and the method for installing the water and sewer lines (ie, open cut or directional bore or other) is to be clearly indicated in the Proponent's submission.
  - (b) The size and location of the vault/mechanical cabinet, as well as the foundation details, is to be clearly indicated in the Proponent's submission. Any changes required to the size and layout of the concrete pad with respect to the mechanical cabinet should also be shown.
- E45.3 Water Service
  - (a) There is an existing seasonal water line complete with shut-off valves that runs into the existing shed. The water line for the new spray pad should be re-directed as required for the new spray pad system.
    - (i) The Contractor can make arrangements to view the existing set-up in the storage shed
  - (b) The new spray pad meter is to be located in the mechanical cabinet or a 1500mm CMP lockable meter pit as per SD-241.
    - (i) The lid shall have a rubber surfacing adhered to it (ie. rubberized surfacing, spray on surface, rubber mat, or other).
    - (ii) The Contractor shall indicate the location of the new meter on the submission drawings.
  - (c) A seasonal supply line to spray pad's manifold/water distribution system is required.
    - (i) All seasonal line(s) to gravity drain.
  - (d) A hose bib shall be included in the mechanical cabinet.
  - (e) Water quality must comply with current Health regulations.
- E45.4 Drain & Sewer Lines
  - (a) A stamped Engineer's technical report shall be submitted to the City of Winnipeg, Water and Waste Department showing the pre and post development flows.
    - (i) On site land drainage management such as an underground storage tank and catch basin(s) with or without restrictors would be needed for the site if the flow to the combined sewer system (wastewater and land drainage) from the spray pad development is greater than the flow previously to the combined sewer system (wastewater and land drainage).
  - (b) The splash pad drain line(s) shall be sized to permit draining of basin to prevent any standing water.
  - (c) All drain line(s) to gravity drain. Angles/bends within the drain lines are to be 45° or less.
  - (d) The splash pad shall contain drain lines as required by design and applicable code(s) with a minimum of two interconnected drains per drainage basin.
    - (i) Deck drains shall have an anti-vortex cover (secured) or approved equal complete with removable clean-out trap.
    - (ii) Deck drains to be heavy duty non-corroding metal alloy or equally durable fibreglass or plastic construction.

(iii) Trench drains may be provided as appropriate to the design.

# E45.5 Mechanical

- (a) All mechanical devices that are required to operate the spray pad are to be located in a vault/cabinet.
  - (i) The vault/cabinet shall be installed on a reinforced concrete foundation.
  - (ii) The vault must connect to the drain system such that no standing water occurs in the vault or cabinet.
  - (iii) Mountings must be structurally designed.
  - (iv) Controls must be easily accessible.
  - (v) The water meter for the spray pad is to be included in the cabinet, along with a backflow preventer valve
  - (vi) A hose bib shall be included in the mechanical cabinet.
  - (vii) All equipment, fixtures and devices requiring normal maintenance and/or cleaning are to be mounted such that they are fully serviceable. Provide necessary isolation access doors, union fittings and the like.
- (b) Controls
  - (i) Low lifecycle cost considering initial investment, daily operations maintenance and expected lifespan.
  - (ii) Rain sensors and automatic shut-off devices are required for the spray pad.
  - (iii) System is to drain away so there is no standing water at any time.
  - (iv) Must comply with current Health regulations.
- E45.6 Electrical
  - (a) The electrical service may tie into the Community Centre electrical system or potentially the Maintenance Building and Maintenance Building Electrical Service (if adequate). Further to B3, the electrical room may be viewed at a pre-bid site meeting.
    - (i) The Contractor is responsible for the supply and installation of any/all upgrades that may be required for the complete operation of the spray pad. All electrical equipment must be C.S.A. and City of Winnipeg approved.
    - (ii) All electrical Work in/on the Community Centre building and maintenance building shall be installed in a neat, unobtrusive manner to the satisfaction of the Contract Administrator.
    - (iii) All components within the spray pad area shall be grounded in accordance with manufacturer's requirements and Electrical code. All fencing and bollards within 1.5m of the spray pad are to be grounded.
    - (iv) All electrical controls and equipment are to be in free-standing weather proof enclosures.
- E45.7 Materials and Methods
  - (a) All mechanical, electrical and plumbing must comply to all regulatory authorities that have jurisdiction, *The City of Winnipeg Standard Construction Specifications*, and manufacturer's recommended practices.
  - (b) All connections to existing services necessary to provide a complete working project shall be included. This includes but is not limited to electrical, water and sewer.
  - (c) All active load pipe shall be Schedule 80 PVC or better.
  - (d) All water supply lines to the features shall be low pressure poly pipe approved for 100psi.
  - (e) All material used as pipe sleeves shall be approved in advance of installation by the Contract Administrator.
  - (f) Piping is to include a shock arrester.
  - (g) Mechanical markings are to be in accordance with the most current standards which may include:

- (h) Qualified tradesmen shall be employed for all work.
- (i) The Contractor shall restore all areas which have been disturbed by the Contractor's operations to as good as or better than the original condition to the satisfaction of the Contract Administrator.
- E45.8 Method of Measurement and Basis of Payment
- E45.8.1 Method of Measurement shall be as follows:
  - (a) Civil, mechanical, and electrical systems will be measured on a lump sum basis for:
    - (i) "Supply & Install Spray Pad Civil, Mechanical and Electrical" on Form B: Prices.
- E45.8.2 Basis of Payment
  - (a) Civil, mechanical, and electrical systems will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all permitting, labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.

# E46. CONCRETE SPRAY PAD

- E46.1 General Description
  - (a) Further to CW 3110 and CW 3310, this specification shall cover the supply and installation of;
- E46.2 Concrete Spray Pad
  - (a) The Concrete Spray Pad shall include:
    - (i) the spray basin; and
    - (ii) the overspray zone.
  - (b) The layout of the spray components shall be such that the manufacturer's spray zones shall be contained entirely within the spray basin.
  - (c) The over spray zone is intended to contain any over spray from the components and provide a dry surface for circulation around the spray pad.
    - (i) The overspray zone shall be sized as indicated on the Drawings.
    - (ii) The overspray zone shall be a minimum of 2.4m wide for the Spray Pad (both the Toddler and Family Zone).
  - (d) Should the Proponent's selection and layout of spray components, or budgetary considerations during the Bidding Process, necessitate adjustments to the layout of the spray pad, the Proponent shall clearly show these changes in their RFP submission.
    - (i) The submitted drawings shall show that the proposed change is consistent with the project design intent as evidenced by the RFP Drawings.
- E46.3 Granite Seating Boulders
  - (a) The Granite Seating Boulders shall be constructed as per the details on the Drawings.
  - (b) Boulders shall be Black Granite at 750-1000mm in diameter, free of sharp edges, and with a flat underside as depicted on the Drawings.
  - (c) Granite Boulders shall be selected in coordination with the Contract Administrator.

  - (iii) Light broom finish with a slip resistant surface. Contractor to have sample of concrete finish approved by Contract Administrator prior to any concrete being poured.
  - (iv) Saw cut locations are to be reviewed by the Contract Administrator prior to implementation.
- E46.7 Method of Measurement and Basis of Payment
- E46.7.1 Method of Measurement shall be as follows:
  - (a) Concrete Spray Pad and Overspray Basin will be measured on a lump sum basis for:
     (i) "Concrete Spray Pad and Overspray Basin" on Form B: Prices.

    - (i) "Supply & Install Granite Boulders" on Form B: Prices.
  - (c) No additional measurement will be made for Grading as this item is incidental to the Work herein.
- E46.7.2 Basis of Payment
  - (a) Concrete Spray Pad and Granite Seating Boulders will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.
  - (b) No additional payment will be made for Grading as this item is incidental to the Work herein.

# E47. SPRAY COMPONENTS

- E47.1 General Description
  - (a) This specification shall cover the supply and installation of all spray components.
  - (b) The design of the spray pad and components should complement the new playground that is part of the project.
    - (i) While the intent is that the spray features are unique to this spray pad and it stands separate from the playground, the two should complement each other in form and colour.
  - (c) Refer to F1 Appendix A Diagram 1 "Valour Community Centre Spray Pad Design Element Concepts" for user zones and spray pad element concepts.
- E47.2 Design

- (a) Further to E47.1(c), the design for the spray pad components should meet the following requirements:
  - (i) Provide for all age and ability user groups. The spray pad should be zoned with two groupings of components dedicated to Toddlers (children 0-4 yrs) and a general Family Zone suitable for all ages.
  - (ii) Follow City of Winnipeg Accessibility Design Standards.
  - (iii) Contain a variety of ground sprays, mid-height components and tall components.
  - (iv) Contain a minimum of four different water spray experiences in the Toddler Zone.
  - (v) Contain a minimum of one "group" or "team" feature that requires multiple user participation to manipulate the type/amount of water being sprayed in the Family Zone.
  - (vi) Contain durable "dumping buckets" or similar feature element.
  - (vii) Contain a minimum of two bollard activators, one located in the Toddler Zone and one at the Family Zone.
  - (viii) Contain a consistent look or "theme" within the spray pad. A "theme" that evokes a certain culture or cartoon type is not permitted.
  - (ix) Contain a vertical focal feature (ie dumping buckets) in both zones shown on the Drawings.
  - (x) Organization of and clustering of features is encouraged to create a sense of space or entry into the spray pad and define zones ( ie spray hoops at perimeter to create a separate zone for younger children. Groups of 3, 5, and 7 work well to define space and create impact.
  - (xi) Spray features should have a sculptural quality and colour that will add interest to the park year-round.
  - (xii) Refer to F2 Appendix A Diagram 2 Valour Community Centre Play Equipment / Spray Pad Colour Themes for reference.
- (b) The design for the spray pad components should <u>**not**</u> include:
  - (i) Trip, entanglement and strangulation hazards.
  - (ii) Components with large surfaces or panels that may be broken or attract graffiti, nor graphic surfaces (ground apron activators) embedded in the concrete where water can get trapped.
  - (iii) Components with shapes or surfaces that may attract skateboarding on them.
  - (iv) "Ground Stream" type features, particularly those containing low to the ground / moveable components.
  - (v) Components with moving parts that may pose a hazard or injury, including those with handles on them that are wide enough for people to stand on and spin with the feature, or that move and might hit a stationary person.
  - (vi) Components that contain complicated computerized mechanisms.
  - (vii) Components with hanging parts that a person could easily reach and hang from, break or bend (ie. Whale tails or palm trees with low hanging leaves).
  - (viii) Large single dumping bucket.
  - (ix) Water cannons or shooting components with high pressure water or components that resemble weapons.
- (c) The Contract Administrator reserves the right to make minor changes to the components and change any or all colours prior to the Contractor ordering the components.

#### E47.3 Materials and Methods

- (a) The spray components shall meet the following requirements:
  - (i) Be from one manufacturer;
  - (ii) Posts/pipes to be minimum 125mm diameter.
  - (iii) Be durable and vandal resistant;
  - (iv) Have a minimum of moving parts and be easy to maintain;
  - (v) Have adjustable controls that can be programmed to allow flexibility in the spray sequence; and,
  - (vi) Have bases/connections that permit component relocation.

- E47.4.1 Method of Measurement shall be as follows:
  - (a) Spray components will be measured on a lump sum basis for:
    - (i) "Spray Components" on Form B: Prices.
- E47.4.2 Basis of Payment
  - (a) Spray components will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.

#### E48. COMMISSIONING

- E48.1 Operations and Maintenance Manuals
  - (a) The Contractor shall supply in a format acceptable to the Contract Administrator three (3) bound copies of the manuals, as well as one electronic copy (in pdf format) detailing the operations and maintenance instructions for all elements of the project including:
    - (i) Manufacturers' written instructions, warranties, shop drawings, schedules, wiring diagrams and a listing of persons to contact for repairs during warranty period.
    - (ii) Descriptions of day-to-day operations, preventative maintenance, annual and periodic maintenance, and procedures for seasonal shutdown and start-up.
    - (iii) The Operation and Maintenance manual shall state that the system cannot be back flushed (automatically or manually) or drained during wet weather events.
- E48.2 System Start-up, First Year Winterization
  - (a) The Contractor is to perform the system start-up in accordance with the information contained in the operations and maintenance manuals in order to have the Work fully operational for public use by the date of Substantial Performance.
  - (b) After the operation of the spray pad for the season, the Contractor shall perform the first year winterization of the Work and the subsequent start-up the following spring.
  - (c) The Contractor shall provide the Contract Administrator with 48 hours notice prior to commencing the start-up and winterization procedures in order that City staff may attend.

# E48.3 Staff Training

- (a) On Site training shall be provided to the City pool staff and maintenance personnel in proper operation and maintenance procedures for the system.
- (b) Trainers shall be qualified trades persons or consultants knowledgeable of the equipment and familiar with the installation.
- (c) Legible documentation shall be provided to City staff during training.
- (d) Training shall be a minimum of one half day duration.
- E48.4 Record Drawings
  - (a) Further to E2, the Contractor shall submit the set of Record Drawings in CAD & PDF format to the Contract Administrator at Total Performance. Final payment will not be made until the Record Drawings are received.
- E48.5 Method of Measurement and Basis of Payment
- E48.6 Method of Measurements shall be as follows:
  - (a) Commissiong will be measured on a lump sum basis for:
    - (i) "Commissioning" on Form B: Prices
  - (b) Winterization and Spring Start Up will be measured on a lump sum basis for:
    - (i) "Winterization and Spring Start Up" on Form B: Prices.
- E48.7 Basis of Payment


(a) Commissioning and Winterization and Spring Start Up will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment, and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.
