Dear Sir,

I have the honour to be, at present, the Senior Officer in the Manitoba Regiment. This Formation comprises the following Infantry Battalions in the Field:-

8th Battalion. (90th., Winnipeg Rifles).
16th Battalion. (Canadian Scottish).
27th Battalion. (City of Winnipeg).
43rd Battalion. (79th., Cameron Highlanders of Canada).

52nd Battalion. (Winnipeg Grenadiers).

In addition to the above there are large numbers of citizens of the Province of Manitoba who have joined other units and branches of the Service.

The natural expectation is, that in the near future large numbers of these men will be discharged from the Service to re-enter civil life, and the Officers of the Regiment lookforward with a degree of anxiety to this critical period. Each man on discharge will, in most cases, receive a considerable amount of deferred pay, and, in all cases, a gratuity of three months pay. While this will proivide for the necessities of the moment, I consider it will also tend to produce a reluctance in some cases to seek civil employment. I feel quite certain, however, that if opportunities for employment of any kind are provided immediately upon, or even prior to discharge, there will be a much greater response than if such opportunities are presented to the men after a period of idleness.

I venture therefore, to address this letter to you and to several prominent citizens of Winnipeg, in the hope that you will interest yourself in the matter, and in the hope that you will see fit to join in some concerted action to provide that the opportunities for employment are presented to the men at the earliest possible moment after their return home.

Many men will accept work if offered to them prior to their discharge, who would not seek it if returned to civil life with money in their pockets.

Farm work will at first appeal to a great many, and while a considerable proportion of this number will not stick at this work, even a few months' such employment will tend a great measure to re-establish the habits of industry which are so essential.

I understand that the Dominion Government, in conjunction with the Provincial Authorities are taking some steps in the matter, but I feel sure that your co-operation will not only be welcomed but will greatly facilitate conditions.

I can assure you that anything you can do will be most deeply appreciated by every soldier from Manitoba;
