On February 7, 2018, the City of Winnipeg received your request for access to the following:

Lawyer Krista Boryskavich was appointed to the position of Acting Director of Legal Services and City Solicitor on or about February 1, 2014. This applicant seeks a copy of the record(s) that effected the appointment of Boryskavich to that position.

Your request for access is granted to an email dated February 21, 2014 from the Acting CAO announcing Krista Boryskavich's appointment to the position of Acting Director of Legal Services and Acting City Solicitor.

We did not locate "a letter of offer"; however, it is possible that such a record, if it exists, could be located in the form of an email or attachment to an email. In order to determine if that record exists, an extensive electronic search of emails would be required. We have confirmed that such a search would be over the 2 free hours allotted by the legislation. If you determine that you would like that search to be conducted, please submit a new FIPPA request for what you need and we will be able to issue a fee estimate for the time over and above the 2 free hours.

Section 59(1) of the *Act* provides that you may make a complaint about this decision to the Manitoba Ombudsman. You have 60 days from the receipt of this letter to make a complaint on the prescribed form to the Manitoba Ombudsman (Mail: 750-500 Portage Avenue, Winnipeg MB R3C 3X1; Telephone 204-982-9130 or 1-800-665-0531).

Good afternoon, everyone. This afternoon I am pleased to advise that Mr. Michael Jack, Director of Legal Services and City Solicitor, has been appointed the City's Acting Chief Operating Officer, effective Monday, February 24, 2014. Ms. Krista Boryskavich, our Deputy City Solicitor, has been appointed Acting Director of Legal Services and Acting City Solicitor, as of the same date.

Michael joined the City's Legal Services Department as a solicitor in 2000. A graduate of the University of Manitoba in both law (LL.B.) and commerce (B.Comm., Honours) he has acted as both a prosecutor and defence counsel, and conducted civil litigation including contract disputes, damage claims, and personal injury files, and acted for the Winnipeg Police Service in several jury trials. He was appointed Director of Legal Services and City Solicitor on May 22, 2012 – in which capacity he led and managed the City's Legal Services team, ensuring the provision of legal advice and representation in all areas required by the City.

In his new capacity as Acting COO, he will assist me with my responsibilities as Acting CAO, as well as providing leadership in coordinating corporate planning; assisting with financial, operational, and performance management; ensuring policy implementation and performance improvement; and maintaining relations with community stakeholders and partners.

In the course of his tenure as a City solicitor and as Director of Legal Services, Michael has represented the City in a wide range of matters; provided advice and counsel to all departments; and proven himself a valued member of our Senior Management Team. I know that he is looking forward to serving Council and his colleagues in his new capacity as Acting COO.

Krista, a graduate of the University of Winnipeg in arts (B.A., Honours), and the University of Manitoba in law (LL.B.) and public administration (M.P.A.) has worked with the City since 2004, and has a strong background in public policy. We are looking forward to her joining the Senior Management Team on a regular basis, as Acting Director of Legal Services.
