PART B – BIDDING PROCEDURES

Revise B2.1 to read:

B2.1 The Submission Deadline is 12:00 noon Winnipeg time, January 20, 2004.

Revise B8.1 to read:

B8.1 The Bidder shall state a price in Canadian funds for each item of the Work in Alternative 1 and/or for each item of Work, for each Section Bid in Alternative 2, identified on Form B: Prices.

Revise B10 to read:

B10. OPENING OF TENDER SUBMISSION

- B10.1 Tender Submissions will be opened publicly, after the Submission Deadline has elapsed, in the office of the Corporate Finance Department, Materials Management Division, or in such other office as may be designated by the Manager of Materials.
- B10.2 Bidders or their representatives may attend.
- B10.3 Prices will not be read out publicly at such time.
- B10.4 A list of unevaluated bid prices, for each Alternative (pending review and verification of conformance with requirements) shall be available for viewing by 12:00 Noon the following Business Day in Adobe Acrobat (pdf) format at The City of Winnipeg, Corporate Finance, Materials Management internet site at http://www.winnipeg.ca/matmgt.

Revise B13 to read:

B13. EVALUATION OF BIDS

- B13.1 Award of the Contract shall be based on the following bid evaluation criteria:
 - (a) compliance by the Bidder with the requirements of the Tender Package;
 - (b) qualifications of the Bidder and the Subcontractors, if any, pursuant to B9;
 - (c) Total Evaluated Bid Price;
 - (d) economic analysis of any approved alternative pursuant to B5.

- B13.2 Further to 13.1(a), the Award Authority may reject a Bid as being non-responsive if the Tender Submission is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The Award Authority may reject all or any part of any Bid, or waive technical requirements if the interests of the City so require.
- B13.3 Further to 13.1(b), the Award Authority shall reject any Bid submitted by a Bidder who does not demonstrate, in his Tender Submission or in other information required to be submitted, that he is responsible and qualified.
- B13.4 Further to 13.1(c), the Total Evaluated bid price shall be evaluated based on the prices submitted on Form B: Prices.
- B13.5 This Contract may be awarded as a whole (Alternative 1) or separately in sections (Alternative 2) as identified on Form B: Prices.
 - B13.5.1 Notwithstanding B8.1, the Bidder may, but is not required to, bid on both alternatives, or on any one or more sections in Alternative 2.
 - B13.5.2 The City shall not be obligated to award any section to the responsible Bidder submitting the lowest evaluated responsive Bid for that section and shall have the right to choose the alternative which is in its best interests. If the Bidder has not bid on both alternatives or on all sections in Alternative 2, he/she shall have no claim against the City if his/her partial Bid is rejected in favour of an award of the Contract on the basis of an alternative or section upon which he/she has not bid.
