PART D - SUPPLEMENTAL CONDITIONS

Revise D11.1 to read:

D11.1 The Contractor shall achieve Substantial Performance by July 31, 2005.

Revise D12.1 to read:

D12.1 The Contractor shall achieve Total Performance by August 31, 2005.

Revise D13. LIQUIDATED DAMAGES to read:

D13. LIQUIDATED DAMAGES

- D13.1 If the Contractor fails to achieve critical stages, Substantial Performance or Total Performance in accordance with the Contract by the days fixed herein for same, the Contractor shall pay the City the following amounts per Calendar Day for each and every Calendar Day following the days fixed herein for same during which such failure continues:
 - (a) Stage 1 Work One Hundred and Fifty dollars (\$150.00);
 - (b) Stage II Work One Hundred and Fifty dollars (\$150.00);
 - (c) Substantial Performance One Hundred and Fifty dollars (\$150.00);
- D13.2 The amounts specified for liquidated damages in D13.1 are based on a genuine pre-estimate of the City's losses in the event that the Contractor does not achieve critical stages or Substantial Performance by the days fixed herein for same.
- D13.3 The City may reduce any payment to the Contractor by the amount of any liquidated damages assessed.

Add D18. CRITICAL STAGES:

D18. CRITICAL STAGES

- D18.1 The Contractor shall achieve critical stages of the Work in accordance with the following requirements:
 - (a) Stage I Work Completion Date shall be **December 31, 2004**.
 - (b) Stage II Work Completion Date shall be **July 31, 2005**.

D18.2 Stage I Work shall include the supply and installation of the following 47 sign structures, complete with sign boxes/plates and sign message information, applicable to all six Alternatives by the stipulated date.

D18.3 Stage II Work shall include the supply and installation of the remaining structures in each Alternative as well as final site restoration at all locations by the stipulated dates.

PART E - SPECIFICATIONS

Revise E3.2.9 to read:

E3.2.9 Paint

The paint system for hot-dip galvanized posts shall consist of a high-build epoxy primer and two coats of urethane topcoat. Approved paint products are Davoe Coatings Devron 201 Universal Epoxy Primer and Devthane 369 Aliphatic Urethane Gloss Enamel for topcoat. The finish colour shall be Pantone Matching System PMS 2738, dark blue. However, the Contract Administrator will supply a swatch sample to the Contractor to match the colour prior to painting.

Revise E3.4.6 to read:

E3.4.6 Painting

All painting shall be carried out in the shop.

For the previously hot-dip galvanized steel items, including posts, base plates, brackets, shrouds, and reaction plates, the paint system for Alternatives 1, 2, and 3 shall be applied as follows:

- a) Surface preparation involving sweep blasting to SSPC-SP7.
- b) One coat of high build epoxy primer with 3 to 4 mils dry film thickness.
- c) Two coats of urethane top coat with each coat 2 to 3 mils dry film thickness. Colour to match Pantone Colour Matching System 2738.

For Alternatives 4, 5, and 6, the posts and breakaway bases are not to be painted.

Revise E5.2.10 to read:

E5.2.10 Paint

The paint system for sign boxes of Alternatives 1, 2, and 3 shall consist of an epoxy primer and two coats of urethane topcoat. Approved paint products are Davoe Coatings Devron 201 Universal Epoxy Primer and Devthane 369 Aliphatic Urethane Gloss Enamel for topcoat. The paint finish colour shall be dark blue to match Pantone Matching System PMS 2738.

Revise E5.3.1 f) to read:

- E5.3.1 f) The sign box extrusion, including screw heads, shall be painted dark blue to match Pantone Matching System 2738, being the colour of the posts for Alternatives 1, 2, and 3. The paint system shall be applied as follows:
 - Totally wipe clean with solvent both the outside and inside surfaces. Do light sanding and rub surface down with tack cloth.
 - ii) Apply one coat of epoxy primer on both the outside and inside surfaces with 3 to 4 mils dry film thickness.
 - iii) Apply two coats of urethane topcoat on both the outside and inside surfaces, each coat to be 2 to 3 mils dry film thickness.
