PART D – SUPPLEMENTAL CONDITIONS

Add: D9.2 The City of Winnipeg will endeavour to award the Contract within 25 Calendar Days of the Submission Deadline. If award is not made within that time period, Contract Dates identified in D10 Critical Stages, D11 Substantial Performance, D12 Total Performance and D13 Liquidated Damages, will be extended by an equivalent number of Calendar Days, until such a time as an award is made.

Replace: D10.1 (a), (b), (c) and (d) with the following:

- (a) Supply and delivery of two (2) 2100 millimetre butterfly valves with electric actuators and two (2) 2100 millimetre butterfly valves with manual actuators to the City of Winnipeg warehouse at 1500 Plessis Road by **September 2, 2005**.
- (b) Successful in-warehouse testing of two (2) 2100 millimetre butterfly valves with electric actuators and two (2) 2100 millimetre butterfly valves with manual actuators by **September 16, 2005**.
- (c) Delivery of remaining 2100 millimetre butterfly valves and actuators to the City of Winnipeg warehouse at 1500 Plessis Road by **September 30, 2005**.
- (d) Successful in-warehouse testing of remaining butterfly valves with actuators by **October 14, 2005**.

Replace: D13.1 (a), (b), (c) and (d) with the following:

- (a) Supply and delivery of two (2) 2100 millimetre butterfly valves with electric actuators and two (2) 2100 millimetre butterfly valves with manual actuators to the City of Winnipeg warehouse at 1500 Plessis Road by **September 2, 2005** – one thousand, five hundred dollars (\$1,500);
- (b) Successful in-warehouse testing of two (2) 2100 millimetre diameter butterfly valves with electric actuators and two (2) 2100 millimetre butterfly valves with manual actuators by **September 16, 2005** – one thousand, five hundred dollars (\$1,500);
- (c) Supply and delivery of remaining 2100 millimetre butterfly valves and actuators to the City of Winnipeg warehouse at 1500 Plessis Road by **September 30, 2005** - one thousand, five hundred dollars (\$1,500);
- (d) Successful in-warehouse testing of remaining 2100 millimetre diameter butterfly valves and actuators by **October 14, 2005** - one thousand, five hundred dollars (\$1,500);
