

- 1. ALL DIMENSIONS ARE IN MILLIMETERS UNLESS OTHERWISE NOTED. ALL ELEVATIONS ARE IN METERS AND ARE TO GEODETIC DATUM. THE CONTRACTOR SHALL VERIFY DIMENSIONS BEFORE BEGINNING CONSTRUCTION AND REPORT DISCREPANCIES TO THE CONTRACT ADMINISTRATOR BEFORE PROCEEDING WITH THE WORK. DO NOT SCALE THE DRAWINGS.
- 2. THIS STRUCTURE IS DESIGNED IN ACCORDANCE WITH AND SHALL BE CONSTRUCTED IN COMPLIANCE WITH THE FOLLOWING BUILDING CODES AND APPLICABLE LOCAL BYLAWS: 2.1. ACI 350-06 ENVIRONMENTAL STRUCTURES
- 2.2. WHERE CONTRADICTORY REQUIREMENTS OCCUR, THE MOST STRINGENT SHALL APPLY.
- 3. DISCREPANCIES OR AMBIGUITIES ON THE DRAWINGS AND/OR SITE, WHICH AFFECT THE STRUCTURAL FRAMING, SHALL BE REPORTED TO THE CONTRACT ADMINISTRATOR.
- 4. THE CONTRACTOR SHALL VERIFY THE LOCATION OF ALL EXISTING UNDERGROUND SERVICES PRIOR TO START OF CONSTRUCTION.
- 5. LOCATION OF CONSTRUCTION JOINTS IS THE RESPONSIBILITY OF THE CONTRACTOR, BUT APPROVAL MUST BE GRANTED BY THE CONTRACT ADMINISTRATOR BEFORE PROCEEDING.
- 6. THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE DESIGN AND INSTALLATION OF ALL NECESSARY SHORING, BRACING AND FORMWORK. FORM WORK FOR NEW CONSTRUCTION SHALL BE BRIDGED OVER EXISTING SERVICES. PROCEDURE MUST BE APPROVED BY THE CONTRACT ADMINISTRATOR.
- 7. NOTIFY THE CONTRACT ADMINISTRATOR AT LEAST 48 HOURS PRIOR TO ALL CONCRETE POURS AND/OR INSTALLATION OF INTERIOR SHEATHING/FORMING, TO ALLOW FOR SITE REVIEWS. ALL CONCRETE WORK TO CSA A23.1 (LATEST).
