Form B(R1): Revise: Items No. 4 to read Approx. Quantity 100.92.

Page numbering on some forms may be changed as a result.

## **PART D - SUPPLEMENTAL CONDITIONS**

Delete: Sections D16. and D18.

Revise: D2.1.1 to read: Snow clearing shall be performed on those regional, bus route and collector, and

residential streets and back lanes listed in Appendix A, Appendix B, Appendix C, Drawing 1, and Drawing 2, where full width snow clearing is required on all or a major portion of

the above streets.

Revise: D10.1(a) to read: commercial general liability insurance, in the amount of at least two million dollars

(\$2,000,000.00) inclusive, with The City of Winnipeg added as an additional insured; such liability policy to also contain a cross-liability clause, contractual liability, non-owned automobile liability, unlicensed equipment liability (contractors equipment) and products and completed operations cover, to remain in place at all times during the performance of

the Work;

Revise: D10.1(b) to read: Automobile Liability Insurance covering all motor vehicles, owned and operated and

used or to be used by the Contractor directly or indirectly in the performance of the Service. The Limit of Liability shall not be less than \$2,000,000 inclusive for loss or damage including personal injuries and death resulting from any one accident or

occurrence.

Revise: D10.2 to read: Deductibles for commercial general liability must be expressly stated on the certificate of

insurance and must not exceed \$5,000.00.

### **PART E - SPECIFICATIONS**

Revise: E3.1.1 to read: Snow clearing equipment shall be supplied on an hourly basis when requested by the

Contract Administrator for winter maintenance activities between storms and opening up streets and back lanes and keeping them open during major snow storms and blizzards.

Revise: E7.1 to read: The Contractor shall provide snow clearing equipment to keep streets and back lanes

open during the extreme snowfall event if requested by the Contract Administrator. The Contract Administrator shall evaluate field conditions and at his discretion, continue or

terminate the hourly snow clearing operations.

Revise: E7.2 to read: Time utilized by the Contractor to keep streets and back lanes open during the snow

storm shall not be part of the time limits established in E2.2, E2.3, and E2.4.

Revise: E7.3 to read: During or after extreme snowfall and/or blizzards, the Contract Administrator may require

that Regional and Collector streets and back lanes be opened using both Contract and City forces in order to open such streets and emergency routes as quickly as possible. The Contractor may be required to dispatch his equipment to work inside and outside the

contract area with and under the direction of City forces.

Revise: E4.1 to read: Where the Contractor does not satisfactorily complete the Work on Priority I, II, III streets,

or back lanes in accordance with the time and quality requirements specified in E1.1, the

Contractor shall be assessed a penalty.
