Revise: E35.1.5(a) to read: The Contractor shall, at his/her expense, warrant the Work against any and all defects or deficiencies resulting from insect infestation, disease and mechanical damage due to improper handling, installation or maintenance, for a period of two (2) year from the date of the Total Performance. Nursery stock damaged by vandalism or reasons beyond the control of the Contractor shall be replaced by the client. The Contract Administrator reserves the right to request material replacement or extend Revise: E35.1.5(c) to read: the Contractor's Maintenance responsibilities for an additional two (2) years if, at the end of the Warranty Period, leaf development and growth are not sufficient to ensure future survival of the plant material. Revise: E35.5.1 to read: Payment for Installation of trees and grasses shall be paid for at the Contract Unit Prices for the "Items of Work" listed below. This price shall be payment in full for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work included in this Specification and accepted by the Contract Administrator Item of Work:
