#### **Site Contact**

Q1 Who will be the site contact?

A1 After award of contract, there will be a designated City contact to coordinate site access for the successful Proponent(s) as per E1.5(c). If a site visit is requested by a Proponent prior to RFP close, they can contact the Contract Administrator to coordinate as per B3.1. The date and time of the visit will be posted as an addendum to be available for all Proponents.

#### 245 Smith

Q2 D2.2: 3 circuits, 185, One Lombard and 1539 all terminate at 245 Smith. Is there more info re: diversity requirements?

A2 2 diverse entrances are described in E1.4.

Q3 Can CPEs for multiple EPLs be shared if opportunity allows for it?

A3 Must be separated for One Lombard Place and 1539 Waverly St as per E1.4(a), but can be combined for 185 King St. if opportunity allows.

Q4 How should Contractors coordinate joint usage of diverse entrances?

A4 Contractors to assume they will work it out mutually and inform the City, but if there is more responsibility required by the City to coordinate this, please bring that to the Contract Administrator's attention prior to submission date.
