### **Questions and Answers**

Q1. The supplier for the specified air-to-air heat recovery ventilation, HRV-1, has advised that delivery of their unit is anticipated to be in the order of 26-weeks after receipt of approved shop drawings. This anticipated equipment delivery date will not permit us to meet the project substantial completion and total completion dates specified; advise on our best course of action.

A1. The specified HRV product listed in specification 23 72 00 has been revised to reflect a heat recovery ventilator that has a better anticipated delivery while still meeting specified operational and performance requirements; see **Part E Specifications** above. The substantial performance and total completion dates specified in Part D Supplemental Conditions have also been revised to reflect a revised anticipated equipment delivery date; See **Part D Supplemental Conditions** above.

Q2. Our civil/structural sub-contractors are asking if there is more information available that can be used to better define the existing building's construction and related cutting and patching details.

A2. Existing building architectural and structural IFC drawings can be provided to the successful Bidder upon project award. Sketches SK-1 and SK-2; see **Drawings** above, are provided at this time to assist bidders in determining their project cutting & patching requirements.
