Please note the following and attached changes, corrections, additions, deletions, information and/or instructions in connection with the Bid Opportunity, and be governed accordingly. Failure to acknowledge receipt of this Addendum in Paragraph 8 of Form A: Bid may render your Bid non-responsive.

## PART D - SUPPLEMENTAL CONDITIONS

Revise: D10.1 to read: The Contractor shall provide and maintain the following insurance coverage:

- a) commercial general liability insurance, in the amount of at least five million dollars (\$5,000,000.00) inclusive, with the City of Winnipeg and the Province of Manitoba added as additional insureds, with a cross-liability clause; such liability policy to also contain contractual liability, unlicensed motor vehicle liability, non-owned automobile liability and products and completed operations, to remain in place at all times during the performance of the Work and throughout the warranty period;
- b) Automobile Liability Insurance covering all motor vehicles, owned and operated and used or to be used by the Contractor directly or indirectly in the performance of the Work. The Limit of Liability shall not be less than \$2,000,000 inclusive for loss or damage including personal injuries and death resulting from any one accident or occurrence;
- c) all risks installation floater, carrying adequate limits to cover all machinery, equipment, supplies and/or materials intended to enter into and form part of any installation.

Add: D10.5 All policies shall be taken out with insurers licensed to carry on business in the Province of

Manitoba.

Revise: D22.1 to read: Notwithstanding C13.2, the warranty period shall begin on the date of Total Performance and

shall expire two (2) years thereafter unless extended pursuant to C13.2.1 or C13.2.2, in

which case it shall expire when provided for thereunder.

Add: D25 LIABILITY

D25.1 The Contractor shall be responsible for all costs that may occur because of damage the

Contractor causes to the roads, utilities or underground services during the performance of

the Work.

D25.2 The Contractor is responsible for the accuracy of all information provided by the Contractor.

D25.3 The Contractor shall indemnify and save harmless the Province of Manitoba from and against

all claims arising from the construction, testing and maintenance of the Work by the

Contractor, its servants or agents.

## PART E – SPECIFICATIONS

Replace 1049-2017\_Addendum 3\_NMS\_Format\_Specifications\_R1 with 1049-2017\_Addendum\_4\_NMS\_Format\_Specifications\_R2. The following is a summary of changes incorporated in the replacement specifications:

Section 01 73 03

Add: 1.4.9 Restore any disturbed areas, surfaces and/or landscaping to the conditions that existed prior

to commencement of the Work. If the Contractor should fail to restore the disturbed areas, surfaces and/or landscaping, the City may perform the restoration required and charge the

Contractor the full amount thereof.

Add: 1.4.10 The Contractor shall use due care and attention to avoid damage to property, including public

and private property. In the event of damage to property during the performance of the Work,

the Contractor shall immediately restore the property to a condition satisfactory to the

Contract Administrator.

Section 26 05 34

Add: 3.1.11 Provide markers for buried services along entire conduit route. The maximum distance

between markers is 100 m.

Add: 3.1.12 Provide horizontal directional drilling for all road crossings. All crossings shall be at right

angles to the road.

Note that 1049-2017\_Addendum\_4\_NMS\_Format\_Specifications\_R2 includes the revisions made in all previous Addenda

# **QUESTIONS AND ANSWERS**

Q1 Is the existing conduit from the Shaw vault into the building re-usable, or just the vault?

A1 The existing Shaw conduit cannot be used for installation of the new fibre cable.

Also note the revisions on Drawing 1-0103A-E0021-R2 note 2 regarding the Shaw handholes:

Existing Shaw handholes on City property cannot be used for installation of the new fibre cable. Locate new handhole next to WEWPCC Admin building on north side of building east of the main door.
