Add: 1.2 CASH ALLOWANCES FOR BUILDING PERMIT

- .1 Include in the Total Bid Price, cash allowances stated herein.
- .2 Cash allowances, unless otherwise specified, will cover all net costs to the Contractor for related services, products, construction machinery and equipment, freight, handling, unloading, storage, installation and other authorized expenses incurred in performing the Work.
- .3 The Total Bid Price, and not each cash allowance, includes the Contractor's overhead and profit related to all cash allowances.
- .4 The Total Bid Price will be adjusted by written Change order when the final cash allowance amounts are reconciliated.
- .5 Where costs under a cash allowance exceed amount of allowance, Contractor will be compensated for any excess incurred and substantiated plus an allowance for overhead and profit as set out in Contract Documents.
- .6 Progress payments on accounts of work authorized under cash

- allowances shall be included in Contract Administrator's monthly certificate for payment.
- .7 The Contractor shall schedule Cash Allowance items and when they are required to be authorized to proceed, so that progress of the Work will not be delayed.
