In accordance with B14.1 the Bidder encloses bid security in the form of a bid bond (Form G1(R1): Bid Bond and Agreement to Bond) and agrees that it shall be held by the City in accordance with the Contract.

Replace Form G1 with Form G1(R1) (2 pages)

Delete Form G2 (2 pages)

Part B – BIDDING PROCEDURES

Revise B8.1 (c) to read:

(c) Form G1: Bid Bond and Agreement to Bond;

Revise B14.1 (a) to read:

B14.1 (a) a bid bond, in the amount of at least ten percent (10%) of the Total Bid Price, and agreement to bond of a company registered to conduct the business of a surety in Manitoba, in the form included in the Bid Submission (Form G1(R1): Bid Bond and Agreement to Bond).

Delete B14.1 (b) and **(c)**

Revise B14.2 to read:

B14.2 The bid security of the successful Bidder and the next two lowest evaluated responsive and responsible Bidders will be released by the City when a Contract for the Work has been duly executed by the successful Bidder and the contract securities are furnished as provided herein. The bid securities of all other Bidders will be released when a Contract is awarded.

Delete B14.2.1 and B14.2.2

Revise B16.2 to read:

Bid Opportunity No. 1035-2018 Addendum 1

Page 2 of 2

B16.2 The acceptance by the City of any Bid shall not release the Bids of the next two lowest evaluated responsive Bidders and these Bidders shall be bound by their Bids on such Work until a Contract for the Work has been duly executed and the **contract security** furnished as herein provided, but any Bid shall be deemed to have lapsed unless accepted within the time period specified in Paragraph 11 of Form A: Bid

PART D - SUPPLEMENTAL CONDITIONS

Revise D12 Performance Security to read D12 Contract Security as follows:

D12. CONTRACT SECURITY

- D12.1 The Contractor shall provide and maintain the performance bond and the labour and material payment bond until the expiration of the warranty period in the form of:
 - (a) a performance bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H1: Performance Bond), in the amount of fifty percent (50%) of the Contract Price; and
 - (b) a labour and material payment bond of a company registered to conduct the business of a surety in Manitoba, in the form attached to these Supplemental Conditions (Form H2 (R1): Labour and Material Payment Bond), in an amount equal to fifty percent (50%) of the Contract Price.
- D12.2 The Contractor shall provide the City Solicitor with the required performance and labour and material payment bonds within seven (7) Calendar Days of notification of the award of the Contract by way of letter of intent and prior to the commencement of any Work on the Site but in no event later than the date specified in C4.1 for the return of the executed Contract.
- D12.3 The Contractor shall, as soon as practicable after entering into a contract with a Subcontractor:
 - (a) give the Subcontractor written notice of the existence of the labour and material payment bond in D12.1(b); and
 - (b) post a notice of the bond and/or a copy of that bond in a conspicuous location at the Site of the Work.

Revise D14.2 (a)(v) to read:

(v) the contract security specified in D12;

Delete Form H2 Irrevocable Letter of Credit

Add: Form H2(R1) Labour and Material Payment Bond
