PART B - BIDDING PROCEDURES

Revise: B6.5 to read: Proponents should submit one (1) unbound 8.5" x 11" original (marked "original")

including tables, charts, drawings and schedule, and five (5) bound 8.5" x 11" copies for sections identified in B6.1 and B6.2. Drawings, schedule, organizational chart, Form P (or equivalent), experience and qualifications of proponent, subconsultants, and of key personnel assigned to the project in a tabular format, in copies only may be 11" x 17" folded to an 8.5" x 11" size. Each 11" x 17" sized page will be considered as one page. Title page, cover letter, table of contents, Form A, Form P, and the Schedule will not be

considered to count towards the page limit specified in B6.6.

Revise: B6.6 to read: Proposals should not be more than twenty five (25) pages in length. Only the first twenty

five (25) pages of each Proposal will be evaluated.

Revise: B8.7(b)(i) to read: pavement structure exploration in accordance with F2; and

PART D - SUPPLEMENTAL CONDITIONS

Revise: D5.2.1(f)(i) to read: Geotechnical Services for Road Improvements shall conform to F2.

Revise: D5.3(b)(i) to read: For greater clarity, the requirements of F2 apply to road improvements only and do not

apply to the geotechnical investigation for the new crossing structure and any associated

channel works.

Add: D5.3(f)(v) The City will obtain and provide the successful proponent with status of title and any

applicable legal plans that may be applicable to the work. Formal appraisals of property value will be obtained by the City in the event property acquisition is required following

conclusion of the Preliminary Design phase.
