BIDDING PROCEDURES

- 11 The Bid must be submitted on the forms provided, with all required entries made clearly in
- If the Bidder finds discrepancies or omissions in the Request for Quotation or any part thereof, or is unsure of the meaning or intent thereof, he shall notify the Buyer. The Buyer will, if he deems it necessary, issue addenda to all Bidders. The Bidder is advised to direct all enquiries or comments to the Buyer at least five (5) business days prior to the Submission Deadline to allow time for the preparation and distribution of necessary 1.2 addenda.
- The Bidder is responsible for investigating the nature of the Work to be done and all conditions that might affect his Bid or his performance of the Work, and shall assume all risk for conditions existing or arising in the course of the Work which have been or could have been determined through such investigation. 1.3
- The Contract is based on the design, methods and materials specified and any proposed substitutes must be clearly identified in the Bid. Where the phrases "or equal" or " alternative" occur in the Request for Quotation, the Bidder is advised to submit descriptive matter in sufficient detail to permit a judgment as to the merits of any "equal" or 1.4 'alternative" offered.
- The Bidder may, but is not required to, offer a prompt payment discount. If prompt payment discounts are offered, they will be considered in determining the lowest 1.5 evaluated responsive Bid.
- The Bid must be submitted enclosed and sealed in an envelope clearly marked with the RFQ Number and the Bidder's name and address. Each envelope must contain only the Bid for one Request for Quotation. 16
- The Bid must be submitted to the Materials Management Division at the address specified no later than the Submission Deadline specified. Bids received after the Submission Deadline will not be considered. 1.7
- 1.8 The Bid may be withdrawn without penalty at any time prior to the Submission Deadline.
- The Bid shall be open for acceptance, binding and irrevocable for the period of time specified on the cover page. A Bidder who withdraws his Bid after the Submission Deadline but before his Bid has been released or has lapsed shall be liable for such damages as are imposed upon the Bidder by law and subject to such sanctions as the 1.9 City considers appropriate in the circumstances.
- 1.10 The City may reject a Bid as being non-responsive if the Bid is incomplete, obscure or conditional, or contains additions, deletions, alterations or other irregularities. The City may reject all or any part of any Bid or waive technical requirements if the interests of the City so require. The City may reject any Bid submitted by a Bidder who does not demonstrate, in his Bid or in other information required to be submitted, that he is responsible and qualified. A responsible and qualified dider is one that meets the qualifications specified and is not suspended, debarred or in default under any contract with the City. with the City.
- Where the Contract is proposed in separate sections or with alternatives, the City shall have the right to award any section separately or to choose any alternative which is in its 1.11 best interests.
- The City will have no obligation to award a Contract to a Bidder, even though one or all of the Bidders are determined to be responsible and qualified, and the Bids are determined to be responsive. Where an award of Contract is made by the City, the award shall be made to the responsible and qualified Bidder submitting the lowest evaluated responsive Bid. 1.12
- 1.13 The Buyer will give notice of the award of the Contract by issuing a Purchase Order to the successful Bidder, or will give notice that no award will be made.
- The Request for Quotation, including but not limited to the specifications, drawings and addenda, and the Contractor's Bid shall be deemed to be incorporated in and to form a 1.14 part of the Purchase Order notwithstanding that they are not necessarily attached to or accompany said Purchase Order.

SCOPE OF WORK

- 2.1 The Work to be done under this Contract shall consist of the supply and delivery of goods and the provision of ancillary services in accordance with applicable specifications, drawings and addenda.
- The Contractor shall provide and pay for all materials, labour, equipment, tools, utilities, 2.2 licenses and fees necessary to complete the Work.

GOODS

- 3.1 All goods supplied under the Contract shall be new and unused
- 3.2 Materials and workmanship shall be fit for the purpose intended and shall equal or exceed he quality specified
- 3.3 The Contractor shall be responsible for the storage, transportation and handling of goods until delivered to and accepted by the City.
- Goods will be inspected at the time of delivery only for general description, quantity and obvious defects or damage. Notwithstanding any waiver or release which may be included on shipping bills, receipts or other such forms signed at the time of delivery, the Contractor shall not be relieved of any responsibility for goods which are defective or damaged or are not in accordance with the specifications. 3.4
- Goods which, in the sole opinion of the City, fail to meet the requirements of the specifications shall be returned to the Contractor at his expense. The Contractor shall not 3.5 be entitled to payment for goods so returned. In the event payment has been made to the Contractor, the City shall be entitled to recover same and to take whatever remedies that it may have at law.

ASSIGNMENT

The Contractor shall not assign the Contract or any payment thereunder without the prior 4.1 written approval of the City.

- An event of default will be deemed to have occurred if the Contractor:

 b) is adjudged bankrupt or files for bankruptcy, becomes insolvent, makes a general assignment for the benefit of his creditors, or has a receiver or liquidator appointed in
- assignment for the benefit of his creditors, or has a receiver or indudator appointed in respect of his assets; or in the judgment of the City, is not performing or has not been performing the Work, or any part thereof, in a sound and workmanlike manner and in all respects in strict conformity with the Contract; or in the judgment of the City, is not progressing continuously with the Work or any part thereof. c)

SPECIFICATIONS

1. GENERAL

1.1 These Specifications shall be applicable to the Work and shall take precedence over the Terms and Conditions.

2. DEFINITIONS

- 2.1 When used in this Request for Quotation:
 - (a) "Business Day" means any Calendar Day, other than a Saturday, Sunday, or a Statutory or Civic Holiday;
 - (b) "Buyer" means the person authorized to represent the City in respect of the Request for Quotation;
 - (c) "Calendar Day" means the period from one midnight to the following midnight;
 - (d) "Contract" means the combined documents consisting of the Request for Quotation package and any documents and drawings referred to and incorporated therein together with any submissions required to be made by the Contractor after award, and all amendments to the foregoing;
 - (e) "Contract Administrator" means the person authorized to represent the City in respect of the Contract and is identified at the time of award of the Contract;
 - (f) "Contractor" means the person undertaking the performance of the Work under the terms of the Contract;
 - (g) "User" means a person, department or other administrative unit of the City authorized by the Contract Administrator to order Work under this Contract;
 - (h) "Work" means the carrying out and the doing of all things, whether of a temporary or permanent nature, that are to be done by the Contractor pursuant to the Contract and, without limiting the generality of the foregoing, includes the furnishing of all equipment, facilities, material, labour and services necessary for or incidental to the fulfilment of the requirements of the Contract.
- 2.2 Further to 2.1(b), the Buyer is:

3. GOODS

- 3.1 The Contractor shall supply hand protection in accordance with the requirements hereinafter specified.
- 3.2 Lined Roper Style Leather Gloves shall be:
 - (a) Made of cowhide leather, 2 1/2 to 3 oz. chrome tanned, cream in color;
 - (b) Construction shall be:
 - (i) sewn with 100% polyester or a poly/cotton blend thread;
 - (ii) clute cut inseam sewn with reinforced set in roper thumb;
 - (iii) gore tab and dome at wrist;
 - (iv) cotton fleece lining (acrylic lining will not be accepted) securely tacked in all finger tips (thumb optional)
 - (v) size: small, medium, large, X- large and XX-large;
- 3.3 Unlined Roper Styles shall be:
 - (a) Made of cowhide leather, 2 1/2 to 3 oz. chrome tanned, cream in color;
 - (b) Construction shall be:
 - (i) sewn with 100% polyester or a poly/cotton blend thread;
 - (ii) clute cut inseam sewn with reinforced set in roper thumb;
 - (iii) gore tab and dome at wrist;
 - (iv) size: small medium, large, X-large and XX-large;

- 3.4 Leather Mitts shall be:
 - (a) Made of cowhide leather, 3 1/2 to 4 oz. chrome tanned, cream in color;
 - (b) Construction shall be;
 - (i) sewn with 100% polyester or a poly/cotton blend thread;
 - (ii) pullover style
 - (iii) elastic back/open wrist;
 - (iv) fully welted chopper thumb bound top;
 - (v) fully welted mitt;
 - (vi) size; small, medium, large, and X-large.
- 3.5 Mitt Liners
 - (a) Made of 2 ply 100%Wool (acrylic fabric will not be accepted)
 - (i) pullover style;
 - (ii) knitted mitt
 - (iii) one size fits all.
- 3.6 Cotton Canvas Work Gloves
 - (a) 100% cotton canvas gloves, cream in color;
 - (i) one size fits all.

3.7 Leather/Cotton Work Gloves

- (a) Construction shall be:
 - (i) Cowhide or pigskin leather on the palm, fingers and finger tips;
 - (ii) Sewn with100% polyester or a poly/cotton blend thread;
 - (iii) Knuckle protector;
 - (iv) Striped canvas back with minimum two inch (2") starched canvas safety cuff;
 - (v) Elastic sewn on inside of back;
 - (vi) Cotton fleece lining on palm (fingers will also be acceptable) secured in glove (acrylic fabric will not be accepted);
 - (vii) Size: large
- 3.8 Appendix A:
 - (a) Glove Sizing, should be used as a tool to measure sizing of gloves required for the City of Winnipeg.

4. ORDERS

- 4.1 The Contractor shall provide a local Winnipeg, or toll-free, telephone number facsimile number at which orders may be placed.
- 4.2 The Contractor shall make provisions to receive orders, by any of the means identified in 4.1 above, at all times between 8:30 a.m. and 4:30 p.m. on Business Days.

5. DELIVERY

- 5.1 Goods shall be delivered on an "as-required" basis during the term of the Contract, f.o.b. destination, freight prepaid, to various locations within the City.
- 5.1.1 Goods shall be delivered within five (5) Business Days of the placing of an order, except where otherwise agreed at the time of ordering.
- 5.1.2 The Contractor shall promptly report any delay or change to an agreed delivery date to the User.
- 5.2 Goods shall be delivered between 8:30 a.m. and 2:00 p.m. on Business Days.
- 5.3 The Contractor shall off-load goods as directed at the delivery location.

6. DURATION OF CONTRACT

- 6.1 The Contract shall be for the period of April 1, 2004 to March 31, 2005.
- 6.2 Notwithstanding the foregoing, the City may terminate the Contract upon thirty (30) Calendar Days written notice by the Contract Administrator in the event that operational changes result in substantial changes to the requirement for the goods.

7. ADDENDA

- 7.1 The Buyer may, at any time prior to the Submission Deadline, issue addenda correcting errors, discrepancies or omissions in the Request for Quotation, or clarifying the meaning or intent of any provision therein.
- 7.2 The Buyer will issue each addendum to all Bidders by:
 - (a) publication at the Materials Management Division's Bid Opportunities internet website at http://www.winnipeg.ca/matmgt/bidopp.asp.
- 7.3 The Bidder is responsible for ensuring that he/she has received all addenda and shall acknowledge receipt of each addendum on the Request for Quotation cover page. Failure to acknowledge receipt of an addendum may render a Bid non-responsive.
- 7.3.1 The Bidder is advised to check the Materials Management Division's Bid Opportunities internet website for addenda shortly before submitting his/her Bid.

8. BID SUBMISSION

- 8.1 The Bid Submission consists of the following components:
 - (a) Request for Quotation cover page completed and signed;
 - (b) Form B: Prices;
- 8.2 Bids may be submitted by:
 - (a) mail, courier or personal delivery to the address shown on the Request for Quotation cover page; or
 - (b) facsimile transmission (fax) to (204) 949-1178.
- 8.2.1 The Bidder is advised that the City cannot take responsibility for the availability of the facsimile machine at any time.
- 8.2.2 Bids submitted by internet electronic mail (e-mail) will not be accepted.

9. PRICES

- 9.1 The Bidder shall state a price in Canadian funds for each item of the Work identified on Form B: Prices.
- 9.2 Prices shall be fixed for the duration of the Contract except for changes stipulated, with amounts and effective dates, in the Bid.
- 9.3 Further to 8.1 of the Terms and Conditions, the City will not consider payment of any charges (e.g., minimum order charges, handling charges, container deposits, etc.), except those imposed after the Submission Deadline by a government or regulatory authority having jurisdiction, unless they are identified and quantified in the Bid.
- 9.4 The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of comparing Bids.
- 9.5 The quantities for which payment will be made to the Contractor shall be determined by the Work actually performed by the Contractor.

10. INVOICES

10.1 The Contractor shall submit invoices to the locations designated at the time of ordering.

- 10.2 Invoices must clearly indicate, as a minimum:
 - (a) the City's Purchase Order (PO) number or Standing Purchase Order Release Authorization (SPORA or RA) number, if issued;
 - (b) shipping date(s);
 - (c) delivery address(s);
 - (d) description, quantity and unit price(s) of goods delivered;
 - (e) total amount payable with GST and PST, where applicable, shown as separate amounts; and
 - (f) where applicable, the Contractor's GST registration number.
- 10.3 The City will bear no responsibility for delays in approval of invoices that are improperly submitted.

11. RECORDS

- 11.1 The Contractor shall keep detailed records of the goods supplied under the Contract.
- 11.2 The Contractor shall record, as a minimum, for each item listed on Form B: Prices:
 - (a) User name(s) and addresses;
 - (b) order date(s);
 - (c) delivery date(s); and
 - (d) description and quantity of goods supplied.
- 11.3 The Contractor shall provide the Contract Administrator with a copy of the records for each quarter year within fifteen (15) Calendar Days of the end of that quarter.

12. WARRANTY

- 12.1 The Contractor warrants that the goods will be free of any and all defects or deficiencies for a period of one (1) year from the date of delivery to and acceptance by the City.
- 12.2 Upon notification by the User, the Contractor shall, at his/her sole cost and expense, remedy any defect or deficiency identified by the User during the warranty period and any damage that may arise or result from the defect or deficiency or as a result of the correction of same.

13. EVALUATION CRITERIA

13.1 Award of this Contract will be based on the following evaluation criteria:


(a)	conformance of the Bid with the requirements of the RFQ	pass/fail;
(b)	qualifications of the Bidder pursuant to 1.10 of the Terms and Conditions	pass/fail;
(c)	total contract price	100%.

- 13.2 Further to 13.1(a), the Bidder shall, within two (2) Business Days of a request by the Buyer, provide representative samples of the goods offered.
- 13.3 Further to 13.1(b), the Bidder shall:
 - (a) submit, within two (2) Business Days of a request by the Buyer, proof satisfactory to the Buyer of the qualifications of the Bidder and of any proposed subcontractor;
 - (b) provide, on the request of the Buyer, full access to any of the Bidder's equipment and facilities to confirm, to the Buyer's satisfaction, that the Bidder's equipment and facilities are adequate to perform the Work.
- 13.4 Further to 13.1(c), total contract price will be evaluated on the basis of the approximate quantities shown on Form B: Prices considering early payment discounts if offered.
- 13.5 Evaluation of the thickness of leather items will be determined by using a Mitutoyo Thickness Gauge, Model Number PK-0505.

14. AWARD OF CONTRACT

- 14.1 Further to 1.11 of the Terms and Conditions, this Contract may be awarded as a whole (Alternative 1) or separately by item (Alternative 2) as identified on Form B: Prices.
- 14.2 The Bidder may, but is not required to, bid on both alternatives, or on any one or more items in Alternative 2.
- 14.3 The City shall not be obligated to award any item to the responsible Bidder submitting the lowest evaluated responsive Bid for that item and shall have the right to choose the alternative which is in its best interests. If the Bidder has not bid on both alternatives or on all items in Alternative 2, he/she shall have no claim against the City if his/her partial Bid is rejected in favour of an award of the Contract on the basis of an alternative or item upon which he/she has not bid.

APPENDIX A: Glove Sizing



GLOVE SIZING:

Measure around the hand at the fullest part (exclude thumb)

- Next, measure from the tip of the middle finger to the base of the hand
- Use the LARGEST of these two measurements for the correct size glove
- If you are RIGHT handed, take measurements from your RIGHT hand
- If you are LEFT handed, take measurements from your LEFT hand
- The number of inches measured equals the size of the glove (example: A 7" measurement equals a size 7 glove)
