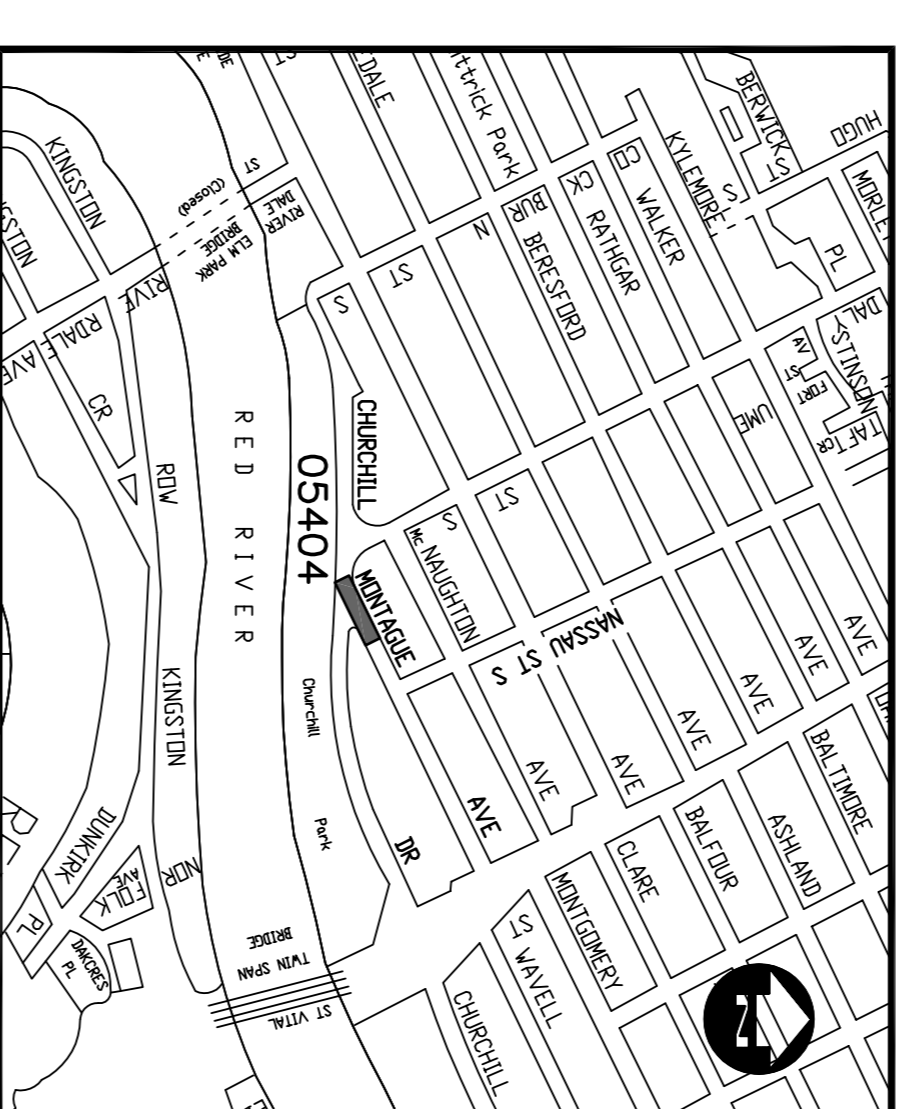
LOCATION PLAN



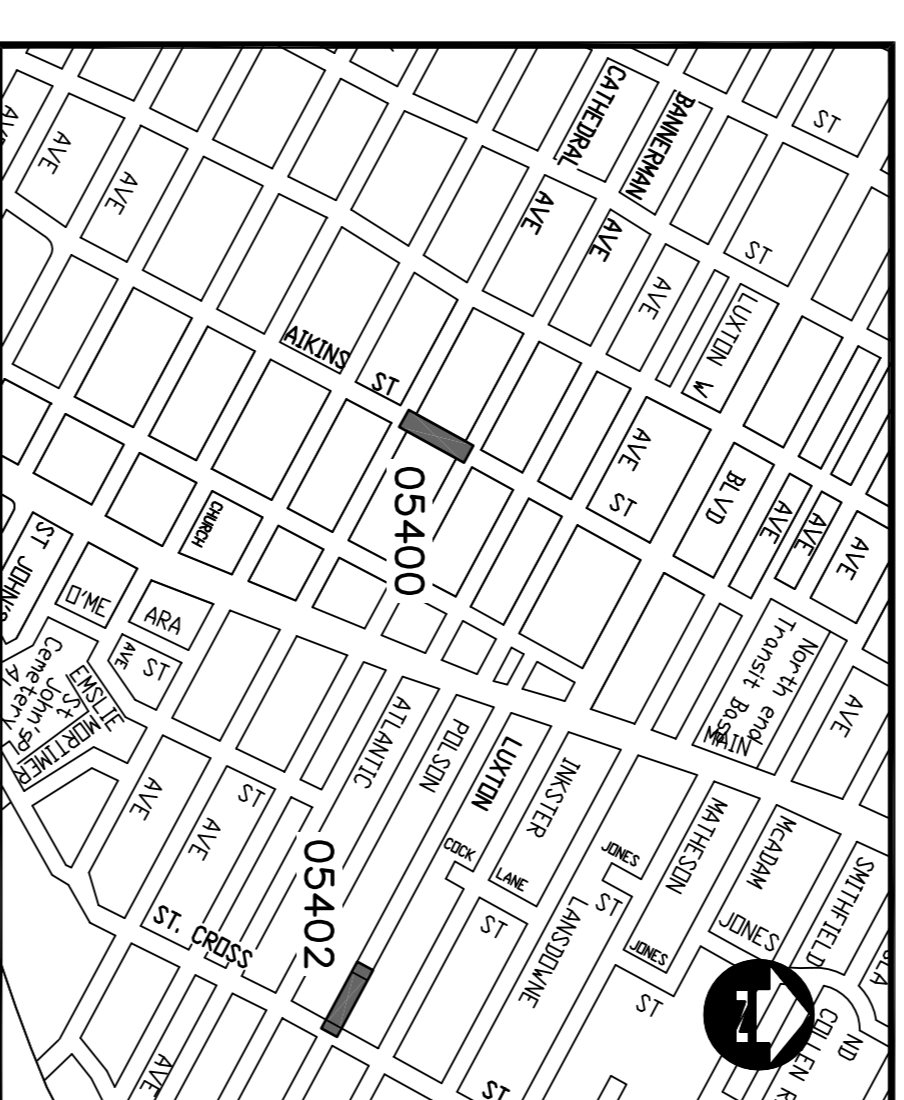
LOCATION PLAN



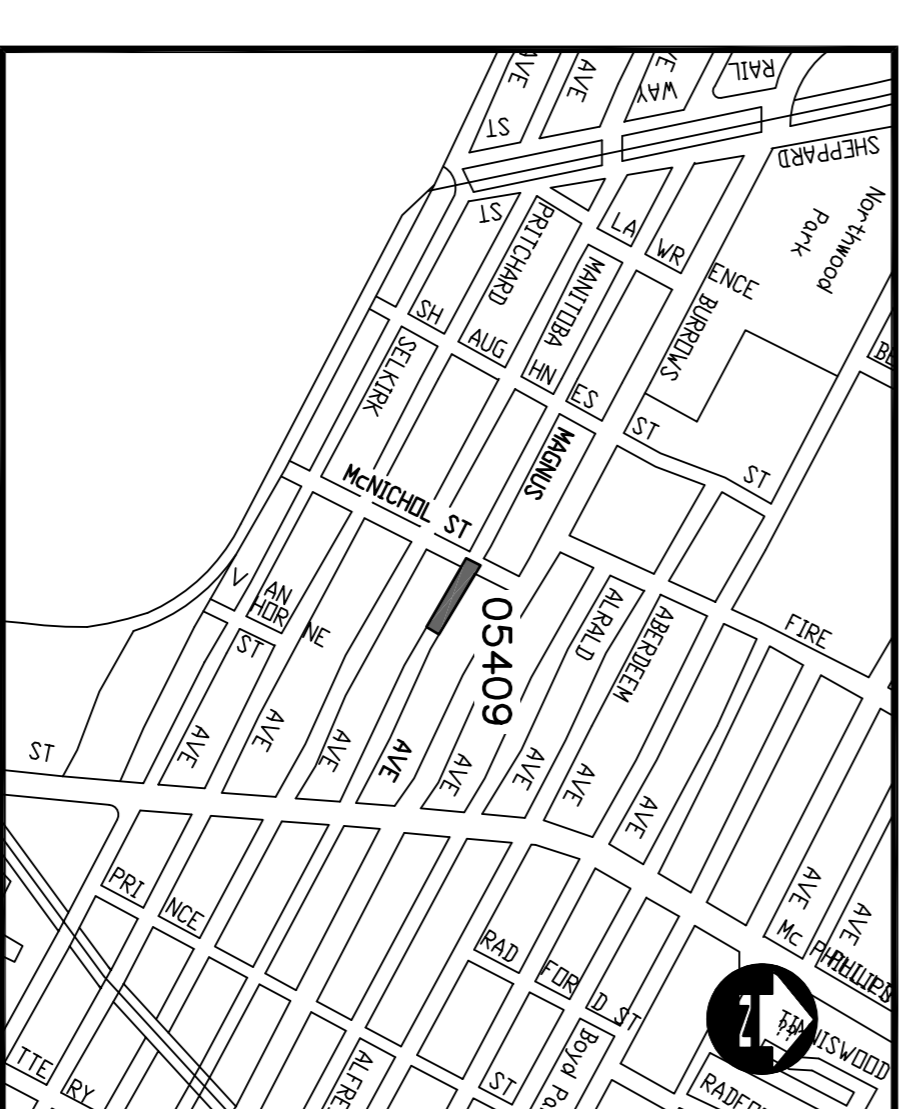

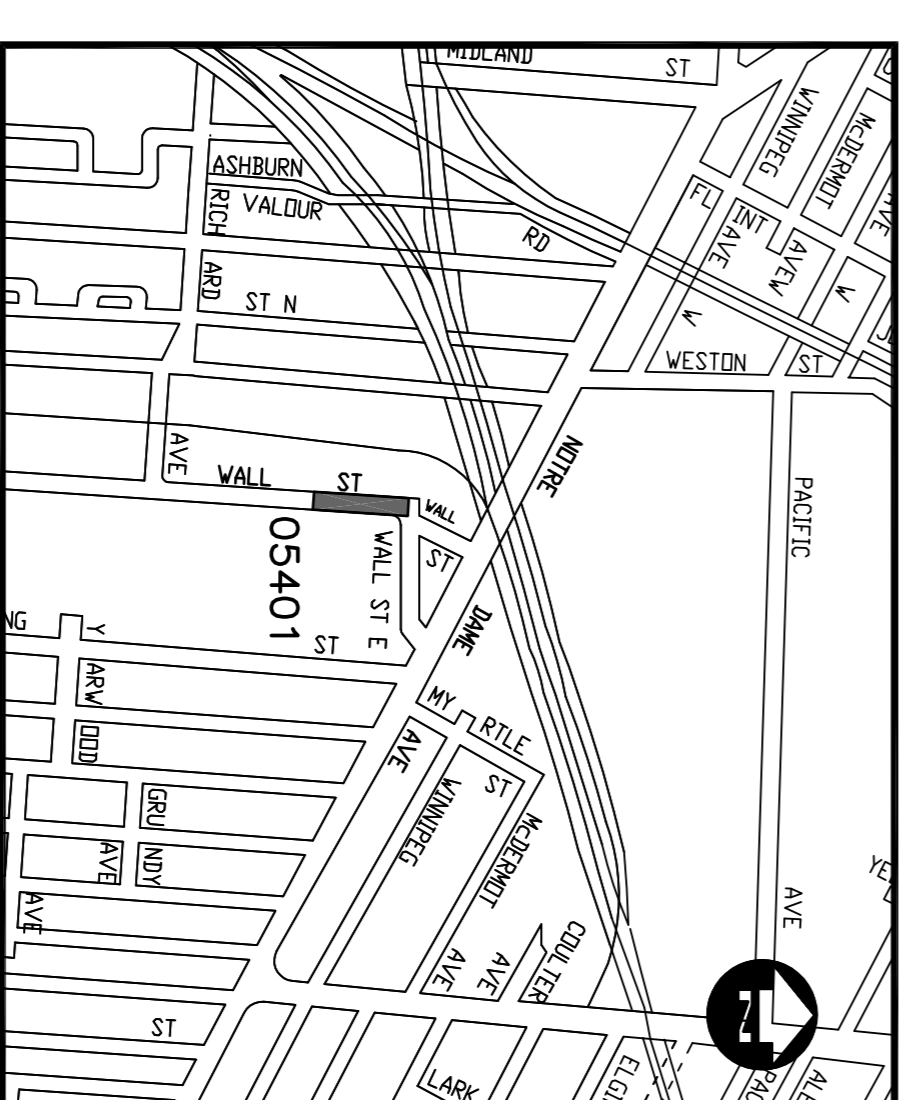
