E2. EXCAVATION AND BACKFILL

- E2.1 Disposal of Unsuitable or Surplus Excavated Material
 - (a) If the contractor has not arranged for an approved disposal site, the City shall provide an optional disposal site for all surplus clean clay, concrete and/or asphalt from the construction site. The material is not to include any refuse, rebar, metals, wood, organics, construction waste or any other deleterious materials. Any surplus soil material not meeting these requirements shall not be considered clean clay and/or pavement and shall not be permitted.
 - (b) The disposal location provided by the City will be at the Summit Road Landfill Site. The Contract Administrator will make arrangements with Colin Potter (986-4463) at the landfill site for disposal of the surplus material.
 - (c) There will be no tipping fees charged at the landfill site to the Contractor for the disposal of surplus soil material meeting the requirements of clean clay as specified.
 - (d) Surplus material not meeting the requirements of clean clay may be disposed of at the Brady Road Landfill Site although tipping fees will be charged.
