

GENERAL REMOVALS:

- 1. Refer to Specifications for description of Site Removals and Salvage items.
- 2. All Existing Trees to be protected unless noted as removal item. Refer to Specifications.

ENTRY AREA REMOVALS:

- 1. Refer to C101 for Sidewalk, Curb, and Paver Removals.
- 2. Salvage Pavers for relaying.
- 3. Remove Concrete Tree Well curbs (4) and Trees (4). Protect Existing Trees on North
- 4. Remove and Salvage Metal Mesh Benches and "Take Pride" Waste Receptacles.
- 5. Remove Concrete curb and Pavers in Median at Existing 'Gate' Structure.

MEDIAN AREA REMOVALS:

- 1. Remove and Salvage Existing Bench, Concrete Planter, and Waste Receptacles.
- 2. Remove and Salvage Existing 600x600mm Concrete Pavers.
- 3. Remove Existing Plant Material in shrub beds and Stumps.
- 4. Trees to remain undisturbed.

BOULEVARD REMOVALS:

- Remove and Salvage Existing Metal Mesh Benches and "Take Pride" Waste Receptacles.
- 2. Metal Fence to be Removed, Repaired, and Refinished Off-site. Locations shown on L1, L2, and L3.
- 3. Existing Fence Footings, Tree Well curbs, and Trees to be Removed at 174 Provencher Boulevard (Shell Canada).
- 4. Refer to L1 for locations of Timber Fence Removals.
- 5. Three (3) Existing Trees to be Removed, Tree Well curbs to Remain. Refer to L1, L2, and L3 locations.
- 7. Existing Concrete Tree Grates to be Removed at all Tree Well locations.
