


- REPLACE ALL FLEXIBLE CONDUIT WITH RIGID CONDUIT.
- RELOCATE PRESSURE SWITCH TO STRUT AND COVER HOLES IN VENTILATION DUCT.



- REPLACE EXISTING LIMIT SWITCHES. INSTALL EYS SEAL FOR NEW LIMIT SWITCHES. REFER TO DETAIL 4 FOR TYPICAL CLOSEUP SEE DRAWINGS SEP-1193, SEP-1195, AND SEP-1197 FOR WIRING DETAILS.

SPECIFIC NOTES:

- INSTALL DUCT SEAL IN EXISTING CONDUIT AT THE FIRST CONDUIT BODY OR JUNCTION BOX WITHIN THE HAZARDOUS AREA (ESTIMATED NUMBER OF LOCATIONS : 5).
- EXISTING PANEL PCP-3 CONTAINS ONLY SOLENOID VALVES AND IS ACCEPTABLE FOR THE NEW AREA CLASSIFICATION.



- REPLACE EXISTING EXIT FIXTURE
