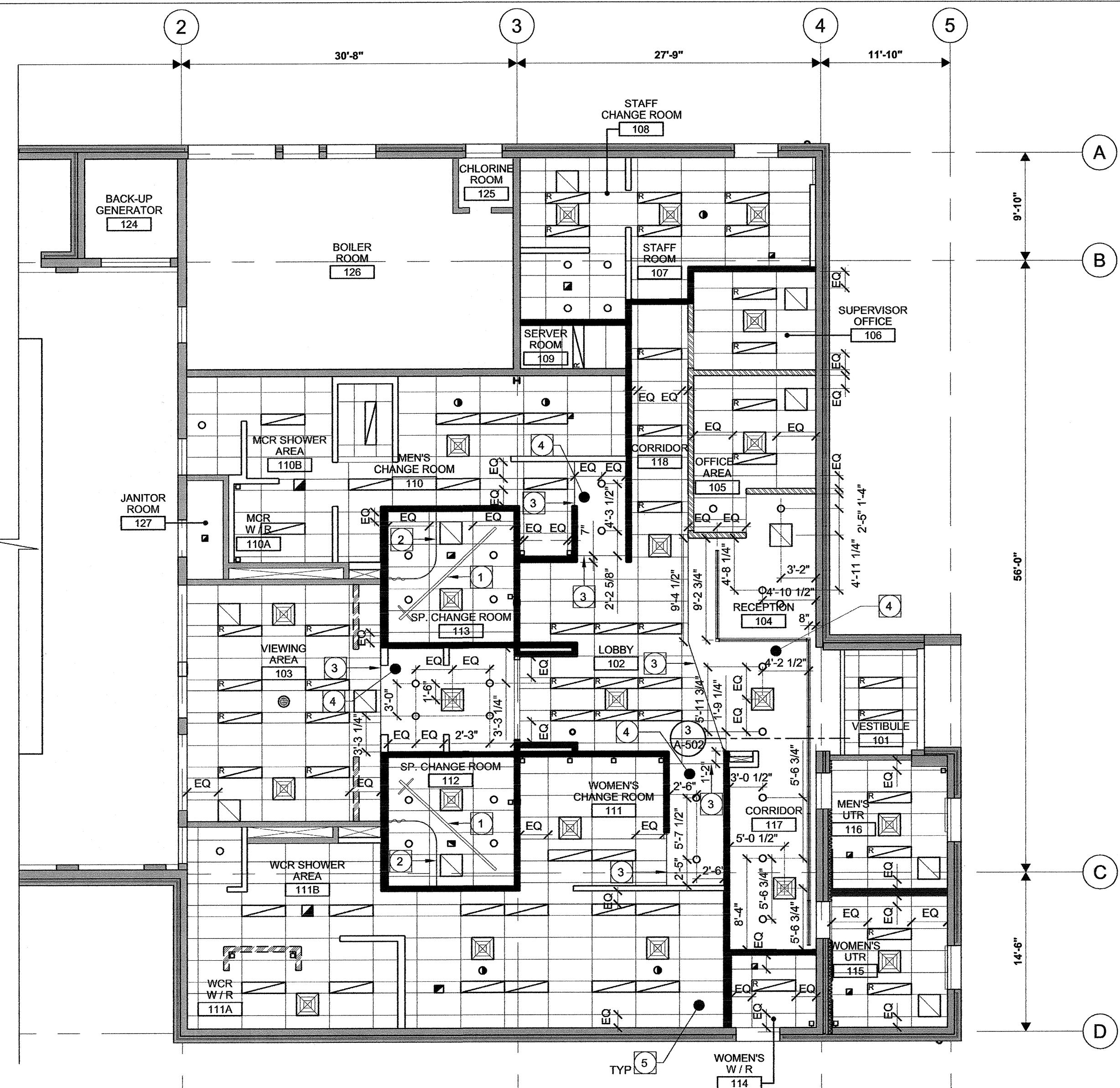

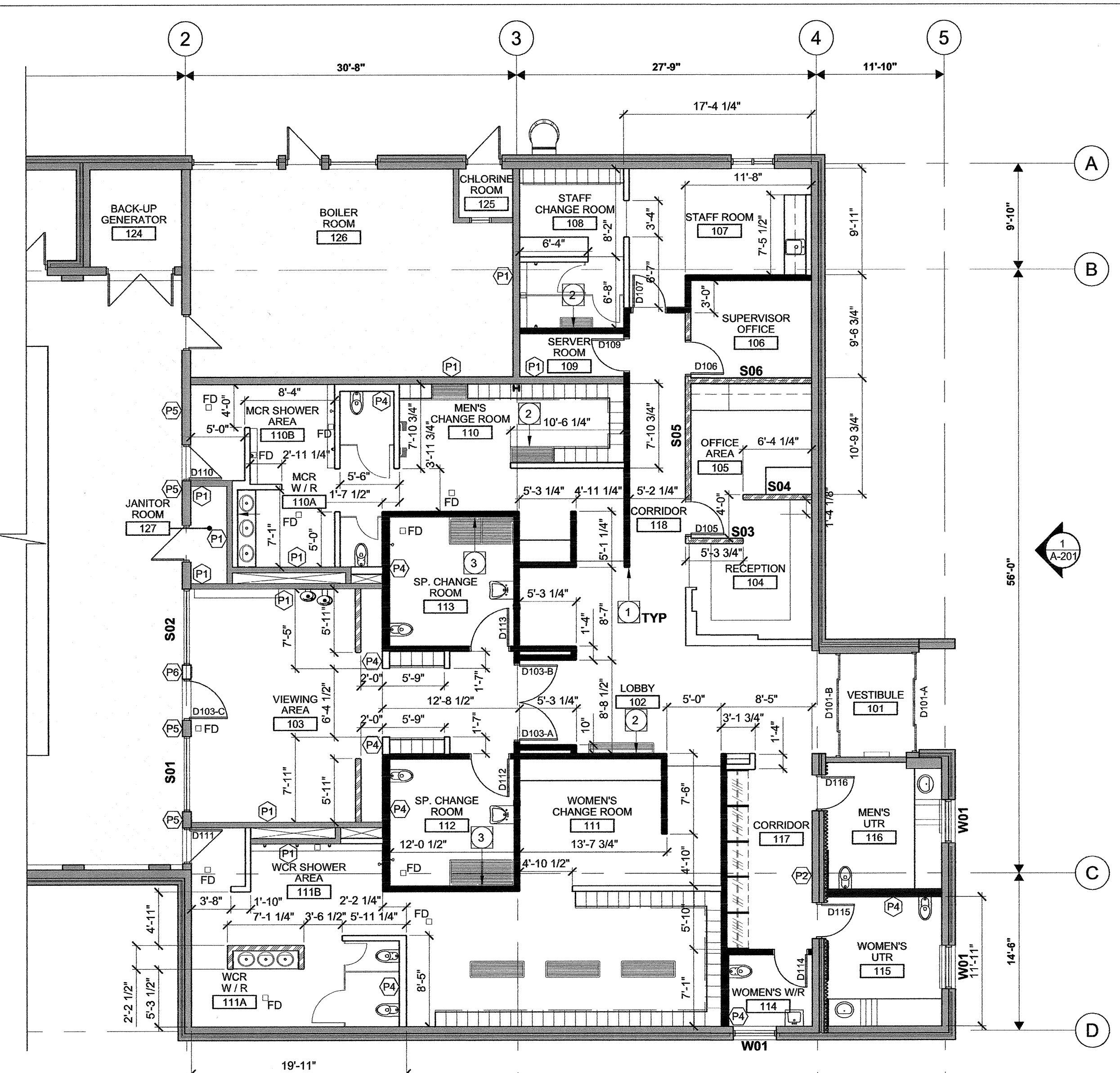
2 RENOVATION REFLECTED CEILING PLAN

REFLECTED CEILING PLAN RENOVATION NOTES:

- 1 CEILING HUNG BARIATRIC HOIST SECURED TO STRUCTURE ABOVE
- 2 SHOWER CURTAIN AND TRACK
- 3 LINE OF SUSPENDED GWB CEILING
- 4 SUSPENDED CEILING GWB @ 8'-7" ABOVE STRUCTURAL CONCRETE SLAB
- 5 ACT @ 9'-0" ABOVE STRUCTURAL CONCRETE SLAB

NEW PARTITION HEIGHT SCHEDULE

- CONCRETE BLOCK WALL TO U/S OF STEEL DECK
- CONCRETE BLOCK WALL TO 1 COURSE ABOVE ACT CEILING

2. REFER TO A-401 FOR ENLARGED FLOOR PLAN.
3. REFER TO A-601 FOR FLOOR PATTERN PLAN.
4. REFER TO A-602 FOR FLOOR DRAIN SLOPES PLAN.
5. DIMENSIONS AND LOCATIONS OF EXISTING BUILDING ELEMENTS ARE APPROXIMATE. NOTIFY THE CONTRACT ADMINISTRATOR WHEN DISCREPANCIES ARE FOUND BETWEEN DRAWINGS AND ACTUAL SITE CONDITION FOR COORDINATION AND CLARIFICATION.
6. DIMENSIONS ARE IN INCHES UNLESS NOTED OTHERWISE.
7. COORDINATE NEW INTERIOR RENOVATION WORK WITH MECHANICAL/ELECTRICAL AND STRUCTURAL DRAWINGS.
8. NOTE THAT ARCHITECTURAL DRAWINGS GOVERN OVER ALL DRAWINGS HEREIN AND DISCREPANCIES ARE TO BE COORDINATED WITH THE CONTRACT ADMINISTRATOR PRIOR TO CONSTRUCTION.
9. PATCH AND MAKE GOOD EXISTING WALLS AFFECTED BY CONSTRUCTION. PAINT TO MATCH ADJACENT SURFACES.
10. REFER TO G-001 FOR PARTITIONS WITH FIRE RESISTANCE RATING.

- 1 PROVIDE SINGLE/DOUBLE BULLNOSE EDGE CMU AT NEW CONCRETE BLOCK WALL ENDS AND CORNERS. REFER TO A-401 FOR LOCATION.
- 2 PROVIDE 2 COURSES OF FULLY GROUTED CONCRETE MASONRY UNITS AT WALL MOUNTED BENCHES LOCATION.
- 3 PROVIDE 4 COURSES OF FULLY GROUTED CONCRETE MASONRY UNITS AT WALL MOUNTED BENCHES LOCATION.

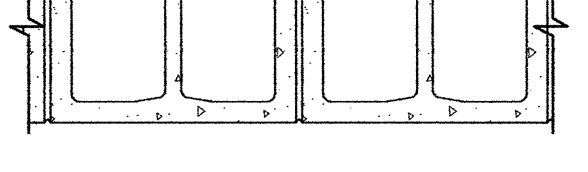
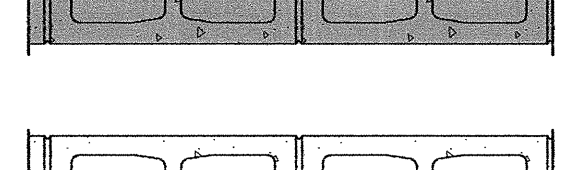
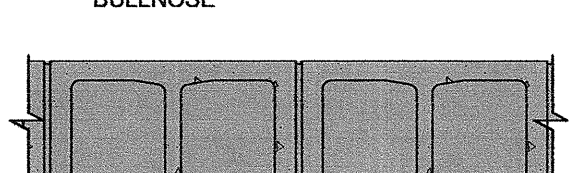
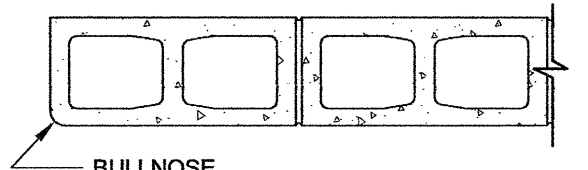
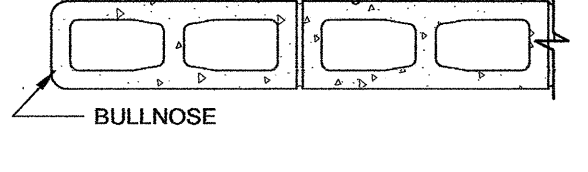
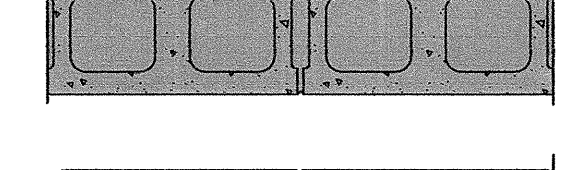
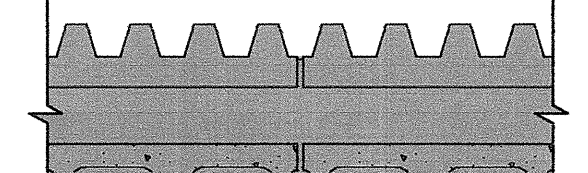
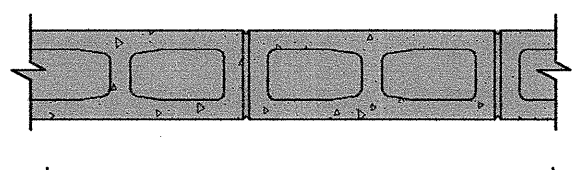
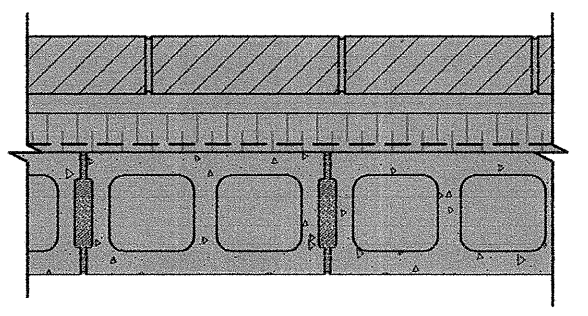
