PART B - BIDDING PROCEDURES

B1. CONTRACT TITLE

B1.1 REQUEST FOR PROPOSAL FOR PROFESSIONAL CONSULTING SERVICES FOR SELKIRK AVENUE FROM ARLINGTON STREET TO SALTER STREET – 2015-2016 WATERMAIN RENEWAL AND PAVEMENT RECONSTRUCTION

B2. SUBMISSION DEADLINE

- B2.1 The Submission Deadline is 4:00 p.m. Winnipeg time, April 17, 2015.
- B2.2 Proposals determined by the Manager of Materials to have been received later than the Submission Deadline will not be accepted and will be returned upon request.
- B2.3 The Project Manager or the Manager of Materials may extend the Submission Deadline by issuing an addendum at any time prior to the time and date specified in B2.1.

B3. ENQUIRIES

- B3.1 All enquiries shall be directed to the Project Manager identified in D2.
- B3.2 If the Proponent finds errors, discrepancies or omissions in the Request for Proposal (RFP), or is unsure of the meaning or intent of any provision therein, the Proponent shall promptly notify the Project Manager of the error, discrepancy or omission at least five (5) Business Days prior to the Submission Deadline.
- B3.3 If the Proponent is unsure of the meaning or intent of any provision therein, the Proponent should request clarification as to the meaning or intent prior to the Submission Deadline.
- B3.4 Responses to enquiries which, in the sole judgment of the Project Manager, require a correction to or a clarification of the RFP will be provided by the Project Manager to all Proponents by issuing an addendum.
- B3.5 Responses to enquiries which, in the sole judgment of the Project Manager, do not require a correction to or a clarification of the RFP will be provided by the Project Manager only to the Proponent who made the enquiry.
- B3.6 All correspondence or contact by Proponents with the City in respect of this RFP must be directly and only with the City's Project Manager. Failure to restrict correspondence and contact to the Project Manager may result in the rejection of the Proponents Proposal Submission.
- B3.7 The Proponent shall not be entitled to rely on any response or interpretation received pursuant to B3 unless that response or interpretation is provided by the Project Manager in writing.

B4. CONFIDENTIALITY

- B4.1 Information provided to a Proponent by the City or acquired by a Proponent by way of further enquiries or through investigation is confidential. Such information shall not be used or disclosed in any way without the prior written authorization of the Project Manager. The use and disclosure of the confidential information shall not apply to information which:
 - (a) was known to the Proponent before receipt hereof; or
 - (b) becomes publicly known other than through the Proponent; or
 - (c) is disclosed pursuant to the requirements of a governmental authority or judicial order.

B4.2 The Proponent shall not make any statement of fact or opinion regarding any aspect of the Request for Proposals to the media or any member of the public without the prior written authorization of the Project Manager.

B5. ADDENDA

- B5.1 The Project Manager may, at any time prior to the Submission Deadline, issue Addenda correcting errors, discrepancies or omissions in the Request for Proposal, or clarifying the meaning or intent of any provision therein.
- B5.2 The Project Manager will issue each addendum at least two (2) Business Days prior to the Submission Deadline, or provide at least two (2) Business Days by extending the Submission Deadline.
- B5.2.1 Addenda will be available on the Bid Opportunities page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/bidopp.asp
- B5.2.2 The Bidder is responsible for ensuring that it has received all Addenda and is advised to check the Materials Management Division website for Addenda regularly and shortly before the Submission Deadline, as may be amended by addendum.
- B5.3 The Bidder shall acknowledge receipt of each addendum in Paragraph 9 of Form A: Proposal. Failure to acknowledge receipt of an addendum may render a Proposal non-responsive.

B6. PROPOSAL SUBMISSION

- B6.1 The Proposal shall consist of the following components:
 - (a) Form A: Proposal (Section A) in accordance with B7;
 - (b) Form B: Prices (Section B) in accordance with B8;
- B6.2 The Proposal should also consist of the following components:
 - (a) Management Proposal Consultant and Subconsultant(s) (Section C), in accordance with B9:
 - (b) Management Proposal Project Team (Section D) in accordance with B10; and
 - (c) Technical Proposal (Section E) in accordance with B11;
 - (d) Project Schedule (Section F) in accordance with B12.
- B6.3 Further to B6.1, all components of the Proposal shall be fully completed or provided in the order indicated, and submitted by the Proponent no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Proposal.
- B6.4 Further to B6.2, all components of the Proposal should be fully completed or provided in the order indicated, and submitted by the Proponent no later than the Submission Deadline, with all required entries made clearly and completely, to constitute a responsive Proposal.
- B6.5 Proponents should submit one (1) unbound 8.5" x 11" original (marked "original") including drawings and six (6) copies (copies can be in any size format) for sections identified in B6.1 and B6.2.
- B6.5.1 Further to B6.5, the Proposal shall be submitted on 8.5" x 11" paper; with a font of not less than 11 pt Arial; margins of not less than 0.75"; line-spacing of not less than single; and shall be no more than twenty (20) pages in length, exclusive of the required form(s). Only the first twenty (20) pages of the Proposal will be evaluated;
- B6.5.2 Further to B6.5.1, anything included as an appendix will not be evaluated;
- B6.6 Further to B6.5 and B6.5.1, a total of four (4) of the twenty (20) total pages may be presented on 11" x 17" paper, with the copies only.

- B6.7 Proponents are advised that inclusion of terms and conditions inconsistent with the Request for Proposal, will be evaluated in accordance with B19.1(a).
- B6.8 The Proposal shall be submitted enclosed and sealed in an envelope/package clearly marked with the RFP number and the Proponent's name and address.
- B6.9 Proposals submitted by facsimile transmission (fax) or internet electronic mail (e-mail) will not be accepted.
- B6.10 Proposals shall be submitted to:

B6.11 Any cost or expense incurred by the Proponent that is associated with the preparation of the Proposal shall be borne solely by the Proponent.

B7. PROPOSAL (SECTION A)

- B7.1 The Proponent shall complete Form A: Proposal, making all required entries.
- B7.2 Paragraph 2 of Form A: Proposal shall be completed in accordance with the following requirements:
 - (a) if the Proponent is a sole proprietor carrying on business in his/her own name, his/her name shall be inserted:
 - (b) if the Proponent is a partnership, the full name of the partnership shall be inserted;
 - (c) if the Proponent is a corporation, the full name of the corporation shall be inserted;
 - (d) if the Proponent is carrying on business under a name other than his/her own, the business name and the name of every partner or corporation who is the owner of such business name shall be inserted.
- B7.2.1 If a Proposal is submitted jointly by two or more persons, each and all such persons shall identify themselves in accordance with B7.2.
- B7.3 In Paragraph 3 of Form A: Proposal, the Proponent shall identify a contact person who is authorized to represent the Proponent for purposes of the Proposal.
- B7.4 Paragraph 11 of Form A: Proposal shall be signed in accordance with the following requirements:
 - (a) if the Proponent is a sole proprietor carrying on business in his/her own name, it shall be signed by the Proponent;
 - (b) if the Proponent is a partnership, it shall be signed by the partner or partners who have authority to sign for the partnership;
 - (c) if the Proponent is a corporation, it shall be signed by its duly authorized officer or officers and the corporate seal, if the corporation has one, should be affixed;
 - (d) if the Proponent is carrying on business under a name other than its own, it shall be signed by the registered owner of the business name, or by the registered owner's authorized officials if the owner is a partnership or a corporation.
- B7.4.1 The name and official capacity of all individuals signing Form A: Proposal should be printed below such signatures.
- B7.5 If a Proposal is submitted jointly by two or more persons, the word "Proponent" shall mean each and all such persons, and the undertakings, covenants and obligations of such joint Proponents in the Proposal and the Contract, when awarded, shall be both joint and several.

B8. FEES (SECTION B)

- B8.1 The Proponent shall complete Form B: Prices, summarizing all applicable Fees.
- B8.2 The Proposal shall include the total Fees for all disciplines, identified and necessary, for all disciplines and/or phases identified in D4 Scope of Services including:
- B8.3 Fees shall be presented as follows:
 - (a) Project planning and Preliminary Design;
 - (b) Detailed Design and Contract (Bid Opportunity) Preparation;
 - (c) Contract Administration services:
 - (d) Post-Construction services; and
 - (e) Other Project Costs.
- B8.3.1 Further to B8.3, separate Fee schedules shall be presented for each of:
 - (a) Surface Works
 - (b) Underground Works
- B8.4 Adjustments to Fees will only be considered based on increases or decreases to the Scope of Services approved by the Project Manager.
- B8.4.1 The City will not consider an adjustment to the Fees based on changes in the Project budget or the Final Total Construction Cost.
- B8.5 Notwithstanding C1.1(b), Fees shall include costs for out of town travel, related meals and accommodations for the duration of the Project and shall not be considered an Allowable Disbursement.
- B8.6 The Fees presented shall include an allowance of up to 8% for Allowable Disbursements as defined in C1.1(b), but shall exclude the costs included in B8.4. No other disbursements will be permitted.
- B8.6.1 Further to D11.2(c)(iii) and D11.2(c)(iv), the Allowable Disbursements shall be identified separately on each invoice.
- B8.7 The Fees shall include a fixed allowance as per B8.13 for Other Project Costs for subconsultants and/or services such as site investigation (geotechnical) services, materials testing services, Underground Structures acquisitions, pipeline loading assessments, closed circuit television (CCTV) sewer inspection, total coliform, HPC testing, and/or hazardous materials investigation.
- B8.7.1 Further to D11, Fees may include an allowance of up to 5% for handling charges for the invoices for Other Project Costs.
- B8.7.2 Further to B8.7, the Proposal should include a description of all assumed Other Project Costs.
- B8.8 The Proposal shall include the Fees to be assessed for Engineering and other Services as defined in D4, Scope of Services. The Fees must be included in the Proposal with descriptions.
- B8.9 The Fees associated with Preliminary Design shall:
 - (a) be a Fixed Fee;
 - (b) include Allowable Disbursements:
- B8.10 The Fees associated with Detailed Design shall:
 - (a) be a Fixed Fee;
 - (b) include Allowable Disbursements;

- B8.11 The Fees associated with Contract Administration shall:
 - (a) be a Total Maximum based on Hourly Rates;
 - (i) Surface Works: use 85 construction contract Working days;
 - (ii) Underground works: use 30 construction contract Working Days for each contract (total of 60).
 - (b) include Allowable Disbursements;
 - (c) include Fees for supervision of any services anticipated in D5.3.2;
- B8.12 The Fees associated with Post-Construction Services shall:
 - (a) be a Total Maximum based on Hourly Rates;
 - (b) include Allowable Disbursements;
- B8.13 The Fees associated with Other Project Costs shall be:
 - (a) A fixed allowance of:
 - (i) \$240,000.00 for Surface Works contracts;
 - (ii) \$20,000.00 for Underground Works contracts.
 - (b) As per B8.7.1, include a maximum 5% handling fee;
 - (c) As per B8.7.2, include a list and cost breakdown of assumed Other Project Costs.
- B8.14 Notwithstanding C10.1, Fees submitted shall not include the Goods and Services Tax (GST) or Manitoba Retail Sales Tax (MRST, also known as PST), which shall be extra where applicable.
- B8.15 Payments to Non-Resident Consultants are subject to Non-Resident Withholding Tax pursuant to the Income Tax Act (Canada).

B9. MANAGEMENT PROPOSAL – CONSULTANT AND SUBCONSULTANT(S) (SECTION C)

- B9.1 The Management Proposal should describe the experience of the Proponent and any Subconsultants, including:
 - (a) general firm profile information, including years in business, average volume of work, number of employees, including local office information, and other pertinent information for the Proponent and all Subconsultants;
 - (b) details demonstrating the history and experience of the Proponent and Subconsultants in providing design, management of construction and contract administration services on a minimum of:
 - (i) two Watermain Renewal projects of similar size and complexity; and
 - (ii) two Pavement Reconstruction projects of similar size and complexity.
- B9.2 For each project listed in B9.1(b), the Proponent should submit:
 - (a) description of the project;
 - (b) role of the consultant;
 - (c) project's original contracted construction cost and final construction cost;
 - (d) design and construction schedule (anticipated Project schedule and actual project delivery schedule, showing design and construction separately);
 - (e) project owner.
- B9.2.1 Where applicable, information should be separated into Proponent and Subconsultant project listings.
- B9.2.2 Reference information (two current names with telephone numbers per project) must be made available upon request of the Project Manager.

B10. MANAGEMENT PROPOSAL – PROJECT TEAM (SECTION D)

- B10.1 Proponent's project management approach:
 - (a) Proposals should include a methodology describing your team's project management approach and organization during the performance of Services, so that the evaluation committee has a clear understanding of the methods the Proponent and Subconsultant(s) will use in the delivery of this Project.
 - (b) Methodology should identify:
 - job function for each identified individual and group of individuals identified in B10.2(a);
 - (ii) shall include time estimates by work activity and in total, including hourly rates, for each person identified in B10.2(a). Time estimates should also include all staff associated with the project including survey, drafting, clerical and any other support staff. Hourly rates are not required for staff not identified in B10.2(a);
 - (iii) an organizational chart for the Project.
- B10.2 Proposals should include, in tabular form:
 - (a) names of key personnel assigned to the Project, who shall not to be substituted without written permission from the Project Manager;
 - (b) the experience and qualifications of the key personnel assigned to the Project, including:
 - job title;
 - educational background and degrees;
 - professional affiliation;
 - years of experience administering projects for the City of Winnipeg;
 - years of experience in current position;
 - years of experience in design; and
 - years of experience in construction administration.
 - (c) for each person identified, list the percentage of their time to be dedicated to the Project.

 Provide this information for each of the phases identified in D4 Scope of Services.
 - (d) roles of each of the key personnel in the Project should be identified in the organizational chart presented in B10.1(b)(ii);
- B10.3 Proposals should include, for each person identified in B10.2(a), a list of at least two projects for each type of work to be performed in D5.1 (i.e. either watermain work, roadwork or both), comparable in complexity, in which the person listed did comparable work and played a comparable role. Provide the following:
 - (a) description of project;
 - (b) role of the person;
 - (c) project owner
- B10.4 Further to B10.3, and upon request of the Project Manager, the Proponent must be able to provide, for each person identified in B10.2(a), two current references, including telephone numbers, for each project listed.
- B10.5 Where applicable, information should be separated into Proponent and Subconsultant project listings.
- B10.6 Proposals may also address any other information that conveys the Proponent's understanding of the Project requirements.

B11. TECHNICAL PROPOSAL (SECTION E)

B11.1 The Technical Proposal should address the deliverables and associated task requirements required by the Scope of Services. It should clearly identify and explain work activities and identify all assumptions and interpretations.

B11.2 Specifically, Proposals should describe:

- (a) the Proponent's practical understanding of the Project, specifically:
 - the team's understanding of the broad functional and technical requirements and urban design issues;
 - (ii) the team's understanding of the proposed Project Budget and Capital Construction Estimate:
- (b) the Proponent's technical approach and methodology to complete the Services;
- (c) the collaborative process/method to be used by the team in the various phases of the Project;
- (d) any location specific issues;
- (e) all activities and services to be provided by the City;
- (f) the deliverable(s) of the Project;
- (g) any assumptions made with respect to the deliverables and Scope of Services.
- B11.3 Methodology should be presented in accordance with the Scope of Service phases as defined in D4, as well as in PART F SPECIFICATIONS, PART G SCOPE OF ENGINEERING SERVICES, and Appendix A Definition of Professional Consulting Services Engineering.

B12. PROJECT SCHEDULE (SECTION F)

- B12.1 Proponents should present a carefully considered Critical Path Method schedule using Microsoft Project or similar project management software, complete with resource assignments (key designers), durations (weekly timescale) and milestone dates or events. The schedule should address each requirement of the Scope of Services.
- B12.2 The Proponent's schedule should include critical dates for review and approval processes by the City and other organizations anticipated during the design and tendering phases of the Project. Reasonable times should be allowed for completion of these processes, not exceeding the Critical Dates specified in D10.

B13. QUALIFICATION

- B13.1 The Proponent shall:
 - (a) undertake to be in good standing under The Corporations Act (Manitoba), or properly registered under The Business Names Registration Act (Manitoba), or otherwise properly registered, licensed or permitted by law to carry on business in Manitoba, or if the Proponent does not carry on business in Manitoba, in the jurisdiction where the Proponent does carry on business; and
 - (b) be financially capable of carrying out the terms of the Contract;
 - (c) have all the necessary experience, capital, organization, and equipment to perform the Services in strict accordance with the terms and provisions of the Contract;
 - (d) have or establish and staff an office in Winnipeg for the duration of the Project.
- B13.2 The Proponent and any proposed Subconsultant (for the portion of the Services proposed to be subcontracted to them) shall:
 - (a) be responsible and not be suspended, debarred or in default of any obligations to the City. A list of suspended or debarred individuals and companies is available on the Information

- B13.3 The Proponent and/or any proposed Subconsultant (for the portion of the Services proposed to be subcontracted to them) shall:
 - (a) have successfully carried out services for the programming; design, management of construction and contract administration for architectural and/or engineering projects of similar complexity, scope and value; and to those required for this Project; and
 - (b) be fully capable of performing the Services required to be in strict accordance with the terms and provisions of the Contract; and
 - (c) have a written workplace safety and health program, if required, pursuant to The Workplace Safety and Health Act (Manitoba);
 - (d) have the knowledge and resources to administer the requirements of The Workplace Safety and Health Act (Manitoba) during the construction works associated with this Contract; and
 - (e) undertake to meet all licensing and regulatory requirements of the appropriate governing authorities and associations in the Province of Manitoba.
 - (f) upon request of the Project Manager the Security Clearances as identified in PART E .
- B13.4 The Proponent shall submit, within three (3) Business Days of a request by the Project Manager, further proof satisfactory to the Project Manager of the qualifications of the Proponent and of any proposed Subconsultant.
- B13.5 The Proponent shall provide, on the request of the Project Manager, full access to any of the Proponent's equipment and facilities to confirm, to the Project Manager's satisfaction, that the Proponent's equipment and facilities are adequate to perform the Services.

B14. OPENING OF PROPOSALS AND RELEASE OF INFORMATION

- B14.1 Proposals will not be opened publicly.
- B14.2 After award of Contract, the names of the Bidders and the Contract amount of the successful Bidder will be available on the Closed Bid Opportunities (or Public/Posted Opening & Award Results) page at The City of Winnipeg, Corporate Finance, Materials Management Division website at http://www.winnipeg.ca/matmgt/.
- B14.3 To the extent permitted, the City shall treat all Proposal Submissions as confidential. However, the Proponent is advised that any information contained in any Proposal may be released if required by City policy or procedures, by The Freedom of Information and Protection of Privacy Act (Manitoba), by other authorities having jurisdiction, or by law.
- B14.4 Following the award of Contract, a Proponent will be provided with information related to the evaluation of its submission upon written request to the Project Manager.

B15. IRREVOCABLE OFFER

- B15.1 The Proposal(s) submitted by the Proponent shall be irrevocable for the time period specified in Paragraph 10 of Form A: Proposal.
- B15.2 The acceptance by the City of any Proposal shall not release the Proposals of the other responsive Proponents and these Proponents shall be bound by their offers on such Services until a Contract for the Services has been duly executed as herein provided, but any offer shall be deemed to have lapsed unless accepted within the time period specified in Paragraph 10 of Form A: Proposal.

B16. WITHDRAWAL OF OFFERS

- B16.1 A Proponent may withdraw its Proposal without penalty by giving written notice to the Manager of Materials at any time prior to the Submission Deadline.
- B16.1.1 The time and date of receipt of any notice withdrawing a Proposal shall be the time and date of receipt as determined by the Manager of Materials.
- B16.1.2 The City will assume that any one of the contact persons named in Paragraph 3 of Form A: Proposal or the Proponent's authorized representatives named in Paragraph 11 of Form A: Proposal, and only such person, has authority to give notice of withdrawal.
- B16.1.3 If a Proponent gives notice of withdrawal prior to the Submission Deadline, the Manager of Materials will:
 - (a) retain the Proposal until after the Submission Deadline has elapsed;
 - (b) open the Proposal to identify the contact person named in Paragraph 3 of Form A: Proposal and the Proponent's authorized representatives named in Paragraph 11 of Form A: Proposal; and
 - (c) if the notice has been given by any one of the persons specified in B16.1.3(b), declare the Proposal withdrawn.
- B16.2 A Proponent who withdraws its Proposal after the Submission Deadline but before its offer has been released or has lapsed as provided for in B15.2 shall be liable for such damages as are imposed upon the Proponent by law and subject to such sanctions as the Chief Administrative Officer considers appropriate in the circumstances. The City, in such event, shall be entitled to all rights and remedies available to it at law.

B17. INTERVIEWS

B17.1 The Project Manager may, in his/her sole discretion, interview Proponents during the evaluation process.

B18. NEGOTIATIONS

- B18.1 The City reserves the right to negotiate details of the Contract with any Proponent. Proponents are advised to present their best offer, not a starting point for negotiations in their Proposal Submission.

F2. SEWER TELEVISING GUIDELINES FOR PUBLIC WORKS PROJECTS (JANUARY 2009)

- F2.1 The Consultant is required to assess the extent of Closed Circuit Television (CCTV) inspection for all combined, wastewater, land drainage and storm relief sewers to confirm any sewer repairs required in the right-of-way within the limits of the street renewal.
- F2.2 The criteria provided are general guidelines and are not intended to replace sound municipal engineering judgement specific to the individual Project scope and/or location.
- F2.3 The available sewer televising information is contained within the City of Winnipeg's Sewer Management System (SMS) application.
- F2.4 Confirm televising requirements with Project Manager.
- F2.5 CCTV inspection general guidelines:
 - (a) Confirm CCTV requirements with Water & Waste Department for sewers 1050 mm and larger in diameter;
 - (b) Televise if no previous CCTV inspections have been completed;
 - (c) Re-televise sewers in Categories A/B/C/X with a Structural Performance Grade (SPG) of 3 or higher that have not been televised in the previous 5 years;
 - (d) Sewers located more than two metres from the curb line (i.e. not located under pavement) do not need to be re-televised if previous CCTV inspection data exist. If a sewer repair or renewal requiring excavation is noted, contact the WWD;
 - (e) On all street reconstructions, regardless of location of the sewer (within the right-of-way);
 - (f) If the street exhibits obvious distress at/along the underground plant;
 - (g) Of all CB leads to be reused, as part of a street reconstruction or major rehabilitation.
- F2.6 For any uncertain situations and/or locations, contact the Project Manager.
- F2.7 The Consultant is required to coordinate the sewer-televising contract and communicate the results to the Water & Waste Department. Any repairs or other activities deemed necessary from these inspections must be coordinated with the Water & Waste Department.

F3. GEOTECHNICAL INVESTIGATION REQUIREMENTS FOR PUBLIC WORKS PROJECTS (OCTOBER 2008)

F3.1 Fieldwork

- (a) Clear all underground services at each test-hole location.

- (e) Drill 125 mm-diameter test-holes into fill materials and subgrade.
- (f) If a service trench backfilled with granular materials is encountered, another hole shall be drilled to define the existing sub-surface conditions.
- (g) Test-holes shall be drilled to depth of 2 m ±150 mm below surface of the pavement.
- (h) Recover pavement core sample and representative samples of soil (fill materials, pavement structure materials and subgrade).
- (i) Measure and record pavement section exposed in the test-hole (thickness of concrete or asphalt and different types of pavement structure materials).

- (j) Pavement structure materials to be identified as crushed limestone or granular fill and the maximum aggregate size of the material (20 mm, 50 mm or 150 mm).
- (k) Log soil profile for the subgrade.
- (I) Representative samples of soil must be obtained at the following depths below the bottom of the pavement structure materials 0.1 m, 0.4 m, 0.7 m, 1.0 m, 1.3 m, 1.6 m, etc. Ensure a sample is obtained from each soil type encountered in the test-hole.
- (m) Make note of any water seepage into the test-hole.
- (n) Backfill test-hole with native materials and additional granular fill, if required. Patch pavement surface with hot mix asphalt or high strength durable concrete mix.
- (o) Return core sample from the pavement and soil samples to the laboratory.

F3.2 Lab Work

- (a) Test all soil samples for moisture content.
- (b) Photograph core samples recovered from the pavement surface.
- (c) Conduct tests for plasticity index and hydrometer analysis on selected soil samples which are between 0.5 m and 1 m below top of pavement (this is the sub-grade on which the pavement and sub-base will be built). The selection will be based upon visual classification and moisture content test results, with a minimum of one sample of each soil type per street to be tested.
- (d) Prepare test-hole logs and classify subgrade (based on hydrometer) as follows:

< 30% silt
- classify as clay
50% - 50% silt
- classify as silty clay
- classify as clayey silt
> 70% silt
- classify as silt

(e) For any uncertain situations and/or locations, or clarification of these requirements, contact the Project Manager.

PART G - SCOPE OF ENGINEERING SERVICES

G1. PROJECT PLANNING & PRELIMINARY DESIGN

- G1.1 Preliminary Design Services associated with the Contract are described in Appendix A-5.
- G1.2 Where applicable, the designs must address:
 - (a) Appropriate geometric standards set by the Transportation Association of Canada (TAC);
 - (b) City of Winnipeg's Transportation Standards Manual (February 1991);
 - (c) City of Winnipeg's *Universal Design Policy (December 2001)* and *Accessibility Design Standards* (May 2010);
 - (d) City of Winnipeg's Tree Planting Details and Specifications Downtown Area and Regional Streets (May 2009);
 - (e) City of Winnipeg's Tree Removal Guidelines;
 - (f) The current edition of The City of Winnipeg Standard Construction Specifications.
- G1.3 The Consultant is responsible for:
 - (a) In consultation with the Project Manager, determining the extent to which Site investigation is required;
 - (b) Field surveys;
 - (c) Acquiring the historical and as-built drawings within Project limits from Underground Structures:
 - (d) Referring to (F2) the Sewer Televising Guidelines for Public Works Projects, determining the extent to which the sewer infrastructure (a) requires inspection, and (b) in consultation with the Water & Waste Department, and the approval of the Project Manager, requires repairs or renewal;
 - (e) Public and Stakeholder Consultation including:
 - Identify and prepare a profile of project stakeholders in the immediate area, as well as technical stakeholders, which may be impacted by the project;
 - (ii) Determine the needs and the impact of each stakeholder on the project;
 - (iii) Develop content for communications to local residents and / or stakeholders. This may include, but is not limited to, direct letters and updates to residents, press releases, social media, and advertisements;
 - (iv) Arrange targeted meetings with the public and other stakeholders, if necessary, to make sure that any outstanding issues are addressed;
 - (v) The public participation process should be based on IAP2 principles (see http://iap2canada.ca/), which will provide the public with balanced and objective information to assist them in understanding the project.
 - (f) Engaging the services of appropriate qualified Subconsultant personnel where additional services are required, including, but not limited to: site investigation (geotechnical) services (F3), materials testing services, pipeline loading assessments, closed circuit television (CCTV) sewer inspection (F2), total coliform and HPC testing;
 - (g) Detailed examination of access and parking requirements for abutting residents/businesses;
 - (h) Reviewing the impact to existing traffic patterns and staging the construction work to establish appropriate Traffic Management Plans that minimize disruption to the public with the approval of the City for all phases (underground and surface works) of the Project. Assumptions must be stated in the Proposal;
 - (i) Providing Project details and regular Project updates to the Envista/Accela right-of-way coordination system.

G2. DETAILED DESIGN & CONTRACT PREPARATION

- G2.1 Detailed Design Services associated with the Contract are described in Appendix A-6.
- G2.2 Designs for surface works to be submitted for review must:
 - (a) Be sealed by a Professional Engineer, registered in the Province of Manitoba;
 - (b) Include aesthetic considerations of the neighbourhood;
 - (c) Include a pavement design brief;
 - (d) Include the pavement cross section;
 - (e) Include the dimensioned jointing design;
 - (f) Conform to the Manual for the Production of Construction Drawings for the City of Winnipeg, Works and Operations Division (November 1984).
- G2.3 Designs for underground works (watermains and sewer repairs) to be submitted for review must:
 - (a) Be sealed by a Professional Engineer, registered in the Province of Manitoba;
 - (b) Consider alignment, depth, method of construction and other special construction features of the watermains;
 - (c) Be drawn at a horizontal scale of 1:250 and vertical scale of 1:50.
- G2.3.1 Further to G2.3, the City will confirm the diameter required for the renewed watermain;
- G2.3.2 Further to G2.2 and G2.3, if applicable and/or appropriate, sewer repairs may be incorporated into the watermain renewal drawings.
- G2.4 Detailed Design Services Watermain
 - (a) Once the preliminary design for the Watermain Renewal project has been completed, a meeting shall be arranged with the City.
 - (b) Tender specifications complete with Form B: Unit Prices, the construction drawings and a pre-tender estimate must be provided to the Department's contact person at least ten (10) calendar days prior to tendering for review. The project shall not be tendered without this review.
 - (c) Digital files of the construction drawings shall be provided to the Department's contact person when the work is tendered. This information will be used to update the Department's GIS until the as-constructed drawings are received.
- G2.5 Allow six weeks for circulation of all design drawings to Underground Structures
 - (a) Ensure that separate copies are sent to affected utilities, with specific requests made for estimates, where required.
- G2.6 The Bid Opportunity documents must be prepared:
 - (a) Using the current applicable template from the Materials Management Division;
 - (b) Referencing the current edition of The City of Winnipeg Standard Construction Specifications.

G3. CONTRACT ADMINISTRATION

- G3.1 Contract Administration Services associated with the Contract are described in Appendix A-7.
- G3.2 The Consultant is required to provide NON-RESIDENT Contract Administration Services including but not limited to:
 - (a) Ensuring persons with demonstrated experience are assigned to administer the Project for the duration of the Project, with personnel changes only upon approval of the Project Manager;

- (b) Conducting pre-award and pre-construction meetings with formal notes as described in the City of Winnipeg's Manual of Project Administration Practice (DRAFT March 1992 – see Appendix B;
- (c) Acting as a liaison between the Public, the contractor, other utilities and the City to issues that encountered during the course of the work;
- (d) Responding to construction issues that may be raised by the City, the contractor, the Public, City Councillors, other utilities and other City Departments;
- (e) Timely processing of accurate progress payments and invoices;
- (f) Reviewing and reconciling extra work claims submitted by the contractor and make recommendations to the City for payment, if any;
- (g) Providing detailed reports supporting any construction over expenditures over the tendered contract amount;
- (h) Reporting promptly to the City regarding unusual or changed site conditions which may or will result in extra work to any contract;
- (i) Providing a detailed monthly "Cost to Complete" report. This report is to include the actual costs to date plus projected costs to complete the Contract including allowances for any unforeseen costs. The report shall identify any expected budget overruns or surpluses.
- G3.3 The Consultant is required to provide RESIDENT Contract Administration Services including but not limited to:
 - (a) Ensuring personnel with demonstrated experience in Watermain Renewals are assigned for continuous full-time on-site inspection of the construction work.
 - (b) Ensuring personnel with demonstrated experience in Regional Street Reconstructions are assigned for continuous, full-time on-site inspection of the construction work;
 - (c) Coordination of the day-to-day Site activities;
 - (d) Ensuring construction contractor conformance to the City of Winnipeg's *Manual of Temporary Traffic Control*:
 - (e) Field and/or laboratory testing and verification of construction material quality:
 - (f) Field measurement and verification of construction material quantities in a manner so as to minimize contract disputes:
 - (g) Provision of periodic and timely updates to the Project Manager on progress and/or expenditures, through:
 - (i) Regular Site meetings with formal minutes as described in the City of Winnipeg's Manual of Project Administration Practice (DRAFT March 1992 – see Appendix B), including the date, location & attendees. Issues, updates and amendments must be itemized and dated:
 - (ii) Other formal and/or informal documented means;
 - (h) Representation of the City to the local residents and businesses in a professional manner, with responsible and prompt reaction to reasonable requests (minimizing impact and/or disruption of the Project to the extent possible);
 - (i) On-going updates to the lane-closure information line as required;
 - (j) Supervision of Subconsultants required to perform any services under G1.3(e);
 - (k) Provision of Project details and regular Project updates to the Envista/Accela right-of-way coordination system.

G4. POST-CONSTRUCTION

- G4.1 Post-Construction Services associated with the Contract are described in Appendix A-8.
- G4.2 The Consultant is required to provide Post-Construction Services including but not limited to:

- (b) Preparation of one of each of the following for every construction contract administered under the Project:

 - (ii) Certificate of Total Performance; and
 - (iii) Certificate of Acceptance.
- (c) Additional Contract Administration for maintenance (pay) items within the warranty period of the construction contract;

- (e) Resolution of deficiencies and/or outstanding warranty issues;

 - For new street pavements Final pavement design
 - For pavement rehabilitations Amount of concrete repairs by percentage of surface

 - Any outstanding services or issue-resolutions required; and
 - Final or projected final contract cost;
 - Daily field reports (as an appendix);

 - (ii) Photographs total minimum of 12, maximum of 20; good quality digital photos using descriptive file names (including year), provided on CD or DVD (notwithstanding pre-construction Site and property condition assessment photos, as per Appendix A – Definition of Professional Consultant Services – Engineering – Public Works)
 - approximately six (6) typical pre-construction photos
 - approximately six (6) typical Post-construction photos
 - approximately six (6) typical construction operation photos (e.g. concrete pour, paving operation).
 - (iii) Provision of record drawings for surface works, where required, in accordance with the Public Works Department's As-Built Drawing Requirements for Public Works Projects (F1), within three months of Substantial Performance of the construction contract, unless waived or amended in writing by the Project Manager.

G5. POST-CONSTRUCTION (PROJECT CLOSE-OUT) REQUIREMENTS SPECIFIC TO THE WATERMAIN RENEWAL CONTRACTS

G5.1 Record Drawings

- (a) Complete and submit record drawings of the completed works to the City for review within three (3) months of the date of Substantial Performance of the work.
- (b) The preliminary record drawing submission is to consist of a drawing transmittal letter to the City, and one (1) complete set of full-size (A1) drawing prints for the Watermain Renewals
- (c) Record drawings are to include the following information:

- (i) All new construction details.
- (ii) Provide a service information table for Watermain Renewals showing renewal corp and curb stop locations as well as non-renewal curb stop locations referenced with long and short measurements
- (iii) Complete materials list for each individual component installed. Distinction shall be made as to which bends and fittings are cast iron and which are PVC.
- (iv) All other information specific to a particular location.
- (v) Date of installation of works (Substantial Performance).
- (vi) The name of the contractor who installed the watermain.
- (d) The reviewed record drawings will be returned with comments (if any) for completion. Once all required revisions have been made, submit one (1) complete set of full size (A1) drawing Mylars for the Watermain Renewals complete with the preliminary drawing prints with comments and the digital file for each as-constructed drawing to the City. The digital drawing file name must be the Water and Waste Department drawing number assigned to that drawing.
- (e) Resubmit the revised as–constructed drawings within one month of receipt of comments from the City.

G5.2 Service Information Sheets

(a) The required measurements (in the required units) for new, modified and reconnected services are to be recorded on the service information sheets provided by the City. Completed service information sheets are to be returned to the City within two (2) months of the date of Total Performance of the work for input into the City's database.

G5.3 Test Results

(a) All test results are to be submitted to the City as soon as they are received. If there are any failed tests, a report is to be written indicating the implications of the failure and a recommendation on what remedial measures are required.

(b) Project Summaries

(i) Provide a brief summary report to the City for each type of work documenting any specialized QA/QC work carried out or unusual problems encountered what the resolution was, and make recommendations for similar future work.
