  - Form B(R1): Item No. 1: NMS specifications for asbestos abatements has increased to from four (4) to five (5) separate areas.

Item No. 2: Increase the Approximate Quantities as identified.

- (a) Print Shop Area 1;
- (b) Work Stations Area 2;
- (c) Print Shop Administration Area 3;
- (d) City Clerks Storage Area 4; and
- (e) Emergency Operations Centre Area 5.

- (c) "Class 3 Estimate" means preliminary design, for budget authorization. The accuracy of the cost estimate shall be -20% to +30%;
- (d) "NMS" means National Master Specification;
