#### **APPLICABLE SPECIFICATIONS**

- 1.0 These Specifications shall apply to the Supply of Power Tools.
- 1.1 Bidders are reminded that requests for approval of substitutes as an approved equal or an approved alternative shall be made in accordance with B6.
- 1.2 The Contractor shall supply only new, unused equipment of current manufacture will be accepted in accordance with the requirements hereinafter specified.
- 1.3 Each piece of equipment supplied shall include an operator's manual. Operator's manuals shall include a section in English and shall cover the complete equipment.
- 1.4 The Bidder should state the hourly shop rate for maintenance and repairs as listed on Form B: Prices. Occasionally, the City may request Successful Bidders to repair non-warrantable items on City owned equipment previously purchased from this Bid Opportunity. The hourly shop rate stated will be reviewed by the City and noted for informational purposes, but shall not be used as an evaluation criteria in this Bid Opportunity.
- 1.5 All water pumps shall be outfitted with quick connect couplers installed on the suction and discharge ports. Couplers shall be Dixon / Boss-Lock Type A adapters. Part numbers are as follows:

(a) 100-A-AL for all 1" pumps
