I acknowledge that I am being transported without charge or consideration by the City of Winnipeg on the GWWD Railway, which is not a railway company, a common carrier or owner of a public utility for the conveyance of persons or goods to or for the public and is under no obligation to convey persons or goods for the public.
2. I agree to comply with the rules set by and the instructions given to me by City of Winnipeg employees or agents during the course of my transportation on the GWWD Railway. Nevertheless, I acknowledge that there are risks and hazards inherent in the very nature of the transportation provided on the GWWD Railway and that as a result of these risks and hazards, as a participant, I may suffer personal injury, even death, as well as property loss. I nevertheless freely and voluntarily assume the aforementioned risks and hazards and accordingly my transportation on the GWWD Railway shall be entirely at my own risk.
3. I waive any claim I may have against the City of Winnipeg, its servants, employees or agents arising from my transportation on the GWWD Railway. I further agree to indemnify and hold harmless the City of Winnipeg, its servants, employees or agents from and against all claims, actions or proceedings arising from loss, injury or, damages by any person arising from my transportation on the GWWD Railway.
