PART D – SUPPLEMENTAL CONDITIONS

Revise: D.12 to read:

D12. INSURANCE

D12.1 The Contractor shall provide and maintain the following insurance coverage:

- (a) commercial general liability insurance, in the amount of at least two million dollars (\$2,000,000.00) inclusive, with The City of Winnipeg added as an additional insured, with a cross-liability clause, such liability policy to also contain contractual liability, unlicensed motor vehicle liability, non-owned automobile liability, broad form property damage cover and products and completed operations, to remain in place at all times during the performance of the Work and throughout the warranty period;
- (b) Automobile Liability Insurance covering all motor vehicles, owned and operated and used or to be used by the Contractor directly or indirectly in the performance of the Work. The Limit of Liability shall not be less than \$2,000,000 inclusive for loss or damage including personal injuries and death resulting from any one accident or occurrence;
- (c) an all risks Installation Floater carrying adequate limits to cover all supplies and/or materials intended to enter into and form part of any installation.

- (d) Property insurance for all machinery and equipment, including field offices and portable toilets used by the contractor directly or indirectly in the performance of the Work on the project that may be owned, rented, leased or borrowed.

D12.2 All policies shall be taken out with insurers licensed to carry on business in the Province of Manitoba.

D12.3 All subcontractors performing work on the project shall provide the contractor with evidence of insurances as outlined in D12.1 (a) and (b) above and be registered with Workers Compensation Board of Manitoba. Such evidence to be maintained during the performance of the work. The Contractor shall provide the contract administrator with evidence of the same prior to the commencement of any work.

D12.4 Deductibles shall be borne by the Contractor.

D12.5 The Contractor shall provide the City Solicitor with a certificate(s) of insurance, in a form satisfactory to the City Solicitor, at least two (2) Business Days prior to the commencement of any Work but in no event later than the date specified in the C4.1 for the return of the executed Contract Documents, as applicable.

D12.6 The Contractor shall not cancel, materially alter, or cause each policy to lapse without providing at least thirty (30) Calendar Days prior written notice to the Contract Administrator.
